The oral hearing relates to a substitution of up to 90,000 tonnes of alternative fuels/raw materials at Irish Cement Ltd cement works at Castlemungret, Co. Limerick.

The purpose of the oral hearing is to provide an opportunity for all parties, who wish to do so, to make further submissions beyond their written submissions, and to allow the Inspector to seek clarification on any relevant **planning** issues arising and submissions made. Parties will also have the opportunity to ask questions or seek clarification on submissions made at the hearing.

There is no obligation on any party to attend, or make a submission to the oral hearing or to ask questions of the other parties. All written submissions already received will be considered by the Inspector and the Board. For this reason, submissions previously made in writing should not be restated at the oral hearing.

On completion of the oral hearing, the Inspector will prepare a report and recommendation on the case for the Board. The decision to grant or refuse permission will be made by the Board.
