Notice of Fees for Appeals in relation to Vacant Sites

The Urban Regeneration and Housing Act 2015 as amended provides for three types of appeals to An Bord Pleanála under sections 9, 11 and 18 of the Act. These appeals relate to entries of certain lands by planning authorities onto a vacant site register and the payment of a vacant site levy by owners of such sites.

An Bord Pleanála hereby gives notice that it has determined a fee as listed below in accordance with section 144 of the Planning and Development Act 2000 as amended with the approval of the Minister for Housing, Planning and Local Government in relation to such appeals.

The fee will apply to any such appeal received by An Bord Pleanála on or after the **1st April, 2019**. In the meantime there is no fee for any such appeal.
