## Dear Nichola,

Many thanks for providing advice that the 16<sup>th</sup> February 2021 is the last day for responses from the consenting authorities in relation to the Proposed Project Scope document for the Celtic Interconnector. While administration of the PCI process is of course entirely a matter for ABP, we have previously advised Diarmuid that EirGrid is under pressure to meet very tight timelines in respect of the Connecting Europe Facility funding milestones. This is compounded by the ongoing risk arising that the new Marine Planning Bill may be commenced in the short term, which would profoundly impact upon the consenting process for the Foreshore Licence for the project.

To help manage the concerns and time pressures arising, I would greatly appreciate if you could advise whether it would be possible for you to:

1. Forward us on any consenting authority responses that are received before the 16<sup>th</sup> February 2021 such that we can work on incorporating that feedback into the scope of the application at the earliest opportunity?

- This would reflect our experience of the standard practice of the Strategic Infrastructure (SI) Unit of ABP in respect of administration of public submissions for SID application files.
- 2. Issue us with your formal response to the Proposed Project Scope document at the earliest possible opportunity after the 16<sup>th</sup> February 2021 such that we can manage any scope changes arising as urgently as we possibly can?

Secondly, I note that Diarmuid had previously indicated that the PCI Unit would expect a hard physical copy of the Draft Application File (DAF) in addition to an electronic copy of same. There is no problem whatsoever in providing the PCI Unit with electronic copies of the DAF. However, in terms providing of a hard copy of same, given the current Level 5 Covid19 restrictions and the clear advice from the Government to stay away from workplaces, the provision of a hard copy of the DAF will constitute a significant challenge. The DAF will be a large suite of documents contained in boxes that ordinarily would have to be collated in the large Board room of an office by a team of people who have ready access to a printer. Neither our consultants nor we in EirGrid have access to office space or printers at present given the current Covid19 restrictions, and this is anticipated to remain the case for some time. Nor, you will appreciate, is it desirable to bring such a team together into a shared space to assist in the collation process. Appreciating the difficulties arising in this particular respect, I feel that I must kindly ask whether the PCI Unit would be agreeable to receiving the DAF in electronic format only? For the avoidance of doubt, this relates only to submission of the DAF at this time (envisaged end-Feb/early-March) and not to the submission of the final application file itself.
