I refer to your email dated 18 November 2020 wherein you requested that EirGrid provide you with an updated list of consents that are required in order to deliver the Celtic Interconnector Project, in addition to the relevant contact details for each of those consent requirements.

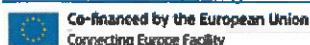
It is timely that we provide you with an updated list of consents at this juncture, as the previous list was sent to you on 24 December 2018 and there have naturally been some changes that have occurred over this period of time. Most notably, as a result of additional engagement that we have been undertaking with consenting authorities in line with Section 4.1 of the Manual of the Permit Granting Procedures, EirGrid has established that certain consents are no longer required (notably the Dumping at Sea Permit). In addition, there have been some changes to legislation and to the relevant contact details for various organisations and wherever possible relevant information in this respect has been updated.

Please refer to Appendix A to this letter which contains an up-to-date list of required consents in the Irish jurisdiction.
