The submissions on this file and the Inspector's report were considered as a Roard meeting held on 04/07/2023.

The Board decided to grant permission generally in accordance with the Inspector's recommendation, for the following reasons and considerations, and subject to the following conditions.

Reasons and Considerations

Having regard to;

- The Guidelines for Sustainable Residential Development in Urban Areas and the accompanying Urban Design Manual – a Best Practice Guide, issued by the Department of the Environment, Heritage and Local Government in May 2009,
- The zoning designation for the site "to provide residential development and improve residential amenity while protecting the existing residential amenities" in the zon Laoghaire Rathdown County Development Plan 2022 to 2028 where assisted living accommodation is permitted in principle,
- The existing, but underutilised, use of the site for residential development,
- The site's location in an urban area where community facilities, transport links and public piped services are available,
- the differing site levels within the site which has allowed for an acceptable quantum of development which respects the amenity of nearby residential development and the visual amenity of the wider area,

 the totality of the documentation submitted with the application including the Badger Conversation Plan, the submissions and observation made on the appeal and the requirement under Condition No 2 for adherence to the Guidelines for the Treatment of Badgers prior the Construction of National Road Schemes (2006),

it is considered, subject to compliance with the conditions set out below, that the proposed development would not endanger pedestrian or traffic safety, would not seriously injure the residential amenity of property in the area by reason of overshadowing or overlooking or the visual amenity of the wider area would not give rise to unacceptable ecological impacts and would otherwise accord with the provisions of the current County Development Plan and with the proper planning and sustainable development of the area.

Conditions

1. evelopment shall be carried out and completed in accordance with the plans and particulars lodged with the application except as may otherwise be required in order to comply with the following conditions. Where such conditions require details to be agreed with the planning authority, the developer shall agree such details in writing with the planning authority prior to commence ment of development and the development shall be carried out and completed in accordance with the agreed particulars.

Reason. In the interest of clarity.

The construction phase, the developer shall adhere to the *Guidelines for the Treatment of Badgers prior to the Construction of National Road Schemes,* published by the National Roads Authority in 2006. In particular, there shall be no blasting or pile driving within 150 metres of an active badger sett during the breeding season (December to June) or construction works within 50 metres of such an active sett during the breeding season.

3. ed measures in relation to the protection of bats shall be submitted to and agreed in writing with the planning authority, prior to commencement of development. These measures shall be implemented as part of the development. Any envisaged destruction of structures that support bat populations shall be carried out only under licence from the National Parks and Wildlife Service and details of any such licence shall be submitted to the planning authority.

on: In the interest of wildlife protection.

4. eveloper shall enter into water and wastewater connection agreement with Irish Water, prior to commencement of development.

pn: In the interests of clarity and public health

 Drainage arrangements including the attenuation and asposal of surface water, shall comply with the requirements of the planning authority for such works and services.

pn: In the interest of public health and surface water management.

 Details of the materials colours and textures of all the external finishes to the proposed development shall be submitted for the written agreement of the planning authority, prior to commencement of development.

Reason: In the interests of visual amenity.

7. The site shall be landscaped in accordance with the detailed scheme of landscaping, which shall be submitted to and agreed in writing with the Planning Suthority prior to commencement of development. The scheme shall include provisions for hard and soft landscaping within the site, boundary treatments and include measures for the protection of trees within and adjoining the site.

pn: In order to ensure the satisfactory completion of the development.

 Proposals for the name of the development and associated signage shall be submitted to and agreed the planning authority prior to occupation of the development. No advertisements/marketing signage relating to the name of

	the development shall be erected until the developer has obtained the planning authority's written agreement to the proposed name.
	on: In the interest of urban legibility.
9.	The developer shall facilitate the preservation, recording and protection of archaeological materials or features that may exist within the site. In this regard, the developer shall employ a suitably qualified archaeologist who shall monitor all site investigations and other excavation works. on: In order to conserve the archaeological heritage of the site and to stocure the preservation and protection of any remains that may exist within the site.
10.	Public lighting shall be provided in accordance with escheme, which shall include lighting along pedestrian routes through open spaces details of which shall be submitted to and agreed in writing with the planning authority prior to installation of lighting. Such lighting shall be provided prior to the making available for occupation of any residential unit.
11.	All service cables associated with the proposed development (such as electrical, telecommunications and communal television) shall be located underground. The cables shall avoid roots of trees and hedgerows to be retained in the one. Ducting shall be provided by the developer to facilitate the provision of broadband infrastructure within the proposed development. on: notice interests of visual and residential amenity A plan containing details for the management of waste within the duvelopment, including the provision of facilities for the storage, separation and collection of the waste and, in particular, recyclable materials shall be submitted to, and agreed in writing with, the planning authority prior to
	commencement of development. Thereafter, the waste shall be managed in accordance with the agreed plan. Reason: To provide for the appropriate management of waste and, in particular recyclable materials, in the interest of protecting the environment

13.	Construction and demolition waste shall be managed in accordance with a
	construction waste and demolition management plan, which shall be
	submitted to, and agreed in writing with, the planning authority prior to
	commencement of development. This plan shall be prepared in accordance
	with the "Best Practice Guidelines on the Preparation of Waste
	Management Plans for Construction and Demolition Projects", published by
	the Department of the Environment, Heritage and Local Government in July
	2006. The plan shall include details of waste to be generated during site
	clearance and construction phases, and details of the methods and
	locations to be employed for the prevention, minimisation, recovery and
	disposal of this material in accordance with the provision of the Vaste
	Management Plan for the Region in which the site is situated.
	Reason: In the interest of sustainable waste management.
14.	The construction of the development shall be managed in accordance with
	a Construction Management Plan, which shall be submitted to, and agreed
	in writing with, the planning authority proper commencement of
	development. This plan shall provide details of intended construction
	practice for the development, including:
	(a) Location of the site and naterials compounds including areas identified
	for the storage of construction refuse; areas for construction site offices and
	staff facilities; site security fencing and hoardings; and car parking facilities
	for site workers during the course of construction;
	(b) The iming and routing of construction traffic to and from the
	concuruction site and associated directional signage, to include proposals to
~	fat ilitate the delivery of abnormal loads to the site; measures to obviate
	deuing of construction traffic on the adjoining road network; and measures
