The submissions on this file and the Inspector's report were considered at a Braid meeting held on14/03/2023.

The Board decided to grant permission, for the following reasons and considerations, and subject to the following conditions.

## **Reasons and Considerations**

In deciding not to accept the Inspector's recommendation to refuse permission, the Board had regard to the provisions of section 25% of the Planning and Development Act, 2000, as amended, national, regional and local policy objectives, as represented in the Sligo County Development Pan including in particular section 11.2.2 and objectives P-TEL-1 and P-TEL-2 and the DOEHLG Section 28 Statutory Guidelines; "Telecommunications Antenna and Support Structures: Guidelines for Planning Authorities, 1996, as upuated by circular letter PL 07/12 in 2012. In its deliberations the Board consider the otality of material provided on the file including maps and visual impact as resonent and considered that subject to compliance with the conditions record below, the proposed development would not be visually intrusive or serious y ourrusive to the amenities of the area or the residential amenities of properties in the vicinity and, would be in accordance with the proper planning and sustainable development of the area.

## Conditions

The development shall be carried out and completed in accordance with the plans and particulars lodged with the application on the 6<sup>th</sup> of July 2021 (as received by An Bord Pleanala on 12 Jan 2022), except as may otherwise be required in order to comply with the following conditions. Where such conditions require details to be agreed with the planning authority, the developer shall agree such details in writing with the planning authority prior to commencement of development and the development shall be carried out and completed in accordance with the agreed particulars.

Reason: In the interest of clarity.

- 2 a) This licence shall apply for a period of five years from the date of this Order. The telecommunications structure and related ancillary structures shall then be removed unless, priod to the end of the period, continuance shall have been granted for their respections or a further period.
  - b) In the event of the telecommunications structure and related ancillary structures becoming absolete and being decommissioned the site shall be reinstated. Details relating to the removal and reinstatement shall be submitted to, and agreed in writing with, the planning authority at least one month before the date of expiry of this licence.

Reason: To enable the impact of the development to be re-assessed, avail gregard to changes in technology and design during the specified period.

The antenna type and mounting configuration shall be in accordance with the details submitted with this application for a licence, and notwithstanding the provisions of the Planning and Development Regulations 2001, and any

statutory provision amending or replacing them, shall not be altered without a prior grant of permission. Reason: To clarify the nature and extent of the permitted development to which this permission relates and to facilitate a full assessment of any future alterations. Surface water drainage arrangements for the proposed development shall comply with the requirements of the planning authority. Reason: In the interest of public health. 5 Details of the proposed colour scheme for the pole, antennes, equipment containers shall be submitted to, and agreed in writing with, the planning authority prior to commencement of development. Reason: In the interest of the visual amenity of the srea The proposal shall be constructed in accordance with the requirements of the Area Engineer for such works. Reason: In the interest of public hear Prior to the commencement, details of foundations for the proposed structure along with lesign calculations shall be submitted for written agreement of the Area Engineer. Reason: In the interest of orderly development. No advertisement structure shall be erected or displayed on the proposed structure or within the curtilage of the site without a prior gan of planning permission. ason: In the interest of the visual amenity of the area.
