The submissions on this file and the Inspector's report were considered at a Board meeting held on 16/11/2023.

The Board decided to grant permission generally in accordance with the Inspector's recommendation, for the following reasons and considerations, and subject to the following conditions.

Reasons and Considerations

Having regard to the location of the site within the village of Harolds Cross, the Z4 zoning objective relating to the site, and the existing pattern of development in the area, it is considered that the proposed development is in keeping with the character of the area, would not seriously injure the residential or visual amenities of the area or of properties in the vicinity, and would be acceptable in terms of traffic and pedestrian safety and convenience. The proposed development would, therefore, be in accordance with the proper planning and sustainable development of the area.

	<p>agreed with the planning authority, the developer shall agree such details in writing with the planning authority prior to commencement of development and the development shall be carried out and completed in accordance with the agreed particulars.</p> <p>Reason: In the interest of clarity.</p>
2.	<p>The retail units at ground floor level shall be used as shops as set out under Class 1 Schedule 2, Part 4 of the Planning & Development Regulations 2001 (as amended). The open-plan space at first floor level shall not be used as a betting office.</p> <p>Prior to the opening of the retail and office units, the uses shall be agreed in writing with the Planning Authority shall be submitted to, and agreed in writing with, the planning authority.</p> <p>Reason: To clarify the scope of the permission and in the interests of the visual amenities of the area.</p>
3.	<p>The shopfronts and fascia signage shall be in accordance with the following requirements:-</p> <p>(a) Signs shall be restricted to a single fascia sign using sign writing or comprising either hand-painted lettering or individually mounted lettering,</p> <p>(b) no additional awnings, canopies or projecting signs or other signs shall be erected on the premises without a prior grant of planning permission,</p> <p>(c) external roller shutter shall not be erected. Any internal shutter shall be only of the perforated type, coloured to match the shopfront colour,</p> <p>(d) no adhesive material shall be affixed to the windows or the shopfront.</p> <p>Reason: In the interest of visual amenity.</p>
4.	<p>Notwithstanding the provisions of the Planning and Development Regulations 2001, or any statutory provision amending or replacing them, no further advertisement signs (including any signs installed to be visible through the windows), advertisement structures, banners, canopies, flags, or other projecting elements shall be displayed or erected on the buildings</p>

	<p>or within the curtilage of the site, unless authorised by a further grant of planning permission.</p> <p>Reason: To protect the visual amenities of the area.</p>
5.	<p>No further amalgamation of units or subdivision of any unit shall take place without a prior grant of planning permission.</p> <p>Reason: To control the layout and scale of the development in the interests of protecting the vitality and viability of the area.</p>
6.	<p>The hours of opening of the retail units shall be restricted to between 0730 hours and 2200 hours.</p> <p>Reason: In the interests of orderly development and to protect the amenities of adjacent property.</p>
7.	<p>Full details in relation to deliveries and the set down space to the rear yard of the site shall be submitted to and agreed in writing with the planning authority prior to the operation of the permitted units.</p> <p>Reason: In the interest of traffic safety.</p>
8.	<p>All plant including extract ventilation systems and refrigerator condenser units shall be sited in a manner so as not to cause nuisance at sensitive locations due to odour or noise. All mechanical plant and ventilation inlets and outlets shall be sound insulated and/or fitted with sound attenuators to ensure that noise levels do not pose a nuisance at noise sensitive locations.</p> <p>Reason: In the interest of residential amenity.</p>
9.	<p>The developer shall comply with the following requirements:</p> <p>a) The developer shall prepare and submit revised plans indicating specifications and finishes to the front of the property along Harolds Cross Road, including measures in the form of bollards and/or hard/soft landscaping to prevent the parking of vehicles on the private landing. These plans shall be submitted to the planning authority for written agreement prior to the commencement of development.</p>

	<p>b) All cycle parking shall be of the Sheffield style design.</p> <p>c) Entrance doors onto Shamrock Villas shall be inward opening.</p> <p>d) All costs incurred by Dublin City Council, including any repairs to the public road and services necessary as a result of the development, shall be at the expense of the developer.</p> <p>Reason: In the interests of traffic safety and the amenity of the area.</p>
10.	<p>Water supply and drainage arrangements, including the attenuation and disposal of surface water, shall comply with the requirements of the planning authority for such works and services.</p> <p>Reason: In the interest of public health.</p>
11.	<p>The applicant or developer shall enter into water and/or wastewater connection agreement(s) with Irish Water prior to the commencement of this development.</p> <p>Reason: In the interest of orderly development.</p>
12.	<p>Site development and building works shall be carried out only between the hours of 0700 to 1800 Mondays to Fridays inclusive, between 0800 to 1400 hours on Saturdays and not at all on Sundays and public holidays. Deviation from these times will only be allowed in exceptional circumstances where prior written approval has been received from the planning authority.</p> <p>Reason: In order to safeguard the residential amenities of property in the vicinity.</p>
13.	<p>The construction of the development shall be managed in accordance with a Construction and Environmental Management Plan, which shall be submitted to, and agreed in writing with, the Planning Authority prior to commencement of development. This plan shall provide details of intended construction practice for the development, including access arrangements for construction traffic, hours of working, noise management measures and off-site disposal of construction/demolition waste.</p> <p>Reason: In the interests of public safety and residential amenity.</p>

14. The developer shall pay to the planning authority a financial contribution in respect of public infrastructure and facilities benefiting development in the area of the planning authority that is provided or intended to be provided by or on behalf of the authority in accordance with the terms of the Development Contribution Scheme made under section 48 of the Planning and Development Act 2000, as amended. The contribution shall be paid prior to commencement of development or in such phased payments as the planning authority may facilitate and shall be subject to any applicable indexation provisions of the Scheme at the time of payment. Details of the application of the terms of the Scheme shall be agreed between the planning authority and the developer or, in default of such agreement, the matter shall be referred to An Bord Pleanála to determine the proper application of the terms of the Scheme.

Reason: It is a requirement of the Planning and Development Act 2000, as amended, that a condition requiring a contribution in accordance with the Development Contribution Scheme made under section 48 of the Act be applied to the permission.
