## Reasons and considerations

The land fails to meet the qualifying criteria set out in s.653B of the Tax Consolidation Act 1997, as amended having regard to the lack of existing pedestrian infrastructure to serve the site in addition to the current capacity of the local road network. Therefore, the site does not warrant inclusion on the map.
