

Having regard to the provisions of the Planning and Development Act, 2000 (as amended), and the nature of the proposed development which comprises a wind farm with an output in excess of 50MW and 110kV sub-station that, if pursued, will form a new node on the transmission network, it is considered that the proposed development falls within the scope of section 37A and 182A of the Act, and that a planning application should be made directly to the Board. Please also be informed that the Board considers that the pre-application consultation process in respect of this proposed development is now closed. Overleaf you will find is a list of prescribed bodies to be notified of the application for the proposed development.

In accordance with section 146(5) of the Planning and Development Act, 2000 as amended, the Board will make available for inspection and purchase at its offices the documents relating to the decision within 3 working days following its decision. This information is normally made available on the list of decided cases on the website on the Wednesday following the week in which the decision is made.
