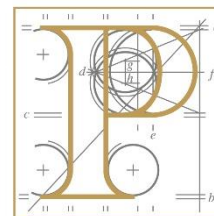

Please be advised that following consultations under section 182E of the Planning and Development Act, 2000, as amended, the Board hereby serves notice that it is of the opinion that the proposed development falls within the scope of section 182A of the 2000 Act as amended and would therefore constitute strategic infrastructure within the meaning of the Act. Any application for approval for the proposed development must therefore be made directly to An Bord Pleanála under section 182A(1) of the Act.

Please also be informed that the Board considers that the pre-application consultation process in respect of this proposed development is now closed. Given that only 1 meeting took place the Board will issue a refund of 3,500 and I will ask our Finance Department to liaise with you on this.
