Further to our meeting of the 26th of February 2024, in addition to receipt of the minutes (copied), we provide an overview previously prepared for presenting at the Cross City Link Oral Hearing held in February 2024. The presentation has been updated for various project status, in addition to including an overview of the BusConnects programme in Galway City.

This is provided for information purposes only, in response to the query raised by the board in respect to the BusConnects proposals being planned for Galway City and the potential for schemes to be lodged with the board.

The Board's representatives asked for an indication of all projects the prospective applicant is planning to develop in terms of Galway BusConnects routes. In response to this, the prospective applicant explained that the Galway BusConnects Cross City Link scheme and this proposed development are the only projects that will be submitted to the Board regarding the BusConnects.

The report attached further expands on this response to note the while two schemes are all that is currently known, more BusConnects schemes will be developed following the completion of the review of the Galway Transport Strategy and the publication of the Galway Metropolitan Area Transport Strategy (GMATS). This will be the strategic basis for BusConnects in the city, and will align to the proposals published by the NTA in respect of the National CycleConnects Plan and the BusConnects Galway Network Redesign. The strategy for the development of BusConnects Designs and associated programme, is subject to discussion with the NTA following the publication and adoption of GMATS.

I hope the attached is informative and provides context to the board.
