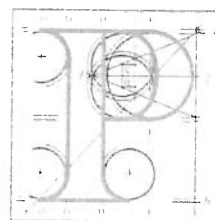

Dear Sir / Madam,

I have been asked by An Bord Pleanála to refer to the above-mentioned proposed development which was determined by the Board by Order dated 25th day of March 2025.

Please note that an error occurred in Condition Number 4 in the Condition section of the Board's Order in that it is stated: "The following design requirements shall be adhered to:

(a) The wind turbines shall be designed to a hub height of 99 meters, a rotor blade diameter of 180 meters and an overall height of 180 meters, in accordance with the turbine option assessed in the Environmental Impact Assessment Report and Natura Impact Statement, together with the application documentation.

(b) The wind turbines, including masts and blades, shall be finished externally in a light grey colour.

Reason: In the interest of clarity and visual amenity."

Should more properly have read as follows: "The following design requirements shall be adhered to:

(a) The wind turbines shall be designed to a hub height of 99 meters, a rotor blade **diameter of 162 meters and an overall height of 180 meters**, in accordance with the turbine option assessed in the Environmental Impact Assessment Report and Natura Impact Statement, together with the application documentation.
