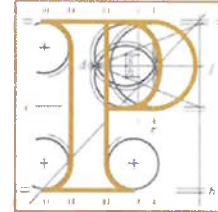



It is the Board's intention that all of the application documentation will remain available for public inspection during the currency of the application.
