#### Closure of Pre-Application Consultation

Dear Sir/ Madam,

We wish to acknowledge receipt of the Board's minutes of our most recent pre-planning meeting in the Board's offices held on 14<sup>th</sup> February 2018 and have reviewed same. On foot of this, there are a number of comments that we would like added to the file as clarification of the Board's record.

- Page 3, final paragraph – reference to "2,000 cm" would appear to be a typo and should read "2,000 mm".
- Page 5, final paragraph, second line, third word – suggest that word "should" be replaced with word "such".

Our final comment relates to the penultimate paragraph on page 5 and reference that "Prior to the holding of an oral hearing, the Board said that it would seek to give notice to parties". Our notes of the meeting indicated that a likely minimum of 3 weeks notice would be given for an oral hearing for this project, with the possibility being that the notice period may be longer. We would welcome any additional notice which the Board may be able to afford the project team.

We trust that these comments, together with our letter of 10<sup>th</sup> April 2018 in relation to the Regional Biosolids Storage Facility, will be added to the Pre-Application Consultation file, and thank the Board for the opportunity to clarify the record of the meeting.

At this stage in the process, we wish to formally close the pre-application consultation with An Bord Pleanála under Section 37B of the Planning & Development Act, 2000, as amended in respect of the above project and hereby invite the Board to formally confirm that the proposed development comprises of Statagic Infrastructure for the purposes of the Act.
