**Re: 26.VC0102 – Proposed electricity interconnector between Ireland and Wales from Great Island, Co. Wexford**

Dear Sir

I refer to the above-mentioned pre-application consultation. I wish to inform you that the Board at a meeting of 29<sup>th</sup> July 2020 issued its Direction on the case as follows: -

Having regard to the provisions of the Planning and Development Act 2000, as amended, and the nature of the proposed development which comprises the construction of an electricity interconnector, consisting of a AC-DC converter station close to Great Island 220kV substation and a 23km underground electricity cable from the converter station to a location at Baginbun Beach, County Wexford, as set out in the plans and particulars submitted, it is considered that the proposed development falls within the scope of section 182A of the Planning and Development Act 2000, as amended, and that a planning application should be made directly to the Board.

Overleaf you will find is a list of prescribed bodies to be notified of the application for the proposed development.

In accordance with section 146(5) of the Planning and Development Act, 2000 as amended, the Board will make available for inspection and purchase at its offices the documents relating to the decision within 3 working days following its decision. 
