**PROPOSED DEVELOPMENT:** Construction of a part two storey, part single storey extension to the rear of the existing dwelling house, all with associated internal alterations and site works at 80 Killane View, Edenderry, County Offaly.

## **DECISION**

GRANT permission for the above proposed development in accordance with the said plans and particulars based on the reasons and considerations under and subject to the conditions set out below.

#### REASONS AND CONSIDERATIONS

Having regard to the nature and scale of the proposed development and established pattern of development in the vicinity of the appeal site, it is considered that, subject to compliance with the conditions set out below, the proposed development would not seriously injure the residential amenities of properties in the area and would not, therefore, be contrary to the proper planning and sustainable development of the area.

## CONDITIONS

1. The development shall be carried out and completed in accordance with the plans and particulars lodged with the application, as amended by the further plans and particulars submitted on the 13<sup>th</sup> day of October, 2016 and the 5<sup>th</sup> day of January, 2017, except as may otherwise be required in order to comply with the following conditions. Where such conditions require details to be agreed with the planning authority, the developer shall agree such details in writing with the planning authority prior to commencement of development and the development shall be carried out and completed in accordance with the agreed particulars.

**Reason:** In the interest of clarity.

2. In relation to the proposed development, the external features and finishes shall match those of the existing development.

**Reason:** In the interest of orderly development and visual amenity.
