

# Board Order ABP-301905-18

Planning and Development Acts 2000 to 2018

**Planning Authority: Dublin City Council** 

Planning Register Reference Number: 4009/17

**Appeal** by Trish Moore care of Tyler Owens Architects of The Mash House, Distillery Road, Dublin against the decision made on the 29<sup>th</sup> day of May, 2018 by Dublin City Council to refuse permission for the proposed development.

Proposed Development: Construction of a new two-storey, two-bedroom pitched roofed contemporary-style mews dwelling. The dwelling will include rooflights, a south facing lightwell and covered carport. Access will be gained via a new road currently under construction, planning register reference number 2401/13, subsequently planning register reference number 3600/17. Other works as part of development include: Sustainable Urban Drainage Systems drainage, landscaping, boundary treatments and all associated works to facilitate the development at 17 Belgrove Road, Dublin.

### **Decision**

GRANT permission for the above proposed development in accordance with the said plans and particulars based on the reasons and considerations under and subject to the conditions set out below.

#### **Matters Considered**

In making its decision, the Board had regard to those matters to which, by virtue of the Planning and Development Acts and Regulations made thereunder, it was required to have regard. Such matters included any submissions and observations received by it in accordance with statutory provisions.

## **Reasons and Considerations**

Having regard to the provisions of the Dublin City Development Plan 2016-2022, the existing pattern of development in the area, and the nature, scale and design of the proposed development, as amended by the further information submitted, it is considered that, subject to compliance with the conditions set out below, the proposed dwelling would not seriously injure the amenities of the area or of property in the vicinity. The proposed development would, therefore, be in accordance with the proper planning and sustainable development of the area.

#### **Conditions**

1. The development shall be carried out and completed in accordance with the plans and particulars lodged with the application, as amended by the further plans and particulars submitted on the 2<sup>nd</sup> day of May, 2018, except as may otherwise be required in order to comply with the following conditions. Where such conditions require details to be agreed with the planning authority, the developer shall agree such details in writing with the planning authority prior to commencement of development and the development shall be carried out and completed in accordance with the agreed particulars.

Reason: In the interest of clarity.

Details of the materials, colours and textures of all the external finishes
to the proposed dwelling shall be submitted to, and agreed in writing
with, the planning authority prior to commencement of development.

**Reason:** In the interest of visual amenity.

 The proposed dwelling shall not be occupied until the works permitted to the laneway under An Bord Pleanála appeal reference number PL 29N.242866 (planning register reference number 2401/13) are completed.

**Reason**: In the interest of the proper planning and sustainable development of the area.

4. All service cables associated with the proposed development (such as

electrical, telecommunications and communal television) shall be located

underground. Ducting shall be provided by the developer to facilitate the

provision of broadband infrastructure within the proposed development.

All existing over ground cables shall be relocated underground as part of

the site development works.

**Reason**: In the interests of visual and residential amenity.

5. All costs incurred by the planning authority, including any repairs to the

public road and services necessary as a result of the development, shall

be at the expense of the developer.

**Reason:** In the interest of the proper planning and sustainable

development of the area.

6. Water supply and drainage arrangements, including the attenuation and

disposal of surface water, shall comply with the requirements of the

planning authority for such works and services.

**Reason:** In the interest of public health.

7. Prior to commencement of development, proposals for a name,

numbering scheme and associated signage shall be submitted to, and

agreed in writing with, the planning authority.

**Reason:** In the interest of orderly development.

8. The construction of the development shall be managed in accordance with a Construction Management Plan, which shall be submitted to, and agreed in writing with, the planning authority prior to commencement of development. This plan shall provide details of intended construction practice for the development, including noise management measures and off-site disposal of construction/demolition waste.

**Reason**: In the interests of public safety and residential amenity.

9. Development described in Classes 1 or 3 of Part 1 of Schedule 2 to the Planning and Development Regulations, 2001, or any statutory provision modifying or replacing them, shall not be carried out within the curtilage of the proposed dwellinghouse without a prior grant of planning permission.

**Reason**: In the interest of residential amenity.

10. Site development and building works shall be carried out only between the hours of 0800 to 1900 Mondays to Fridays inclusive, between 0800 to 1400 hours on Saturdays and not at all on Sundays and public holidays. Deviation from these times will only be allowed in exceptional circumstances where prior written approval has been received from the planning authority.

**Reason**: In order to safeguard the residential amenities of property in the vicinity.

11. The developer shall pay to the planning authority a financial contribution in respect of public infrastructure and facilities benefiting development in the area of the planning authority that is provided or intended to be provided by or on behalf of the authority in accordance with the terms of the Development Contribution Scheme made under section 48 of the Planning and Development Act 2000, as amended. The contribution shall be paid prior to the commencement of development or in such phased payments as the planning authority may facilitate and shall be subject to any applicable indexation provisions of the Scheme at the time of payment. Details of the application of the terms of the Scheme shall be agreed between the planning authority and the developer or, in default of such agreement, the matter shall be referred to An Bord Pleanála to determine the proper application of the terms of the Scheme.

**Reason:** It is a requirement of the Planning and Development Act 2000, as amended, that a condition requiring a contribution in accordance with the Development Contribution Scheme made under section 48 of the Act be applied to the permission.
