

## Board Order ABP-302937-18

Planning and Development Acts 2000 to 2018

**Planning Authority: Cork County Council** 

Planning Register Reference Number: 18/06168

**Appeal** by Citidwell Homes Limited care of BRH Design Partners Limited of Phoenix House, Monahan Road, Cork against the decision made on the 10<sup>th</sup> day of October, 2018 by Cork County Council to refuse permission for the proposed development.

**Proposed Development:** Construct an additional 10 number dwellinghouses, new roads/services and all ancillary development works at site numbers 42-51 at Glen Dara, Bishops Island, Watergrasshill, County Cork.

## Decision

GRANT permission for the above proposed development in accordance with the said plans and particulars based on the reasons and considerations under and subject to the conditions set out below.

## **Matters Considered**

In making its decision, the Board had regard to those matters to which, by virtue of the Planning and Development Acts and Regulations made thereunder, it was required to have regard. Such matters included any submissions and observations received by it in accordance with statutory provisions.

## **Reasons and Considerations**

Having regard to the residential zoning objective for the site, the provisions of the Cork County Development Plan 2014, the existing pattern of development in the area and the nature and scale of the proposed development, it is considered that, subject to compliance with the conditions set out below, the proposed development would be acceptable in terms of traffic safety and convenience and would not seriously injure the amenities of the area. The proposed development would, therefore be in accordance with the proper planning and sustainable development of the area.

**Conditions** 

1. The development shall be carried out and completed in accordance

with the plans and particulars lodged with the application, except as

may otherwise be required in order to comply with the following

conditions. Where such conditions require details to be agreed with the

planning authority, the developer shall agree such details in writing with

the planning authority prior to commencement of development and the

development shall be carried out and completed in accordance with the

agreed particulars.

**Reason:** In the interest of clarity.

2. The proposed development shall be amended as follows:

> (a) A window shall be provided on the side (east) elevation of the

first floor of house number 51.

Revised drawings, indicating the size and location of the window, shall

be submitted to, and agreed in writing with, the planning authority prior

to commencement of development.

Reason: In the interest of the proper planning and sustainable

development of the area.

3. The two metre high concrete posts and panel fence to the rear gardens

shall be omitted. The hedgerow shall be maintained and all rear

gardens shall be bounded by block walls, 1.8 metres in height, capped

and rendered on both sides.

**Reason:** In the interest of residential and visual amenity.

ABP-302937-18 An Bord Pleanála Page 3 of 9 4. Prior to commencement of development, final details of the location and facilities provided in the neighbourhood play area shall be submitted to, and agreed in writing with, the planning authority.

**Reason:** In the interest of residential amenity.

- 5. The developer shall facilitate the preservation, recording and protection of archaeological materials or features that may exist within the site. In this regard, the developer shall -
  - (a) notify the planning authority in writing at least four weeks prior to the commencement of any site operation (including hydrological and geotechnical investigations) relating to the proposed development,
  - (b) employ a suitably-qualified archaeologist who shall monitor all site investigations and other excavation works, and
  - (c) provide arrangements, acceptable to the planning authority, for the recording and for the removal of any archaeological material which the authority considers appropriate to remove.

In default of agreement on any of these requirements, the matter shall be referred to An Bord Pleanála for determination.

**Reason:** In order to conserve the archaeological heritage of the site and to secure the preservation and protection of any remains that may exist within the site.

6. Proposals for a house numbering scheme and associated signage shall

be submitted to, and agreed in writing with, the planning authority prior

to commencement of development. Thereafter, all estate and street

signs, and house numbers, shall be provided in accordance with the

agreed scheme.

**Reason:** In the interest of urban legibility.

7. The construction of the development shall be managed in accordance

with a Construction Management Plan, which shall be submitted to,

and agreed in writing with, the planning authority prior to

commencement of development. This plan shall provide details of

intended construction practice for the development, including traffic

management, noise management measures and off-site disposal of

construction/demolition waste.

**Reason:** In the interests of public safety and residential amenity.

8. The landscaping scheme shall be carried out within the first planting

season following substantial completion of external construction works.

All planting shall be adequately protected from damage until

established. Any plants which die, are removed or become seriously

damaged or diseased, within a period of five years from the completion

of the development shall be replaced within the next planting season

with others of similar size and species, unless otherwise agreed in

writing with the planning authority.

**Reason**: In the interest of residential and visual amenity.

9. Site development and building works shall be carried out only between

the hours of 0700 to 1900 Mondays to Fridays inclusive, between 0800

to 1400 hours on Saturdays and not at all on Sundays and public

holidays. Deviation from these times will only be allowed in exceptional

circumstances where prior written approval has been received from the

planning authority.

Reason: In order to safeguard the residential amenities of property in

the vicinity

10. The internal road network serving the proposed development, including

turning bays, junctions, parking areas, footpaths and kerbs shall

comply with the detailed standards of the planning authority for such

road works.

**Reason:** In the interest of amenity and of traffic and pedestrian safety.

11. Public lighting shall be provided in accordance with a scheme, details

of which shall be submitted to, and agreed in writing with, the planning

authority prior to commencement of development.

**Reason:** In the interests of amenity and public safety.

12. All service cables associated with the proposed development (such as

electrical, telecommunications and communal television) shall be

located underground. Ducting shall be provided by the developer to

facilitate the provision of broadband infrastructure within the proposed

development.

**Reason:** In the interests of visual and residential amenity.

ABP-302937-18 An Bord Pleanála Page 6 of 9 13. Water supply arrangements shall comply with the requirements of Irish Water and the planning authority for such works and services as appropriate.

**Reason:** In the interest of public health and to ensure a proper standard of development.

14. Drainage arrangements, including the disposal and attenuation of surface water, shall comply with the requirements of the planning authority for such works and services.

**Reason**: In the interest of public health.

15. The management and maintenance of the proposed development following its completion shall be the responsibility of a legally constituted management company, or by the local authority in the event of the development being taken in charge. Detailed proposals in this regard shall be submitted to, and agreed in writing with, the planning authority prior to commencement of development.

**Reason:** To ensure the satisfactory completion and maintenance of this development.

16. Prior to commencement of development, the developer shall lodge with the planning authority a cash deposit, a bond of an insurance company, or other security to secure the provision and satisfactory completion of roads, footpaths, watermains, drains, open space and other services required in connection with the development, coupled with an agreement empowering the local authority to apply such security or part thereof to the satisfactory completion of any part of the development. The form and amount of the security shall be as agreed between the planning authority and the developer or, in default of agreement, shall be referred to An Bord Pleanála for determination.

**Reason:** To ensure the satisfactory completion of the development.

17. The developer shall pay to the planning authority a financial contribution in respect of public infrastructure and facilities benefiting development in the area of the planning authority that is provided or intended to be provided by or on behalf of the authority in accordance with the terms of the Development Contribution Scheme made under section 48 of the Planning and Development Act 2000, as amended. The contribution shall be paid prior to commencement of development or in such phased payments as the planning authority may facilitate and shall be subject to any applicable indexation provisions of the Scheme at the time of payment. Details of the application of the terms of the Scheme shall be agreed between the planning authority and the developer or, in default of such agreement, the matter shall be referred to An Bord Pleanála to determine the proper application of the terms of the Scheme.
