**IARRATAS** a fuair An Bord Pleanála ar an 12 Nollaig, 2018 ó Uisce Éireann faoin alt 76 agus faoi Tríú Sceideal d'Acht na dTithe, 1966 a síneadh faoin alt 10 Acht Rialtais Áitiúla (Uimh.2), 1960 (arna ionadú le halt 86 d'Acht na dTithe, 1966) agus faoi na hAchtanna um Pleanáil agus Forbairt 2000 go 2018, maidir le daingniú ordú ceannaigh éigeantaigh dar dáta 22 Samhain, 2018, ordú a údarú tailte a thógáil go héigeantach agus dar teideal **Ordú Ceannaigh Éigeantaigh (Scéim Séarachais An Cheathrú Rua) 2018.**

**APPLICATION** received by An Bord Pleanála on the 12<sup>th</sup> of December, 2018 from Irish Water pursuant to section 76 of, and the Third Schedule to, the Housing Act, 1966 as extended by section 10 of the Local Government (No. 2) Act, 1960 (as substituted by section 86 of the Housing Act, 1966) and the Planning and Development Acts, 2000 to 2018, for confirmation of a compulsory purchase order dated the 22<sup>nd</sup> day of November, 2018 authorising compulsory acquisition of lands and entitled **Irish Water Compulsory Purchase (Carraroe Sewerage Scheme) Order 2018.**
