

Board Order ABP-303483-19

Planning and Development Acts 2000 to 2018 Planning Authority: Donegal County Council Planning Register Reference Number: 18/50009.

**Appeal** by Eddie Gallagher care of Sean Lorinyenko of Lough Eske, Donegal Town, County Donegal against the decision made on the 13<sup>th</sup> day of December, 2018 by Donegal County Council to refuse permission for the proposed development.

**Proposed Development:** Construction of a boathouse to serve an existing dwellinghouse with access to public road. Surface water to discharge into the existing public drainage network. The boathouse to include all associated site development works at Cnoc Na Muirleog Townland, Downings, County Donegal.

## Decision

GRANT permission for the above proposed development in accordance with the said plans and particulars based on the reasons and considerations under and subject to the conditions set out below.

## **Matters Considered**

In making its decision, the Board had regard to those matters to which, by virtue of the Planning and Development Acts and Regulations made thereunder, it was required to have regard. Such matters included any submissions and observations received by it in accordance with statutory provisions.

## **Reasons and Considerations**

Having regard to the provisions of the Donegal County Development Plan 2018-2024, to the pattern of development in the area, and to the nature of the proposed development, it is considered that, subject to compliance with the conditions set out below, the proposed development would not seriously injure the visual amenity of the area and would be acceptable in terms of traffic safety and convenience. The proposed development would, therefore, be in accordance with the proper planning and sustainable development of the area.

In deciding not to accept the Inspector's recommendation to refuse permission, the Board considered that the proposed development and the occasional use of a boathouse would be acceptable in terms of traffic safety and convenience.

## Conditions

 The development shall be carried out and completed in accordance with the plans and particulars lodged with the application, as amended by the further plans and particulars submitted on the 28<sup>th</sup> day of November, 2018, except as may otherwise be required in order to comply with the following conditions. Where such conditions require details to be agreed with the planning authority, the developer shall agree such details in writing with the planning authority prior to commencement of development and the development shall be carried out and completed in accordance with the agreed particulars.

Reason: In the interest of clarity.

2. Notwithstanding the exempted development provisions of the Planning and Development Regulations, 2001, and any statutory provision amending or replacing them, the use of the proposed development shall be restricted to the storage of a boat and related uses, unless otherwise authorised by a prior grant of planning permission.

Reason: To protect the amenities of property in the vicinity.

3. Water supply and drainage arrangements, including the attenuation and disposal of surface water, shall comply with the requirements of the planning authority for such works and services.

Reason: In the interest of public health.
