

Board Order ABP-305572-19

Planning and Development Acts 2000 to 2019 Planning Authority: Clare County Council Planning Register Reference Number: P19/586

**Appeal** by B. Connors care of Planning Consultancy Services of Suite 3, Third Floor, Ross House, Victoria Place, Eyre Square, Galway against the decision made on the 10<sup>th</sup> day of September, 2019 by Clare County Council to refuse permission for the proposed development.

**Proposed Development:** Minor revisions to the existing mixed-use development at Heather Hill, Ennis, County Clare. Removal of internal wall partition between retail unit number 1 and off-licence unit number 2, together with associated site works and services at Heather Hill, Limerick Road, Ennis, County Clare.

## Decision

GRANT permission for the above proposed development in accordance with the said plans and particulars based on the reasons and considerations under and subject to the conditions set out below.

## Matters Considered

In making its decision, the Board had regard to those matters to which, by virtue of the Planning and Development Acts and Regulations made thereunder, it was required to have regard. Such matters included any submissions and observations received by it in accordance with statutory provisions.

## **Reasons and Considerations**

Having regard to the planning history of the site, to the permitted use of units numbers 1 and 2 for retail and off-licence purposes respectively, the pattern of development on site and in the vicinity and to the modest nature of the proposed development, it is considered that, subject to compliance the conditions set out below, the proposed development would be acceptable in the context of Development Plan policy, would constitute an appropriate form of development within the existing building, and would be acceptable in terms of pedestrian and traffic safety. The proposed development would, therefore, be in accordance with the proper planning and sustainable development of the area.

## Conditions

1. The development shall be carried out and completed in accordance with the plans and particulars lodged with the application, except as may otherwise be required in order to comply with the following conditions. Where such conditions require details to be agreed with the planning authority, the developer shall agree such details in writing with the planning authority prior to commencement of development and the development shall be carried out and completed in accordance with the agreed particulars. Reason: In the interest of clarity.

 Details of all external shopfronts and signage shall be submitted to, and agreed in writing with, the planning authority prior to commencement of development.

Reason: In the interest of the amenities of the area/visual amenity.

3. Water supply and drainage arrangements, including the attenuation and disposal of surface water, shall comply with the requirements of the planning authority for such works and services.

Reason: In the interest of public health.

4. Site development and building works shall be carried only out between the hours of 0700 to 1900 Mondays to Fridays inclusive, between 0800 to 1400 hours on Saturdays and not at all on Sundays and public holidays. Deviation from these times will only be allowed in exceptional circumstances where prior written approval has been received from the planning authority.

**Reason:** In order to safeguard the amenities of property in the vicinity.
