

Board Order ABP-307510-20

Planning and Development Acts 2000 to 2020

WHEREAS a question has arisen as to whether the proposed erection of a concrete post and rail fence on privately owned land at Coast Road, Kilmichael East, Myrtleville, Cork is or is not development or is or is not exempted development:

AND WHEREAS Owen O'Brien requested a declaration on the said question from Cork County Council and the Council issued a declaration on the 10th day of June, 2020 stating that the said matter is development and is not exempted development:

AND WHEREAS Brendan Mullins on behalf of the Mullins-Collins Family of 27 College Grove, Ennis, County Clare referred the declaration for review to An Bord Pleanála on the 6th day of July, 2020:

AND WHEREAS An Bord Pleanála, in considering this referral, had regard particularly to –

- (a) section 3 of the Planning and Development Act, 2000, as amended,
- (b) Articles 6(1), 9(1)(a)(iii), (x) and (xi) of the Planning and Development Regulations, 2001, as amended,
- (c) Class 11(a) of Part 1 of Schedule 2 of the Planning and Development Regulations, 2001, as amended, and
- (d) the submissions on file, and
- (e) the report of the Planning Inspector:

AND WHEREAS An Bord Pleanála has concluded that -

- (a) the fence in question is development for the purposes of Section 3 of the Planning and Development Act, 2000, as amended,
- (b) the development comprises exempted development under Class 11(a) of Part 1 of Schedule 2 of the Planning and Development Regulations 2001, as amended,
- (c) the development would not be exempted development, having regard to Article 9(1)(a)(x) as it would consist of the fencing or enclosure of land habitually open to or used by the public during the ten years preceding such fencing or enclosure of a means of access to the seashore or other place of natural beauty or recreational utility.
