Planning Authority: Wicklow County Council

Application by Mags Crean of 12 Burnaby Lawns, Greystones, County Wicklow requesting An Bord Pleanála to exercise its powers under article 250(3)(b) of the Planning and Development Regulations, 2001, as amended, whether the local authorityWicklow County Council should be directed to prepare a Natura Impact Statement in respect of <u>a proposed 41-unit housing development number residential units</u> in the townland of Charlesland to the south of Greystones Golf Club₄₇ Greystones, County Wicklow.

Decision

Direct the local authority not to prepare a Natura Impact Statement in respect of the said-proposed development, based on the reasons and considerations set out below.

Matters Considered

In making its decision, the Board had regard to those matters to which, by virtue of the Planning and Development Acts and Regulations made thereunder, it was required to have regard.

Reasons and Considerations

Having regard to:

- (a) the nature and limited scale of the proposed development,
- (b) the separation distance between the proposed development and European Sites,
- (c) the identified capacity in the Greystones Waste Water Treatment Plant to cater for the discharges associated with the development,
- (d) the submission made on behalf of the local authority, including the Appropriate Assessment Screening Report dated the 22nd day of August 2019, and
- (e) the report and recommendation of the person appointed by the Board to make a report and recommendation on the matter,

it is considered reasonable to conclude, on the basis of the information available, which is considered adequate to issue a screening determination, that the proposed development, either individually or in combination with other plans or projects, would not be likely to have a significant effect on The Glen of the Downs Special Area of Conservation (<u>Seite Ceode: 000719</u>), Bray Head Special Area of Conservation (<u>Seite Ceode: 000719</u>), Bray Head Special Area of Conservation (<u>Seite Ceode: 000714</u>), The Murrough Wetlands Special Area of Conservation (<u>Seite Ceode: 002249</u>) and Murrough Special Protection Area (<u>Seite eCode: 004186</u>), in view of the conservation objectives for these sites and that a Stage 2 Appropriate Assessment and the <u>preparationsubmission</u> of a Natura Impact Statement for the proposed development is not, therefore, required.
