An Fhorbairt atá Beartaithe:

Teach cónaithe aon urlár go leith, le garáiste, slí isteach agus oibreacha coimhdeacha a thógáil, iad go léir ag an tSeanchill, Rinn Ua gCuanach, Dún Garbháin, Contae Phort Láirge.

Proposed Development: Construction of one and a half storey dwellinghouse with garage, entrance and ancillary works, all at Shankill, Rinn Ua gCuanach, Dungarvan, County Waterford.

An Cinneadh

Cead sracléaráide a DHIÚLTÚ don fhorbairt bheartaithe thuas de réir na gcúiseanna agus na nithe atá leagtha amach thíos.

Decision

REFUSE outline permission for the above proposed development in accordance with the reasons and considerations set out below.

Na Nithe a Cuireadh san Áireamh

Agus a chinneadh á dhéanamh aige, thug an Bord aird ar na hábhair sin a raibh sé de cheangal air, de bhua na nAchtanna um Pleanáil agus Forbairt agus na Rialachán a rinneadh fúthu, aird a thabhairt orthu. Áiríodh ar ábhair den sórt sin aon aighneachtaí agus tuairimí a fuair sé de réir fhorálacha reachtúla.

In making its decision, the Board had regard to those matters to which, by virtue of the Planning and Development Acts and Regulations made thereunder, it was required to have regard. Such matters included any submissions and observations received by it in accordance with statutory provisions.

1. Having regard to

- (a) the location of the site
within an "Area Under
Strong Urban Influence" as
identified in the Sustainable
Rural Housing Guidelines
for Planning Authorities
issued by the Department of
the Environment, Heritage
and Local Government in
April 2005,

- (b) the National Planning
Framework – National
Policy Objective (NPO) 19
which, for rural areas under
urban influence, provides
for single housing in the
countryside based on the
core consideration of
demonstrable economic or
social need to live in a rural
area having regard to the
viability of smaller town and
rural settlements, and

(c) suíomh an láithreáin i
limistéar ina bhfuil tithíocht
teoranta do dhaoine a
léiríonn riachtanas áitiúil
de réir Phlean Forbartha
Contae Phort Láirge 2011-
2017 (mar a athraíodh
agus a leathnaíodh é),

meastar nach dtagann an t-
iarratasóir faoi raon feidhme
na gcrítear riachtanas
tithíochta mar atá leagtha
amach sa bheartas náisiúnta
nó áitiúil do theach ag an
láthair seo. Chuirfeadh an
fhorbairt a bheartaítear, mura
mbeadh aon riachtanas
aitheanta áitiúil bunaithe ar an

cheantar agus chuirfeadh sé i

timpeallachta tuaithe agus
soláthar éifeachtach seirbhísí
poiblí agus bonneagair.
Bheadh an forbairt a
bheartaítear, dá bhrí sin,
contrártha le treoirlínte
aireachta agus le pleanáil
cheart agus forbairt
inbhuanaithe an cheantair.

(c) the location of the site in an
area where housing is
restricted to persons
demonstrating local need in
accordance with the
Waterford County
Development Plan 2011-
2017 (as varied and
extended),

it is considered that the
applicant does not come within
the scope of the housing need
criteria as set out in the national
or local policy for a house at this
location. The proposed
development, in the absence of
any identified locally based
need for the house, would
contribute to the encroachment
of random rural development in
the area and would militate
against the preservation of the
rural environment and the
efficient provision of public
services and infrastructure. The
proposed development would,
therefore, be contrary to
ministerial guidelines and to the
proper planning and sustainable
development of the area.

2. Chuirfeadh an fhorbairt a bheartaítear le forbairt ribíneach neamh-inmhianaithe i gceantar tuaithe lasmuigh de thailte atá criosaithe d'fhorbairt chónaithe, sháródh sí forálacha Alt 11.1 (Forbairt Ribín) d'Athrú Uimh. 1 de Phlean Forbartha Contae Phort Láirge 2011-2017 (mar a athraíodh agus a leathnaíodh é) agus dá bhrí sin, bheadh sé contrártha le pleanáil cheart agus forbairt inbhuanaithe an cheantair.

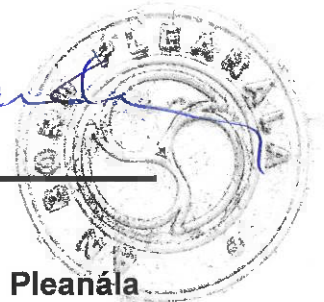
2. The proposed development would exacerbate undesirable ribbon development in a rural area outside lands zoned for residential development, would contravene the provisions of Section 11.1 (Ribbon Development) of Variation No. 1 of the Waterford County Development Plan 2011-2017 (as varied and extended) and would, therefore, be contrary to the proper planning and sustainable development of the area.
