

## Board Order ABP-309848-21

**Appeal** by Eamonn Slattery of 235 South Circular Road, Dublin against the decision made on the 4<sup>th</sup> day of March, 2021 by Dublin City Council to grant subject to conditions a permission to Margaret and Nicolas Vejsbjerg care of Cearden Limited of 9 Dolphins Barn, Dublin in accordance with plans and particulars lodged with the said Council.

**Proposed Development:** The replacement of the existing garage with a single storey kitchen extension to the side of existing house with ancillary site works at 233 South Circular Road. Dublin.

## Decision

GRANT permission for the above proposed development in accordance with the said plans and particulars based on the reasons and considerations under and subject to the conditions set out below.

**Matters Considered** 

In making its decision, the Board had regard to those matters to which, by

virtue of the Planning and Development Acts and Regulations made

thereunder, it was required to have regard. Such matters included any

submissions and observations received by it in accordance with statutory

provisions.

**Reasons and Considerations** 

Having regard to the Z2 residential conservation objective for the site in the

Dublin City Development Plan 2016-2022, the existing pattern of development

in the area, and the nature, scale and design of the proposed development, it

is considered that, subject to compliance with the conditions set out below, the

proposed development would not seriously injure the amenities of the area or

of property in the vicinity. The proposed development would, therefore, be in

accordance with the proper planning and sustainable development of the

area.

**Conditions** 

1. The development shall be carried out and completed in accordance with

the plans and particulars lodged with the application, except as may

otherwise be required in order to comply with the following conditions.

Where conditions require details to be agreed with the planning authority

the developer shall agree such details in writing with the planning

authority prior to the commencement of development and the

development shall be carried out and completed in accordance with

agreed particulars.

Reason: In the interest of clarity.

2. Details of the materials, colours, and textures of all the external finishes to the proposed extension shall be submitted to, and agreed in writing with, the planning authority prior to commencement of development.

Reason: In the interest of visual amenity.

 No more than two car parking spaces shall be provided within the curtilage.

Reason: In the interest of orderly development.

 Water supply and drainage arrangements, including the attenuation and disposal of surface water, shall comply with the requirements of the planning authority for such works and services.

**Reason:** In the interest of public health.

5. The construction of the development shall be managed in accordance with a Construction Management Plan, which shall be submitted to, and agreed in writing with, the planning authority prior to commencement of development. This plan shall provide details of intended construction practice for the development, including noise management measures and off-site disposal of construction/demolition waste and shall include provision of measures to prevent any damage to external fabric or the foundations of adjoining properties.

**Reason**: In the interests of public safety and residential amenity.

6. Site development and building works shall be carried out only between the hours of 0800 to 1900 Mondays to Fridays inclusive, between 0800 to 1400 hours on Saturdays and not at all on Sundays and public holidays. Deviation from these times will only be allowed in exceptional circumstances where prior written approval has been received from the planning authority.

**Reason:** In order to safeguard the residential amenities of property in the vicinity.
