Agus a chinneadh á dhéanamh aige, d'fhéach an Bord do na nithe sin a raibh sé de cheangal orthu, de bhua na nAchtanna agus na Rialachán Pleanála agus Forbartha, féachaint dóibh. Áiríodh ar na nithe sin aon aighneachtaí nó tuairimí a fuair sé de réir na bhforálacha reachtúla.

Matters Considered

In making its decision, the Board had regard to those matters to which, by virtue of the Planning and Development Acts and Regulations made thereunder, it was required to have regard. Such matters included any submissions and observations received by it in accordance with statutory provisions.

Cúiseanna agus Cúrsaí

Bheadh an fhorbairt a bheartaítear ina cineál forbartha míchuí ar an láithreán ag breathnú amach ar chlós seirbhíse agus carrchlós, le spás oscailte neamhleor nach bhfuil inghlactha i dtéarmaí cáilíochta agus inúsáidteachta, agus a mhainníonn déileáil leis an soláthar d'áiseanna luchtaithe leordhóthanacha d'fheithiclí seirbhíse a ghintear ar an láithreán faoi láthair. Ina theannta sin, ag féachaint don leibhéal laghdaithe cúrsaíochta agus á bhreithniú i dtéannta na ngluaiseachtaí breise iompaithe a ghintear sa láthair seo, meastar go gcuirfeadh an fhorbairt a bheartaítear timpeallacht drochchaighdeán ar fáil do chónaitheoirí amach anseo agus go ndéanfaidh sí díobháil mhór do thaitneamhachtaí cónaithe an limistéir. Mar sin bheadh an fhorbairt atá beartaithe contrártha le pleanáil chuí agus forbairt inbhuanaithe an limistéir.

Reasons and Considerations

The proposed development would constitute an inappropriate type of development of the site overlooking a service yard and car park, with inadequate open space that is not acceptable in terms of quality and usability, and fails to deal with the provision for adequate loading facilities for service vehicles that are currently generated on site.

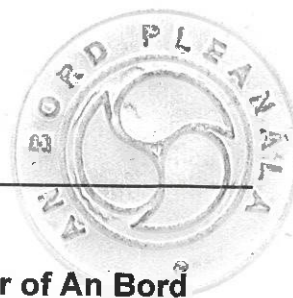
Furthermore, having regard to the reduced level of circulation and taken in conjunction with the additional turning movements generated in this location, it is considered that the proposed development would give rise to a poor quality environment for future residents and would seriously injure the residential amenities of the area. The proposed development would, therefore, be contrary to the proper planning and sustainable development of the area.
