Planning and Development Acts 2000 to 2020

Planning Authority: Fingal County Council

Application for permission under section 4 of the Planning and Development (Housing) and Residential Tenancies Act 2016, as amended, in accordance with plans and particulars, lodged with An Bord Pleanála on the 4th day of August 2021 by The Shoreline Partnership care of Brady Shipman Martin of Mountpleasant Business Centre, Ranelagh, Dublin.

Proposed Development comprises of the following:

- The proposed residential development will consist of 1,221 number residential apartment and duplex dwellings (one number studio, 502 number one-bed, 636 number two-bed, 82 number three-bed) set out as follows:
 - Blocks E1, ranging in height from five to eight storeys, providing 157 number apartment units with proposed balconies, and solar panels at roof level.
 - Blocks E2, at five to six storeys, providing 68 number apartment units with proposed balconies, and solar panels at roof level.
 - Blocks E3, at six storeys, providing 45 number apartment units with proposed balconies, and external roof terrace and solar panels at roof level.
 - Blocks E4, at five storeys, providing 36 number apartment units with proposed balconies, and external roof terrace and solar panels at roof level.

- Blocks F1, ranging in height from two to five storeys providing 91 number apartment units with proposed balconies, external roof terrace, and solar panels at roof level.
- Blocks F2, ranging in height from two to six storeys providing 122 number apartment units with proposed balconies, and solar panels at roof level.
- Blocks G1, ranging in height from four to ten storeys providing 170
 number apartment units with proposed balconies, and solar panels at
 roof level.
- Blocks G2, ranging in height from four to ten storeys providing 175 number apartment units with proposed balconies, and solar panels at roof level.
- Blocks G3, ranging in height from seven to fifteen storeys, providing 124 number apartment units with proposed balconies, and solar panels at roof level.
- Blocks G4, at seven storeys, providing 60 number apartment units with proposed balconies, and solar panels at roof level.
- Blocks G5, ranging in height from four to ten storeys providing 173
 number apartment units with proposed balconies, and solar panels at
 roof level.
- Residential Tenant Amenity Facilities of circa 2,301 metres located in Blocks E3, E4, G3, G4 and G5 and external communal amenity space of circa 10,263 square metres provided at ground, podium and terrace levels throughout the scheme.
- A crèche of circa 452 square metres in addition to outdoor play space of circa123 square metres. is proposed in the ground floor of Block G4 and one number restaurant or cafe units of circa 205 square metres is proposed on the ground floor of Block E3. Total non-residential uses circa 657 square metres.

- 3. Car Parking is provided in a mix of undercroft for Blocks E1-E2, F1 and F2 and at basement level for Blocks G1-G3 and G4-G5 with a total parking of 632 number spaces for residential units with 33 number spaces at surface level for residential use and eight number spaces (four number staff in G4/G5 and four number drop off) associated with the proposed crèche. 2021 number bicycle parking spaces are provided for residents and 312 number for visitor and commercial uses, in secure locations and within the public realm throughout the scheme.
- 4. A new central public space between Blocks E1-E2 and E3 and E4 and a new linear space between Blocks G2-G3 and G4-G5 provides pedestrian and bicycle connectivity from Longfield Road to the proposed future Racecourse Park to the north is provided.
- 5. Proposed new bus, bicycle, pedestrian and taxi ramp to the south of the site and north of Stapolin Square providing access from Longfield Road to Clongriffin Train Station. Proposed road connections to the site to the south via the extension of Longfield Road and eastward through the regrading of the existing road, providing access to the subject site via these two roads.
- 6. The development will also provide for all associated ancillary site development infrastructure including: Electricity Supply Board substations, bin stores, plant rooms, public lighting, new watermain connection to the north and foul and surface water drainage; internal roads and footpaths; site landscaping, including boundary treatments; associated scheme signage, and all associated engineering and site works necessary to facilitate the development.

The proposed scheme is designed to integrate with and continue both the existing permitted development on the southern GA01 lands (as permitted under Fingal County Council Register Reference F16A/0412, An Bord Pleanála Reference PL06F.248970 and as amended under Fingal County Council Register Reference F20A/0258 and Fingal County Council Register Reference F21A/0046), and the current proposed alterations to the GA01 Lands (currently subject to a separate Strategic Housing Development Application An Bord Pleanála Reference ABP-310418-21) for which an overall total of 981 units are either under construction or proposed. The infrastructure and road elements of the Fingal County Council

Register Reference F16A/0412, An Bord Pleanála Reference PL06F.248970 (and as amended under Fingal County Council Register Reference F20A/0258 and Fingal County Council Register Reference F21A/0046) have commenced, along with 99 number housing units at Blocks C4, C5 and C6, which will provide for both services and roads connectivity to the GA03 Lands along, and as proposed extended, Longfield Road all located at lands at Baldoyle/Stapolin, referred to as GA03 Lands in the Baldoyle-Stapolin Local Area Plan 2013, as extended and which forms part of the wider landholding of lands formerly known as the Coast, Baldoyle, Dublin 13. The lands are bound by the Dublin-Belfast and DART train line to the west, existing and proposed residential areas to the south and east, and future Racecourse Park to the north.

Decision

Grant permission for the above proposed development in accordance with the said plans and particulars based on the reasons and considerations under and subject to the conditions set out below.

Matters Considered

In making its decision, the Board had regard to those matters to which, by virtue of the Planning and Development Acts and Regulations made thereunder, it was required to have regard. Such matters included any submissions and observations received by it in accordance with statutory provisions.

Reasons and Considerations

In coming to its decision, the Board had regard to the following:

- (a) The location of the site adjacent to Clongriffin Train Station and close to other local facilities and amenities, within an established built up area on lands with zoning objective RA 'new residential' that seeks to 'provide for new residential communities subject to the provision of the necessary social and physical infrastructure.' In the Fingal County Development Plan 2017-2023;
- (b) The policies and objectives as set out in the Fingal County Development Plan 2017-2023 and Baldoyle-Stapolin Local Area Plan 2013, extended to May 2023;
- (c) Objectives 3a, 3b,11, 13 and 35 of Project Ireland 2040 National Planning Framework;
- (d) The provisions of the Dublin Metropolitan Area Strategic Plan, part of the Eastern and Midland Regional Assembly Regional Spatial and Economic Strategy 2019-2031;
- (e) The provisions of Rebuilding Ireland Action Plan for Housing and Homelessness 2016;
- (f) The provisions of Housing for All, A New Housing Plan for Ireland issued by the Department of Housing, Local Government and Heritage September 2021;
- (g) The provisions of the Design Manual for Urban Roads and Streets (DMURS) issued by the Department of Transport, Tourism and Sport and the Department of the Environment, Community and Local Government in March 2019, as amended;
- (h) The provisions of the Guidelines for Sustainable Residential Developments in Urban Areas and the accompanying Urban Design Manual, A Best Practice Guide, issued by the Department of the Environment, Heritage and Local Government in May 2009;
- (i) The provisions of the Urban Development and Building Heights Guidelines for Planning Authorities, issued by the Department of Housing, Planning and Local Government in December 2018;

- (j) The provisions of the Sustainable Urban Housing: Design Standards for New Apartments, Guidelines for Planning Authorities issued by the Department of Housing, Planning and Local Government in December 2020;
- (k) The provisions of the Planning System and Flood Risk Management for Planning Authorities (including the associated Technical Appendices), issued by the Department of the Environment, Heritage and Local Government in 2009;
- (I) The nature, scale and design of the proposed development;
- (m) The availability in the area of a wide range of educational, social, community and transport infrastructure,
- (n) The pattern of existing and permitted development in the area and the extant planning application that refers to the site and lands concerned;
- (o) The Chief Executive's Report of Fingal County Council;
- (p) The submissions and observations received;
- (q) The report of the Planning Inspector.

It is considered that, subject to compliance with the conditions set out below, the proposed development would not seriously injure the residential or visual amenities of the area or of property in the vicinity, would respect the existing character of the area and would be acceptable in terms of traffic and pedestrian safety and convenience. The proposed development would, therefore, be in accordance with the proper planning and sustainable development of the area.



Appropriate Assessment Screening

The Board completed an Appropriate Assessment screening exercise in relation to the potential effects of the proposed development on designated European Sites, taking into account the nature, scale and location of the proposed development within a zoned and serviced urban site, the information for the Appropriate Assessment Screening and Natura impact statement submitted with the application, the Inspector's Report, and submissions on file. In completing the screening exercise, the Board adopted the report of the Inspector and concluded that, by itself or in combination with other development in the vicinity, the proposed development would not be likely to have a significant effect on any European Site in view of the conservation objectives of such sites, other than Baldoyle Bay Special Area of Conservation (Site Code: 000199) and Baldoyle Bay Special Protection Area (Site Code: 004016), which are European Sites for which there is a likelihood of significant effects.

Appropriate Assessment

The Board considered the Natura impact statement and all other relevant submissions including expert submissions received and carried out an appropriate assessment of the implications of the proposed development on Baldoyle Bay Special Area of Conservation (Site Code: 000199) and Baldoyle Bay Special Protection Area (Site Code: 004016), in view of the above sites' Conservation Objectives. The Board considered that the information before it was sufficient to undertake a complete assessment of all aspects of the proposed development in relation to the sites' Conservation Objectives using the best available scientific knowledge in the field.

In completing the assessment, the Board considered, in particular, the following:

- (a) the likely direct and indirect impacts arising from the proposed development both individually or in combination with other plans or projects,
- (b) the mitigation measures which are included as part of the current proposal,
- (c) the mitigation measures advanced by the National Parks and Wildlife Service, Development Applications Units, the Department of Housing, Local Government and Heritage, and

(d) the conservation objectives for the European Sites.

In completing the Appropriate Assessment, the Board accepted and adopted the Appropriate Assessment carried out in the Inspector's report in respect of the potential effects of the proposed development on the aforementioned European Sites, having regard to the site's Conservation Objectives.

In overall conclusion, the Board was satisfied that the proposed development, by itself or in combination with other plans or projects, would not adversely affect the integrity of European Sites in view of the site's conservation Objectives. This conclusion is based on a complete assessment of all aspects of the proposed project and there is no reasonable scientific doubt as to the absence of adverse effects

Environmental Impact Assessment Screening

The Board completed, in compliance with section 172 of the Planning and Development Act 2000, as amended, an Environmental Impact Assessment of the proposed development, taking into account:

- (a) The nature, scale and extent of the proposed development;
- (b) The Environmental Impact Assessment Report and associated documentation submitted in support of the application;
- (c) The submissions from the applicant, planning authority, the observers, and the prescribed bodies in the course of the application; and
- (d) The Planning Inspector's report.

The Board considered that the environmental impact assessment report, supported by the documentation submitted by the applicant, adequately identifies and describes the direct, indirect, secondary and cumulative effects of the proposed development on the environment.

The Board agreed with the examination, set out in the Inspector's report, of the information contained in the environmental impact assessment report and associated documentation submitted by the applicant and submissions made in the course of the planning application.

The Board considered and agreed with the Inspector's reasoned conclusions, that the main significant direct and indirect effects of the proposed development on the environment are, and would be mitigated, as follows:

- Significant direct positive effects with regard to population and material assets due to the increase in the housing stock that it would make available in the urban area.
- A significant direct effect on land by the change in the use and appearance of a relatively large area of urban waste ground to residential. Given the location of the site within the built up area of Dublin and the public need for housing in the region, this effect would not have a significant negative impact on the environment.
- Potential significant effects on soil during construction, which will be mitigated by the re-use of most material on the site and the implementation of measures to control emissions of sediment to water and dust to air during construction.
- Potential effects arising from noise and vibration during construction which will be mitigated by appropriate management measures.
- Potential effects on air during construction which will be mitigated by a dust management plan including a monitoring programme.
- Potential indirect effects on water which will be mitigated during the
 occupation of the development by the proposed system for surface water
 management and attenuation with respect to stormwater runoff and the
 drainage of foul effluent to the public foul sewerage system, and which will be
 mitigated during construction by appropriate management measures to control
 the emissions of sediment to water.
- A positive effect on the streetscape because the proposed development would improve the amenity of the land through the provision of dedicated public open spaces and improved public realm.



The Board completed an environmental impact assessment in relation to the proposed development and concluded that, subject to the implementation of the mitigation measures set out in the environmental impact assessment report, and subject to compliance with the conditions set out below, the effects on the environment of the proposed development, by itself and in combination with other development in the vicinity, would, therefore, be acceptable. In doing so, the Board adopted the report and conclusions of the Inspector.

Conclusions on Proper Planning and Sustainable Development

The Board considered that, subject to compliance with the conditions set out below that the proposed development would constitute an acceptable quantum and density of development in this accessible urban location, would not seriously injure the residential or visual amenities of the area, would be acceptable in terms of urban design, height and quantum of development and would be acceptable in terms of pedestrian safety. The proposed development would, therefore, be in accordance with the proper planning and sustainable development of the area. In coming to this conclusion, specific regard was had to the Chief Executive's Report from the planning authority.

The Board considered that, while a grant of permission for the proposed Strategic Housing Development would not materially contravene a zoning objective of the statutory plans for the area, a grant of permission could materially contravene the Fingal County Development Plan 2017-2023 in relation to core strategy and car parking provision and the Baldoyle-Stapolin Local Area Plan 2013, extended to May 2023, in relation to building height and unit mix. The Board considers that, having regard to the provisions of section 37(2)(b)(i), (ii), (iii) and (iv) of the Planning and Development Act 2000, as amended, the grant of permission in material contravention of the Fingal County Development Plan 2017-2023 and Baldoyle-Stapolin Local Area Plan 2013, extended to May 2023, would be justified for the following reasons and consideration:

- (a) In relation to section 37(2)(b)(i) of the Planning and Development Act 2000, as amended: the proposed development is in accordance with the definition of Strategic Housing Development, as set out in section 3 of the Planning and Development (Housing) and Residential Tenancies Act 2016, as amended, and comprises a significant amount of housing units (1,221) to deliver on the Government's policy to increase delivery of housing from its current under supply as set out in Rebuilding Ireland Action Plan for Housing and Homelessness 2016 and Housing for All, A New Housing Plan for Ireland issued by the Department of Housing, Local Government and Heritage September 2021.
- (b) In relation to section 37(2)(b)(ii) of the Planning and Development Act 2000, as amended: the matter of conflicting objectives in the Fingal County Development Plan 2017-2023, Objective PM38 of the Fingal County Development Plan 2017-2023 seeks to achieve an appropriate dwelling mix, size, type, tenure in all new residential developments, no specific targets are mentioned, however, Objective RS 2 of the Baldoyle-Stapolin Local Area Plan 2013, extended to May 2023, seeks to limit one bed units to no more than 5%, The statutory plans for the area contain conflicting objectives.
- (c) In relation to section 37(2)(b)(iii) of the Planning and Development Act 2000, as amended: in terms of the core strategy the Housing for All, A New Housing Plan for Ireland issued by the Department of Housing, Local Government and Heritage September 2021 builds on the Project Ireland 2040 National Planning Framework National Policy Objectives that seek to increase residential density in settlements through increased building heights and at an appropriate scale of provision relative to location, National Policy Objective 35 and National Policy Objective 33 refers. With reference to the regional planning guidelines for the area, the Eastern and Midland Regional Assembly Regional Spatial and Economic Strategy 2019-2031 seeks to increase densities on appropriate sites within Dublin City and Suburbs and this can result in more units and taller buildings.

The proposed development in terms of height is in accordance with national policy as set out in the Project Ireland 2040 National Planning Framework. specifically National Policy Objective 13 and National Policy Objective 35 and is in compliance with the Urban Development and Building Heights Guidelines for Planning Authorities, issued by the Department of Housing, Planning and Local Government in December 2018, in particular Specific Planning Policy Requirement 3. In terms of unit mix, the proposed development meets the requirements of Specific Planning Policy Requirement 1 of the Sustainable Urban Housing: Design Standards for New Apartments, Guidelines for Planning Authorities issued by the Department of Housing, Planning and Local Government in December 2020 and Specific Planning Policy Requirement 4 of the Urban Development and Building Heights Guidelines for Planning Authorities, issued by the Department of Housing, Planning and Local Government in December 2018 that seeks a greater mix of building heights and typologies. In terms of car parking provision, this can be minimised, substantially reduced or wholly eliminated at accessible urban locations, section 4.19 of the Sustainable Urban Housing: Design Standards for New Apartments, Guidelines for Planning Authorities issued by the Department of Housing, Planning and Local Government in December 2020.

(d) In relation to section 37(2)(b)(iv) of the Planning and Development Act 2000, as amended: the pattern of development and permissions granted in the area since the adoption of the Fingal County Development Plan 2017-2023 where taller buildings were proposed, recent planning permissions for strategic housing granted in the wider area include; An Bord Pleanála Reference ABP-310418-21, Fingal County Council Register Reference F16A/0412 (An Bord Pleanála Reference PL06F.248970), An Bord Pleanála Reference ABP-305316-19 and An Bord Pleanála Reference ABP 305319-19 refer.

Conditions

The proposed development shall be carried out and completed in accordance with the plans and particulars lodged with the application except as may otherwise be required in order to comply with the following conditions. Where such conditions require details to be agreed with the planning authority, the developer shall agree such details in writing with the planning authority prior to commencement of development and the development shall be carried out and completed in accordance with the agreed particulars. In default of agreement, such issues may be referred to An Bord Pleanála for determination.

Reason: In the interest of clarity.

 The mitigation and monitoring measures outlined in Chapter 22 of the Environmental Impact Assessment Report submitted with this application, shall be carried out in full, except where otherwise required by conditions attached to this permission.

Reason: To protect the environment.

3. The mitigation and monitoring measures as they relate to the Baldoyle Bay Special Area of Conservation (Site Code: 0199) and Baldoyle Bay Special Protection Area (Site Code: 4016) outlined in Table 11 of the Natura impact statement submitted with this application, shall be carried out in full, except where otherwise required by conditions attached to this permission. In addition, Prior to the commencement of development, specific measures with respect to the Baldoyle Bay Special Area of Conservation (Site Code: 000199) and Baldoyle Bay Special Protection Area (Site Code: 004016) shall be submitted to, and agreed in writing with, the planning authority, as follows:

- (a) The erection of signage along the boundaries of the development site and with agreement from the planning authority the nearby Coast Road adjacent to the Baldoyle Bay Special Protection Area (Site Code: 004016) to alert the public to the potential detrimental effects on SCI birds species for the Baldoyle Bay Special Protection Area (Site Code: 004016) of disturbance by humans or their dogs; the text and location of these signs to be agreed with the planning authority and to be erected before the commencement of works on the development site.
- (b) A revised glazing scheme for the proposed development, this plan shall incorporate bird friendly glazing to be installed according to the methodology set out in the Nature Conservation section of the submission made by the Development Applications Unit of the Department of Housing, Local Government and Heritage dated the 6 September 2021.

Reason: To protect the environment and integrity of Baldoyle Bay Special Area of Conservation (Site Code: 000199) and Baldoyle Bay Special Protection Area (Site Code: 004016).

4. Prior to the commencement of any duplex unit in the development as permitted, the applicant or any person with an interest in the land shall enter into an agreement with the planning authority such agreement must specify the number and location of each duplex unit), pursuant to section 47 of the Planning and Development Act 2000, s amended, that restricts duplex units permitted, to first occupation by individual purchasers i.e. those not being a corporate entity, and/or by those eligible for the occupation of social and/or affordable housing, including cost rental housing.

Reason: To restrict new housing development to use by persons of a particular class or description in order to ensure an adequate choice and supply of housing, including affordable housing, in the common good.

5. Prior to commencement of any works, a finalised Construction and Environmental Management Plan shall be prepared and submitted to the planning authority for its written agreement, this Construction and Environmental Management Plan to incorporate the measures set out in the Natura impact statement and Outline Construction and Environmental Management Plan supporting this application to avoid any pollution through surface water runoff or by airborne dust of European Sites during the construction of the proposed development, including the erection of silt fences, installation of settling ponds, and the safe storage and handling of hydrocarbons, other chemicals, concrete and cement on the site; the Construction and Environmental Management Plan also to include provision for the employment of an ecologist to supervise the carrying out of these mitigation measures and to be implemented in full.

Reason: To protect the environment and integrity of Baldoyle Bay Special Area of Conservation (Site Code: 000199) and Baldoyle Bay Special Protection Area (Site Code: 004016).

6. The developer shall comply with all requirements of the planning authority in relation to roads, access, cycling infrastructure and parking arrangements. In particular:

The roads and footpaths shall be constructed in accordance with the Council's standards for taking in charge.

Reason: In the interests of traffic, cyclist and pedestrian safety and to protect residential amenity.

The streets that are constructed and or completed on foot of this permission shall comply with the standards and specifications set out in of the Design Manual for Urban Roads and Streets (DMURS) issued by the Department of Transport, Tourism and Sport and the Department of the Environment, Community and Local Government in March 2019, as amended. All streets shall be local streets as set out in section 3.2.1 of Design Manual for Urban Roads and Streets (DMURS) issued by the Department of Transport, Tourism and Sport and the Department of the Environment, Community and Local Government in March 2019, as amended, whose carriageway shall not exceed 5.5 metres in width. Where perpendicular parking is provided on those streets the additional width required for vehicles to manoeuvre shall be incorporated into the spaces in accordance with figure 4.82 of Design Manual for Urban Roads and Streets (DMURS) issued by the Department of Transport, Tourism and Sport and the Department of the Environment, Community and Local Government in March 2019, as amended.

7.

Reason: In the interests of road safety and to ensure that the streets in the authorised development facilitate movement by sustainable transport modes in accordance with the applicable standards set out in Design Manual for Urban Roads and Streets (DMURS) issued by the Department of Transport, Tourism and Sport and the Department of the Environment, Community and Local Government in March 2019, as amended.

8. Details of any alterations to the road and pedestrian network serving the proposed development, including loading areas, footpaths, kerbs and access road to the underground car park shall be in accordance with the detailed construction standards of the planning authority for such works and design standards outlined in the Design Manual for Urban Roads and Streets (DMURS) issued by the Department of Transport, Tourism and Sport and the Department of the Environment, Community and Local Government in March 2019, as amended. In default of agreement the matter(s) in dispute shall be referred to An Bord Pleanála for determination.

Reason: In the interest of amenity and of traffic and pedestrian safety.

9. All roads and footpaths shown connecting to adjoining lands shall be constructed up to the boundaries to provide access to adjoining lands. These areas shall be shown for taking in charge in a drawing to be submitted and agreed with the planning authority.

Reason: In the interests of permeability and proper planning and sustainable development.

10. Details of the materials, colours and textures of all the external finishes to the proposed dwellings and buildings shall be as submitted with the application, unless otherwise agreed in writing with, the planning authority prior to commencement of development. In default of agreement the matter(s) in dispute shall be referred to An Bord Pleanála for determination.

Reason: In the interest of visual amenity.

11. All plant including extract ventilation systems and refrigerator condenser units shall be sited in a manner so as not to cause nuisance at sensitive locations due to odour or noise. All mechanical plant and ventilation inlets and outlets shall be sound insulated and or fitted with sound attenuators to ensure that noise levels do not pose a nuisance at noise sensitive locations.

Reason: In the interest of residential amenity.

12. No advertisement or advertisement structure other than those shown on the plans and particulars submitted with the application shall be erected or displayed on the building or within the curtilage of the site in such a manner as to be visible from outside the building, unless authorised by a further grant of planning permission.

Reason: In the interest of visual amenity.

13. Proposals for an estate and street name, apartment numbering scheme and associated signage shall be submitted to, and agreed in writing with, the planning authority prior to commencement of development. Thereafter, all estate and street signs, and unit numbers, shall be provided in accordance with the agreed scheme. The proposed name(s) shall be based on local historical or topographical features, or other alternatives acceptable to the planning authority. No advertisements or marketing signage relating to the name(s) of the development shall be erected until the developer has obtained the planning authority's written agreement to the proposed name(s).

Reason: In the interest of legibility and to ensure the use of locally appropriate place names for new residential areas.

14. Public lighting shall be provided in accordance with a scheme, which shall include lighting along pedestrian routes through open spaces details of which shall be submitted to, and agreed in writing with, the planning authority prior to commencement of development or installation of lighting. Such lighting shall be provided prior to the making available for occupation of any house.

Reason: In the interests of amenity and public safety.

15. All service cables associated with the proposed development such as electrical, telecommunications and communal television shall be located underground. Ducting shall be provided by the developer to facilitate the provision of broadband infrastructure within the proposed development. All existing over ground cables shall be relocated underground as part of the site development works.

Reason: In the interests of visual and residential amenity.

 regulate the extent of parking. The mobility strategy shall be prepared

21. The site shall be landscaped in accordance with the detailed comprehensive scheme of landscaping, which accompanied the application submitted, unless otherwise agreed in writing with, the planning authority prior to commencement of development.

Reason: In the interest of residential and visual amenity.

- 22. The developer shall facilitate the preservation, recording and protection of archaeological materials or features that may exist within the site. In this regard, the developer shall -
 - (a) notify the planning authority in writing at least four weeks prior to the commencement of any site operation including hydrological and geotechnical investigations relating to the proposed development,

Deviation from these times will only be allowed in exceptional circumstances where prior written approval has been received from the planning authority.

27. Details of the application of the terms of the Scheme shall be agreed between the planning authority and the developer or, in default of such agreement, the matter shall be referred to An Bord Pleanála to determine the proper application of the terms of the Scheme.

Reason: It is a requirement of the Planning and Development Act 2000, as amended, that a condition requiring a contribution in accordance with the Development Contribution Scheme made under section 48 of the Act be applied to the permission.
