

## Board Order ABP-315156-22

Planning and Development Acts 2000 to 2022

Planning Authority: South Dublin County Council

**Appeal** by Bridget Smyth of 15 Sycamore Drive, Kingswood Heights, Dublin and by Julie-Anne Smyth of 15 Sycamore Drive, Kingswood Heights, Dublin against the decision made on the 24<sup>th</sup> day of October, 2022 by South Dublin County Council to grant, subject to conditions, a licence to Cignal Infrastructure Limited care of Jason Redmond and Associates of 5 Lismard Court, Portlaoise, County Laois.

**Licence Application:** Proposed 18 metre Multi-operator Streetpole Solution and ground equipment cabinet, at public footpath at the junction of Sylvan Drive and Katherine Tynan Road (R838), Kilnamanagh, adjacent to Kingswood LUAS stop, Dublin.

## Decision

In exercise of the powers conferred on it under section 254 of the Planning and Development Act, 2000, as amended, An Bord Pleanála, directs the planning authority to GRANT a licence, based on the reasons and considerations under and subject to the conditions set out below.

## Reasons and Considerations

Having regard to the provisions of section 254 of the Planning and Development Act, 2000, as amended, the South Dublin County Development Plan 2022-2028, and the 'Telecommunications Antennae and Support Structures Guidelines for Planning Authorities (1996) (as updated by Circular Letters PL 07/12 and PL11/2020, respectively), it is considered that, subject to compliance with the conditions set out below, the proposed development would not be visually intrusive or seriously injure the visual or residential amenity of the area, or of properties in the vicinity, and would, therefore, be in accordance with the proper planning and sustainable development of the area.

## Conditions

The development shall be carried out and completed in accordance with the plans and particulars lodged with the application, except as may otherwise be required in order to comply with the following conditions. Where such conditions require details to be agreed with the planning authority, the developer shall agree such details in writing with the planning authority prior to commencement of development and the development shall be carried out and completed in accordance with the agreed particulars.

Reason: In the interest of clarity.

2. The license shall be valid for three years from the date of this Order. The telecommunications structure and related ancillary structures including any access arrangements shall then be removed and the site lands shall be reinstated on removal of the telecommunications structure and ancillary structures unless, prior to the end of the period, a further licence or planning permission shall have been granted for their retention for a further period.

**Reason**: To enable the impact of the development to be re-assessed, having regard to changes in technology and design during the specified period.

 Details of the proposed colour scheme for the telecommunications structure, ancillary structures and fencing shall be submitted to, and agreed in writing with, the planning authority prior to commencement of development.

Reason: In the interest of the visual amenities of the area.

4. The construction of the development shall be managed in accordance with a Construction Management Plan, which shall be submitted to, and agreed in writing with, the planning authority prior to commencement of development. This plan shall provide details of intended construction practice for the development, including hours of working, noise management measures, off-site disposal of construction/demolition waste and the proposed parking/set down location for maintenance crews.

Reason: In the interests of public safety and residential amenity.

5. A low intensity fixed red obstacle light shall be fitted as close to the top of the mast as practicable and shall be visible from all angles in azimuth. Details of this light, its location and period of operation shall be submitted to, and agreed in writing with, the planning authority prior to commencement of development.

**Reason**: In the interest of public safety.

6. In the event of obsolescence, or withdrawal or expiry of the license without renewal, the telecommunications pole and associated cabinet shall be removed from the site and the site reinstated at the expense of the licensee as per the following, unless otherwise agreed with the planning authority.

Reason: To protect the amenities of the area.
