AND WHEREAS having regard to the nature of the issue involved, the Board decided not to invite submissions in relation to the matter from persons who had made submissions or observations in relation to the application the subject of this amendment,

NOW THEREFORE in accordance with section 146A(1) of the Planning and Development Act 2000, as amended, the Board hereby amends the above-mentioned decision so that Condition number 4(b) of its Order shall be as follows:



4. Comhlíonfar na riachtanais

- (a) Déanfar na hoibreacha de réir dhoiciméad Iascach Intíre Éireann "Treoirínte maidir le hiascach a chosaint le linn oibreacha tógála in uiscí agus in aice leo".
- (b) Ní dhéanfar aon oibreacha insrutha gan dul i gcomhairle roimh ré le hIascach Intíre Éireann, agus ní dhéanfar na hoibreacha idir Deireadh Fómhair agus Meitheamh (an dá cheann san áireamh).
- (c) Déanfar freastal iomlán ar shaorghluaiseacht éisc.
- (d) Déanfar oibreacha insrutha, agus úsáidfear coincreit le linn tréimhsí sreafaí ísle uisce.
- (e) Ní dhéanfar aon fhásra bruachánach a bhaint le linn na tréimhse ó 1 Márta go 31 Lúnasa (an dá dháta san áireamh).
- (f) Déanfar aon chriosanna bruachánacha a ndéanann innealra nó trealamh damáiste dóibh a athchóiriú go hiomlán.
- (g) Déanfaidh éiceolaí cuícháilithe suirbhé réamhthógála ar na madraí uisce sula dtosófar ar

4. The following nature conservation

requirements shall be complied with:

- (a) The works shall be carried out in compliance with the Inland Fisheries Ireland document "Guidelines on protection of fisheries during construction works in and adjacent to waters".
- (b) No in-stream works shall be undertaken without prior consultation with Inland Fisheries Ireland, and the works shall not be undertaken between October and June (inclusive).
- (c) The free passage of fish shall be fully accommodated.
- (d) In-stream works, and the use of concrete shall take place during periods of low water flows.
- (e) No riparian vegetation removal shall take place during the period from the 1st March to 31st August (inclusive).
- (f) Any riparian zones damaged by machinery or equipment shall be fully reinstated.
- (g) A pre-construction otter survey by a suitably qualified ecologist shall be carried out before works commence, any

- (i) Cuirfear bearta coiscthe i bhfeidhm chun tabhairt isteach nó scaipeadh diúilicíní riabhacha san uiscechúrsa.

- (h) A pre-construction bat survey shall be carried out by a suitably qualified ecologist during the active bat season; any destruction of bat roosting sites or relocation of bat species shall be carried out by a suitably qualified ecologist under a Derogation Licence granted by the Minister for Housing, Local Government and Heritage; and the works shall be undertaken in accordance with the Bat Conservation of Ireland document "Bats and Lighting, Guidance Notes for: Planners, engineers, architects and developers 2010".
- (i) Prevention measures shall be put in place to prevent the introduction or spread of Zebra mussel in the watercourse.
