Amendment of Commission Order

Development Concerned: Development comprising the replacement of one number illuminated 7.35 metre by 3.35 metre advertising display with one number digital 6.28 metre by 3.4 metre advertising display at Victoria Cross, Wilton Road, Cork, (adjacent Victoria Station, Student Accommodation) demolition of a boundary wall and all associated site works and services and permanent decommissioning of three number 6.3 metre by 3.5 metre advertising display facing Wilton Road, Victoria Cross, Cork (adjacent to Farranlea Hall Student Accommodation, Victoria Cross, Cork). Permission was granted for the permanent decommissioning of three number 6.3 metre by 3.5 metre advertising displays facing Wilton Road, Victoria Cross, Cork (adjacent to Farranlea Hall student accommodation, Victoria Cross, Cork) in accordance with the plans and particulars lodged with the said Council and to refuse permission for the replacement of one number illuminated 7.35 metre by 3.35 metre advertising display with one number digital 6.28 metre by 3.4 metre advertising display at Victoria Cross, Wilton Road Cork (adjacent Victoria Station, Student Accommodation). Demolition of a boundary wall and all associated site work and services.

WHEREAS the Commission made a decision to grant, subject to conditions, permission, in relation to the above-mentioned appeal by order dated the 16th day of June, 2026:

AND WHEREAS it has come to the attention of the Commission that a clerical error occurred in condition number 1:

AND WHEREAS the Commission considered that the correction of the above-mentioned error would not result in a material alteration of the terms of the subject of the permission,

AND WHEREAS having regard to the nature of the issue involved, the Commission decided not to invite submissions in relation to the matter from persons who had made submissions or observations in relation to the matter, the subject of this amendment:

NOW THEREFORE in accordance with section 146A(1) of the Planning and Development Act 2000, as amended, the Commission hereby amends the above-mentioned decision so that condition number 1 of its Order, and the reason therefor, shall be as follows:

1. The development shall be carried out and completed in accordance with the plans and particulars lodged with the application, except as may otherwise be required in order to comply with the following conditions. Where such conditions require details to be agreed with the planning authority, the developer shall agree such details in writing with the planning authority prior to commencement of development and the development shall be carried out and completed in accordance with the agreed particulars.
