#### Introduction

The representatives of An Bord Pleanála (ABP) welcomed the prospective applicant, Planning Authority (PA) and introductions were made. The procedural matters relating to the meeting were as follows:

- The written record will be placed on the pre-application consultation file and will be made public, along with that file, should an application arise following the conclusion of this consultation process,
- ABP received a submission from the PA on 31<sup>st</sup> October, 2019 providing the records
  of consultations held pursuant to section 247 and its written opinion of considerations
  related to proper planning and sustainable development that may have a bearing on
  ABP's decision.
- The consultation meeting will not involve a merits-based assessment of the proposed development,
- The meeting will focus on key site-specific issues at strategic overview level, and whether the documents submitted require further consideration and/or amendment in order to constitute a reasonable basis for an application.
- Key considerations will be examined in the context of the statutory development plan for the area and section 28 Ministerial Guidelines where relevant,
- A reminder that neither the holding of a consultation or the forming of an opinion shall prejudice ABP or the PA concerned in relation to any other of their respective functions under the Planning Acts or any other enactments and cannot be relied upon in the formal planning process or in legal proceedings.

The ABP representatives acknowledged the letter dated 4<sup>th</sup> October, 2019 formally requesting pre-application consultations with ABP. Prospective applicant advised of the need to comply with definition of SHD as set out in the Act of 2016, in relation to thresholds of development. It was also noted that the Inspector dealing with the pre-application consultation request would be different to who would deal with the application when it was submitted. Recording of the meeting is prohibited.

## 1. Natural Heritage - Hydrological Assessment.

# ABP sought further elaboration/discussion on:

➤ The submitted Hydrological Impact Assessment and the potential hydrological impacts arising from the proposed development.

#### **Prospective Applicant's response:**

- Statement of consistency sets out steps taken to address previous reason for refusal.
- > New Hydrological Assessment undertaken and NIS has been updated.
- Engaged in discussions with NPWS in relation to methodology for Hydrological Assessment. Reviewed existing information and collected supplementary information.
- Updated analysis confirms that no part of proposed development will affect SAC, no impact on tufa springs or other qualifying interest.
- Clear conclusions in this report together with mitigation measures.
- Construction / operation surface water management measures proposed. Initial set of measures in CEMP, plus additional mitigation measures provided in this application.
- Further details set out in application documentation in relation to future management of proposed development.
- Documentation has comprehensively addressed the issues previously raised by NPWS.

#### **Planning Authority's comments:**

Taking in Charge will be done as standard. PA not in a position to Take in Charge complex surface water management systems.

#### **Further ABP comments:**

- Note updated documentation and Hydrological Assessment.
- Awaiting submission from NPWS, will accompany Opinion when issuing.
- ➤ Need to address issues raised in NPWS submission on previous application including issues raised in relation to long term management of the site and any issues raised by NPWS in relation to the new documentation.

- Revised plan removed brick finish. This is welcomed.
