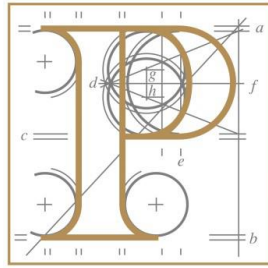

Buneolas, Forléargas agus Achoimre ar Sheirbhísí

Bunaíodh an Bord Pleanála i 1977 faoin Acht Rialtais Áitiúil (Pleanáil agus Forbairt), 1976 agus is air atá an cúram as achomhairc a chinneadh agus gnóthaí eile faoi na hAchtanna um Pleanáil agus Forbairt, 2000 go 2019 agus as iarratais dhíreacha ar Fhorbairt Bonneagair Straitéisigh agus Tithíochta Straitéisí a chinneadh. Tá cúram air, leis, as déileáil le tograí maidir le ceannach éigeantach talún a dhéanann údaráis áitiúla agus údaráis eile faoi na hachtacháin éagsúla. s é an Bord Pleanála, leis, a chinneann achomhairc faoi na hAchtanna um Thruaillíú Uisce agus Rialú Foirgníochta.

Is é seo ár ráiteas misin:

“Ár gcion a dhéanamh mar chomhlacht náisiúnta neamhspleách ar bhealach neamhchlaon, éifeachtach agus oscailte le cinntiú go luífidh forbairt fhisiciúil agus tionscnaimh mhóra bhonneagair in Éirinn le prionsabail na forbartha inbhuanaithe, lena n-áirítear cosaint an chomhshaoil.”

Tá roinnt oibleagáidí ag Bord Pleanála faoi Alt 135 (8) den Acht um Pleanáil agus Forbairt, 2000 maidir leis an nGaeilge.

Is iad sin:

- (a) Féadfar éisteacht ó bhéal a reáchtáil trí mheán na Gaeilge nó an Bhéarla.
- (b) Sa chás go mbaineann éisteacht ó bhéal le forbairt laistigh den Ghaeltacht, seolfar an éisteacht trí mheán na Gaeilge, mura n-aontaíonn na páirtithe san achomharc nó sa tarchur lena mbaineann an éisteacht gur chóir an éisteacht a reáchtáil i mBéarla.

Chapter 1

Introduction, Overview and Summary of Services.

An Bord Pleanála was established in 1977 under the Local Government (Planning and Development) Act 1976 and is responsible for the determination of appeals and certain other matters under the Planning and Development Acts 2000 (as amended) and determination of direct applications for Strategic Infrastructure and Housing Developments. It is also responsible for dealing with proposals for the compulsory acquisition of land by local authorities and others under various enactments. An Bord Pleanála also determines appeals under the Water Pollution and Building Control Acts.

Our mission statement is:

"To play our part as an independent national body in an impartial, efficient and open manner, to ensure that physical development and major infrastructure projects in Ireland respect the principles of sustainable development, including the protection of the environment."

An Bord Pleanála has a number of obligations under Section 135(8) of the Planning and Development Act, 2000 concerning the Irish language.

These are:

- (a) An oral hearing may be conducted through the medium of the Irish or the English language.
- (b) Where an oral hearing relates to development within the Gaeltacht, the hearing shall be conducted through the medium of the Irish language, unless the parties to the appeal or referral to which the hearing relates agree that the hearing should be conducted in English.



(c) Sa chás go mbaineann éisteacht ó bhéal le forbairt lasmuigh den Ghaeltacht, seolfar an éisteacht trí mheán an Bhéarla, mura n-aontaíonn na páirtithe san achomharc nó an tarchur lena mbaineann an éisteacht gur chóir an éisteacht a reáchtáil i nGaeilge.

(c) Where an oral hearing relates to development outside the Gaeltacht, the hearing shall be conducted through the medium of the English Language, unless the parties to the appeal or referral to which the hearing relates agree that the hearing should be conducted in the Irish language.

Caithfidh an Bord Pleanála, faoi Alt 120 (1) d’Acht 2000, daoine a cheapadh le bheith ina bhfostaithe ag féachaint don ghá lena chinntiú go bhfuil líon leordhóthanach foirne inniúil sa Ghaeilge ionas go mbeidh siad in ann seirbhís a sholáthar trí Gaeilge.

An Bord Pleanála, under Section 120(1) of the 2000 Act, must also appoint persons to be employees having regard to the need to ensure that an adequate number of staff are competent in the Irish language so as to be able to provide service through Irish.

Ina theannta sin, foráiltear le hAlt 10(2)(m) d’Acht 2000 go n-áireofar i bplean forbartha cuspóirí chun oidhreacht theangeolaíoch agus chultúrtha na Gaeltachta a chosaint lena n-áirítear an Ghaeilge a chur chun cinn mar theanga an phobail, áit a bhfuil ceantar Gaeltachta i limistéar an phlean forbartha. Tá sé de cheangal ar Bhord Pleanála aird a thabhairt ar phlean forbartha an údaráis phleanála agus a chinntí á ndéanamh aige.

Furthermore, Section 10(2)(m) of the 2000 Act provides that a development plan shall include objectives for the protection of the linguistic and cultural heritage of the Gaeltacht including the promotion of Irish as the community language, where there is a Gaeltacht area in the area of the development plan. An Bord Pleanála is bound to have regard to the development plan of the planning authority when making its decisions.

Fáiltíonn an Bord Pleanála roimh ullmhú na Scéime Teanga seo mar dheis chun leordhóthanacht na seirbhísí a thairgeann sé a mheas agus leathnú a dhéanamh ar infhaighteacht seirbhísí trí Ghaeilge.

An Bord Pleanála welcomes the preparation of this Language Scheme as an opportunity to assess the adequacy of the services it offers and to expand on the availability of services through Irish.

Rinne an Bord Pleanála uasghrádú le déanaí ar a chórais Teicneolaíochta Faisnéise agus Cumarsáide. Is é an uailmhian don todhchaí áis a sholáthar ionas gur féidir iarratais, achomhairc agus breathnuithe a dhéanamh ar líne trínár suíomh Gréasáin nuashonraithe. 2.1 Scéim Ghaeilge nua a ullmhú

D'ullmaigh an Bord Pleanála a tríú scéim de réir Alt 15 d'Acht na dTeangacha Oifigiúla 2003.

D'iarr an tAire Turasóireachta, Cultúir, Ealaíon, Gaeltachta, Spóirt agus na Meán ar an mBord Pleanála de réir alt 15 den Acht athbhreithniú a dhéanamh ar a tríú scéim agus dréachtscéim nua a ullmhú.

Foráiltear le halt 11 den Acht, chun úsáid na Gaeilge a chur chun cinn chun críocha oifigiúla sa Stát, go n-ullmhóidh comhlachtaí poiblí scéim reachtúil ina sonrú na seirbhísí a bheartaíonn an comhlacht poiblí a sholáthar:

- go heisiach trí mheán na Gaeilge
- go heisiach trí mheán an Bhéarla, agus
- trí mheán na nGaeilge agus na mBéarla

agus na bearta a bheartaíonn an comhlacht a ghlacadh chun a chinntiú go ndéanfar aon seirbhís nach soláthraíonn an comhlacht trí mheán na Gaeilge a sholáthar amhlaidh laistigh de chreat ama comhaontaithe.

Ullmhaíodh an Scéim seo ag féachaint do na Treoirínte faoi Alt 12 d'Acht na dTeangacha Oifigiúla 2003 a d'eisigh an Roinn Gnóthaí Pobail, Tuaithe agus Gaeltachta i Meán Fómhair 2004.

Chapter 2

2.1 Preparation of New Language Scheme

An Bord Pleanála prepared its third scheme under Section 15 of the Official Languages Act 2003.

The Minister for Tourism, Culture, Arts, Gaeltacht, Sport and Media requested An Bord Pleanála in accordance with section 15 of the Act to review its third scheme and to prepare a new draft scheme.

Section 11 of the Act provides that, for the purposes of promoting the use of the Irish Language for official purposes in the State, public bodies prepare a statutory scheme specifying the services, which the public body proposes to provide:

- exclusively through the medium of the Irish Language
- exclusively through the medium of the English Language, and
- through the medium of both the Irish and English Languages

and the measures the body proposes to adopt to ensure that any service that are not provided by the body through the medium of the Irish Language will be so provided within an agreed timeframe.

This Scheme was prepared having regard to the Guidelines under Section 12 of the Official Languages Act 2003 issued by the Department of Community, Rural and Gaeltacht Affairs in September 2004.

An Bord Pleanála published a notice under section 13 of the Act, inviting submissions from any interested parties regarding the preparation of the new draft scheme. Any submissions received are available at www.pleanala.ie

Tá an scéim ceadaithe freisin ag an Aire Turasóireachta, Cultúir, Ealaíon, Gaeltachta, Spóirt agus na Meán Catherine Martin, TD.

2.2 Ábhar agus Cuspóirí na Scéime Gaeilge

Aithníonn an Bord Pleanála gur féidir le baill an phobail a dtuairimí agus a riachtanais a chur in iúl níos fearr sa teanga is fearr leo, gur ábhar dea-chleachtais é a chumasú don phobal a rogha teanga a úsáid, agus go bhféadfadh sé baill an phobail a chur faoi mhíbhuntáiste diúltú dóibh an teanga is fearr leo a úsáid. Le cur i bhfeidhm na scéime seo, tá an Bord Pleanála tiomanta do chultúr dátheangach a chruthú agus é ag plé le custaiméirí agus a sheirbhísí go léir a sholáthar trí mheán na Gaeilge de réir a chéile in imeacht roinnt blianta.

Is é príomhaidhm Acht na dTeangacha Oifigiúla 2003 agus na scéime seo a chinntiú go mbeidh seirbhísí poiblí níos fearr agus ar chaighdeán Gaeilge níos airde ar fáil.

Tugadh gealltanais shuntasacha i gcéad trí scéim an Bhoird Phleanála leibhéal na seirbhísí trí Ghaeilge a fheabhsú. Tá an ceathrú scéim seo bunaithe ar an tuiscint gur cuireadh na gealltanais seo go léir sna scéimeanna roimhe seo i bhfeidhm.

This new fourth scheme was prepared and approved by the Board of An Bord Pleanála following consideration of all relevant submissions received. These included the views of Conradh na Gaeilge, Údarás na Gaeltachta and Irish Language Committees of An Bord Pleanála. The scheme has also been approved by the The Minister for Tourism, Culture, Arts, Gaeltacht, Sport and Media Ms Catherine Martin. TD.

2.2 Content and Objectives of the Language Scheme

An Bord Pleanála recognises that members of the public can express their views and needs better in their preferred language, that enabling the public to use their preferred language is a matter of good practice, and that denying the customer the right to use their preferred language could place members of the public at a disadvantage. With the implementation of this scheme, An Bord Pleanála is committed to creating a bilingual culture in its dealings with customers and to provide all its services through the medium of Irish in a phased manner over a number of years.

The primary objective of the Official Languages Act 2003 and this scheme is to ensure better availability and a higher standard of public services through Irish.

Significant commitments were given in An Bord Pleanála's first three schemes to improve the level of services through Irish. This fourth scheme is based on the understanding that all of these commitments in the earlier schemes were implemented.

The objective of this fourth scheme is to continue the delivery of the commitments made in the earlier schemes and to build on the progress

achieved over the period of those schemes and on the language policy that has been operated by An Bord Pleanála for a number of years. The following provisions are in accordance with this objective:

- Callers to our offices are able to conduct their business in Irish if they wish.
- Where an appeal or observation is written in Irish, the decision of the Board will be issued in Irish or bilingually.
- Where an oral hearing relates to a proposed development within the Gaeltacht, the oral hearing will be conducted through Irish, unless the parties to the appeal agree that the oral hearing should be conducted in English.
- Any correspondence received in Irish will be responded to in Irish in accordance with the provisions of section 9(2) of the Official Languages Act 2003.
- Publish all advertisements in Gaeltacht areas in an Irish language newspaper.
- Publication of the An Bord Pleanála Annual Report bilingually.
- In-house training courses will be provided to staff to encourage staff to increase their knowledge of Irish with the intention of providing a better service through Irish.
- Staff will be encouraged and facilitated in attending external Irish language courses through the reimbursement of fees and the granting of study leave.



- Éascófar don fhoireann freastal ar chúrsaí Gaeilge sa Ghaeltacht i rith míonna an tsamhraidh.
- Staff will be facilitated to attend Irish language courses in the Gaeltacht during the summer months.

Tá sé beartaithe go neartóidh an scéim na gealltanais a tugadh inár bPlean Gníomhaíochta do Chustaiméirí maidir le Comhionannas na dTeangacha Oifigiúla.

2.3 Dáta Thús Feidhme na Scéime

Tá an scéim daingnithe ag an Aire Turasóireachta, Cultúir, Ealaíon, Gaeltachta, Spóirt agus na Meán. Tosóidh an scéim le héifeacht ón 01 Nollaig 2021 agus fanfaidh sí i bhfeidhm go ceann tréimhse trí bliana ón dáta seo nó go dtí go mbeidh scéim nua deimhnithe ag an Aire faoi alt 15 d'Acht na dTeangacha Oifigiúla 2003, cibé acu is déanaí.

It is intended that the scheme will strengthen the commitments made in our Customer Action Plan concerning Official Languages Equality.

2.3 Commencement Date of the Scheme

This Scheme has been confirmed by the Minister for Tourism, Culture, Arts, Gaeltacht, Sport and Media. The scheme will commence with effect from 01 December 2021 and will remain in force for a period of three years from this date or until a new scheme has been confirmed by the Minister under section 15 of Official Languages Act 2003, whichever is the later.



Caibidil 3

3.1 Modhanna Cumarsáide i dtaobh Seirbhísí.

Is iad príomh-mhodhanna cumarsáide an Bhoird Phleanála le hachomharcóirí /iarratasóirí/breathnóirí/agóideoirí agus an pobal i gcoitinne:

- i. Cinntí agus comhfhreagras a eisíodh i ndáil le hachomhairc, atreoruithe agus iarratais aonair.
- ii. Foilseacháin chorparáideacha lena n-áirítear Ráiteas Straitéise, Tuarascáil Bhliantúil, Cairt do Chustaiméirí / Plean Gníomhaíochta do Chustaiméirí agus an Scéim Ghaeilge.
- iii. Suíomh gréasáin:
- iv. Doiciméid Faisnéise Ginearálta agus Treoirlíne
- v. Na Meáin Náisiúnta agus Áitiúla.

i) Cinntí agus Comhfhreagras

Sa chás go mbaineann an t-iarratas le forbairt i gceantar Gaeltachta agus i gcás go ndearnadh an t-iarratas, an t-achomharc nó an tuairim i nGaeilge, is é an beartas ordú a eisiúint go dátheangach. Ina theannta sin, is é cleachtas an Bhoird Phleanála ordú dátheangach a eisiúint ar aon chinneadh a bhaineann le forbairt shuntasach i gceantar Gaeltachta d'ainneoin nach bhfuarthas aon aighneacht i nGaeilge.

ii) Foilseacháin Chorparáideacha

Cuirtear foilseacháin chorparáideacha, ar nós Tuarascáil Bhliantúil an Bhoird Phleanála, ar fáil go dátheangach. Go dátheangach a eisítear aon ráiteas meán i dtaca le foilseacháin. I mBéarla a bhíonn seoltaí meánach, má iarrtar é, tabharfaidh urlabhraí agallamh trí Ghaeilge ar chláir nuachta teilifíse agus raidió, nuair is féidir.

Chapter 3

3.1 Means of Communications in relation to Services.

An Bord Pleanála's main means of communications with appellants/applicants/observers/objectors and the general public are through:

- i. Decisions and correspondence issued in relation to individual appeals, referrals and applications.
- ii. Corporate publication including Statement of Strategy, Annual Report, Customer Charter/Customer Action Plan and Language Scheme
- iii. Website.
- iv. General Information and Guideline Documents
- v. National and Local Media.

i) Decisions and Correspondence

Where the application relates to development in a Gaeltacht area and where the application, appeal or observation was made in Irish, it is the policy to issue an order bilingually. In addition, it is An Bord Pleanála's practice to issue a bilingual order on any decision relating to a significant development in a Gaeltacht area notwithstanding that no submission was received in Irish.

ii) Corporate Publications

Corporate publications are produced and made available bilingually such as An Bord Pleanála's Annual Report which is issued yearly. Any media statement issued in conjunction with publications are also issued bilingually. Media launches are held through English but, if requested, a spokesperson will conduct an interview through Irish language on television and radio news programmes, where possible.





iii) Suíomh gréasáin

Sheol an Bord Pleanála suíomh Gréasáin nuashonraithe in Aibreán 2021. Tá feidhmiúlacht fheabhsaithe ag an suíomh Gréasáin agus cuirtear gach eolas stach ar fáil go dátheangach. Féachann an Bord leis an bhfeidhmiúlacht seo a fheabhsú agus a bhreisiú go leanúnach chun a dhícheall a dhéanamh go mbeidh na seirbhísí inrochtana do gach duine ar mian leo a ngnó a dhéanamh trí Ghaeilge. Cuimsíonn an suíomh Gréasáin leaganacha Gaeilge agus Béarla de dhoiciméid faisnéise, tuarascálacha agus treoirlínte atá foilsithe ag an eagraíocht.

Cuirtear tuairiscí forbartha ar chásanna nua agus cásanna cinnte ar an suíomh Gréasáin gach seachtain. Éilíonn an beartas atá ann faoi láthair go gcuirfí na tuairiscí forbartha ar an suíomh Gréasáin sa teanga ina ndearnadh na hiarratais. Cuirtear gach mír nuachta nó fógra a rinne an eagraíocht ar fáil i nGaeilge agus i mBéarla. Cuirtear cláir oibre aon Éisteachtaí ó Bhéal atá ag an mBord Pleanála ar an suíomh Gréasáin sa dá theanga freisin.

iv) Eolas/Treoirlínte

Cuirtear faisnéis agus treoirlínte a d'fhoilsigh an Bord Pleanála ar fáil sa dá theanga agus cuirtear ar an suíomh Gréasáin iad sa dá theanga

v) Na Meáin Náisiúnta agus Áitiúla

Go ginearálta eisítear cinntí faoi mhórfhorbairtí nó faoi nithe is inspéise do na meáin do na meáin tar éis fógra a thabhairt do na páirtithe lena mbaineann. Déileáiltear le ceistanna ó

iii) Website

An Bord Pleanála launched a updated website in April 2021. The website has enhanced functionality, it offers bi-lingual in respect of all static information. The Board seeks to continually improve and enhance this functionality to strive that services are accessible to all who wish to conduct their business through Irish. The website includes Irish and English versions on information documents, reports and guidelines published by the organisation.

Development descriptions of new and decided cases are posted on the website every week. The existing policy dictates the development descriptions are placed on the website in the language in which the applications were made. All news items or announcements which have been made by the organisation are added in both Irish and English format. Agendas for any Oral Hearings held by An Bord Pleanála are also placed on the website in both languages in addition.

iv) Information/Guidelines

Information and guidelines published by An Bord Pleanála are produced in both languages and are put on the website in both languages

v) National and Local Media

Decisions on major developments or of media interest generally are released to the media following their notification to the parties concerned. Media queries in relation to

Breisiú na Seirbhísí a Chuirfear ar Fáil go Dátheangach

Enhancement of Services to be Provided Bilingually.

Geallann an Bord Pleanála rochtain a thabhairt ar ar sheirbhísí trí Ghaeilge. Chomh maith leis na bearta atá liostaithe ar na leathanaigh seo a leanas, féachann an Bord Pleanála le seirbhísí ar ardchaighdeán trí Ghaeilge a sholáthar i gcónaí.

Chapter 5

Implementation

The Official Languages Act 2003 states that a public body in preparing a draft Scheme 'shall ensure that an adequate number of its staff are competent in the Irish Language so as to be able to provide its services through Irish as well as English'. This is to enable An Bord Pleanála to deliver the services it commits to provide bilingually in this Scheme or over a series of schemes in line with the principles of quality customer services.

An Bord Pleanála is committed to providing services that are efficient and of good quality to those who wish to deal with it through Irish. An Bord Pleanála's aim is that it will continue to have sufficient numbers of staff competent in the Irish language to enable quality customer service through Irish. Training and other support initiatives will continue to be available to staff members in order to underpin and increase proficiency in the Irish language and to encourage wider general use of the Irish language in the organisation.

5.1 Training

5.1.1 In-house and external training programmes will be continued and enhanced.

Target: Ongoing

5.1.2 Members of staff will be encouraged to attend appropriate courses aimed at increasing their level of competence in the language.

Target: Ongoing



5.1.3 Aithneofar baill foirne go leanúnach a bhfuil inniúlacht leordhóthanach acu sa Ghaeilge ionas go bhféadfaidís tabhairt faoi chúrsaí tríú leibhéal iomchuí sa Ghaeilge, ar mhaithe le seirbhís do chustaiméirí ar chaighdeán níos fearr a sholáthar. 5.1.7 Staff will be encouraged to converse in Irish in the workplace as often as possible.

Additional marks will be awarded in all internal competitions for a demonstrated capability in the Irish language.

Monatóireacht agus Athbhreithniú

Coinneoidh an Coiste Bainistíochta comhdhéanta d'ardbhainistíocht na heagraíochta oibriú na Scéime faoi athbhreithniú. Ina theannta sin, leanfaidh an Coiste Gaeilge atá ann cheana de bhealaí a scrúdú trína bhféadfadh an eagraíocht infhaighteacht níos fearr agus caighdeán níos airde seirbhísí poiblí Gaeilge a sholáthar. Lorgófar aiseolas ar oibriú na Scéime ón gCoiste Comhpháirtíochta freisin.

Tá bainisteoirí líne freagrach as oibriú na Scéime ó lá go lá mar aon le monatóireacht leanúnach a dhéanamh ar leibhéal an éilimh sna réimsí éagsúla.

Mar chuid den phróiseas monatóireachta, tabharfaidh an Bhainistíocht, tar éis dul i gcomhairle le Coiste na Gaeilge, tuarascáil bhliantúil don Bhord ar dhul chun cinn na mbeart éagsúil i gcomparáid leis an gclár ama atá leagtha amach sa Scéim. Chapter 6

Monitoring and Review

The Management Committee comprising senior management in the organisation will keep the operation of the Scheme under review. Additionally, the existing Irish Language Committee will continue to investigate ways to ensure better availability and a higher standard of public services to be provided by the organisation through Irish. Feedback on the operation of the Scheme will also be sought from the Partnership Committee.

The day-to-day operation of the Scheme together with ongoing monitoring of the level of demand in the various areas is the responsibility of line managers.

As part of the monitoring process, Management will, following consultation with the Irish Language Committee, make an annual report to the Board on the progress of the various measures against the timetables set out in the Scheme. Following the commencement of the Scheme, any complaints concerning the commitments made in the Scheme will be processed in accordance with the procedures set out in An Bord Pleanála's Customer Action Plan.

- Nótaí a sholáthar i bhfoilseacháin agus i bhfógraí go soláthraíonn an Bord Pleanála seirbhísí trí Ghaeilge agus, dá réir sin, go bhfáiltíonn sé roimh chustaiméirí ar mian leo déileáil leis i nGaeilge, de réir na ngealltanais ina Scéim aontaithe.

Chapter 7

Publicising of New Scheme

- The contents of the new Scheme along with the commitments and the provisions of the scheme will be notified to the general public by means of publication of the scheme on the website and display in An Bord Pleanála's reception.

Staff and Board members will be informed of the new scheme and reminded of the commitments as set out therein.

In addition, An Bord Pleanála will take every opportunity in its day-to-day interactions with customers to promote and publicise the services it provides through Irish, including by:

- Directly informing customers on a proactive basis of the option of dealing with An Bord Pleanála through Irish, for example, by the display of notices at reception areas indicating the Irish language services that are available and also by prominently listing these on www.pleanala.ie:
- Including footnotes on selected guidelines, leaflets and application forms explaining that these documents are also available in Irish (in cases where bilingual printed material is not produced under a single cover); and
- Including notes in publications and advertisements that An Bord Pleanála provides services through Irish and, accordingly, welcomes customers who wish to deal with it in Irish, according to the commitments in its agreed Scheme.
