## CHAIRPERSON'S STATEMENT

2007 was the thirtieth anniversary of the Board's foundation and it is probably true to say that it was the most challenging of those 30 years. As well as coping with the record level of intake of planning appeals, we also had to take on the new functions in relation to the approval of major infrastructure projects assigned to the Board under the Planning and Development (Strategic Infrastructure) Act 2006. These functions brought significant changes to the scope and operations of the Board, in particular the conduct of pre-application consultations with the project sponsors.

### Workload and Performance in 2007

The record level of activity experienced by the Board in 2005 and 2006 continued unabated in 2007 when the intake of cases of all kinds approached the 6,700. Notwithstanding a 10% increase in cases determined, this resulted in a significant rise in the workload on hands at year end and a further deterioration in the Board's performance in relation to the timeliness of its decision making.

The following gives an overview of the Board's workload and performance in 2007:

- intake of new cases 6,664 - up 12% on 2006.
- cases determined 6,163 - up 10%.
- workload on hands at year end 2,865 - up 21%.
- 18 week statutory objective met in 48% of cases, compared to 52% in 2006.
- average time to determine cases 19 weeks, compared to 18 weeks in 2006.

### Other noteworthy features in 2007

The percentage of local authority planning decisions appealed to the Board showed a slight decrease to 6.7% (from 6.9% in 2006).

The rate of reversal of local planning authority decisions appealed showed a slight decrease - 32% in 2007 compared to 33% in 2006. The disparity between local authorities in the rate of reversal, apparent in previous years, was somewhat less pronounced in 2007.

Just under half of planning appeals lodged with the Board came from third parties, similar to 2006.

## RÁITEAS AN CHATHAOIRLIGH

Ba é 2007 30ú comóradh bliana bhunú an Bhoird agus is dócha gur fíor a rá gurbh í an bhliaín ba dhúshlánaí den tréimhse sin de 30 bliain. Chomh maith le déileáil leis an leibhéal thar na bearta d'achomhairc phleanála isteach, b'éigean dúinn freisin aghaidh a thabhairt ar na feidhmeanna nua maidir le faomhadh na mórtionscadal infrastruchtúir a sannadh ar an mBord faoin Acht um Phleanáil agus Fhorbairt (Infrastruchtúr Straitéiseach) 2006. Bhí athruiithe suntasacha i gceist leis na feidhmeanna seo do scóip agus d'oibríochtaí an Bhoird, go háirithe seoladh comhairliúchán réamhiarratais le hurraithe an tionscadail.

### Ualach Oibre agus Feidhmíocht 2007

Lean an barrleibhéal gníomhaíochta a raibh ar an mBord aghaidh a thabhairt air i 2005 agus i 2006 ar aghaidh gan staonadh i 2007 nuair a bhí líon de chásanna isteach de gach cineál cóngarach do 6,700. In ainneoin mhéadú de 10% sna cásanna a cinneadh, méadaíodh go mór an t-ualach oibre ar láimh ag deireadh na bliana, agus chuaigh feidhmíocht an Bhoird in olcas tuilleadh i dtaca le tráthúlacht a chinnteoirreachta.

Seo a leanas forbhreathnú d'ualach oibre agus d'fheidhmíocht an Bhoird i 2007:


- cásanna nua isteach 6,664 – méadú de 12% i dtaca le 2006.
- cásanna a cinneadh 6,163 – méadú de 10%.
- Ualach oibre ar láimh ag deireadh na bliana, 2,865 – méadú de 21%.
- baineadh an cuspóir reachtúil de 18 seachtaine amach i 48% de chásanna, le hais 52% i 2006.
- meántréimhse le cásanna a chinneadh, 19 seachtaine, le hais 18 seachtaine i 2006.

### Gnéithe suntasacha eile i 2007

Bhí laghdú beag ann i gcéatadán na socruithe pleánála údarás áitiúil a ndearnadh achomharc fúthu don Bhoird, síos go 6.7% (ó 6.9% i 2006).

Bhí laghdú beag ann i ráta freaschuir socruithe de chuid na n-údarás pleánála áitiúil - 32% i 2007 le hais 33% i 2006. Bhí laghdú beag ann i 2007 san éagothroime idir údarás áitiúla sa ráta freaschuir a bhí le sonrú le blianta beagaanuas.

Tríu páirtithe a thaiscigh beagnach leath de na hachomhairc phleanála a taisceadh leis an mBord, ar an dul céanna le 2006.



Invalid appeals constituted 12.4% (14.8% in 2006) of all appeals determined, with late appeals (4.0%), invalid fee (3.7%) and third party appeals with no acknowledgement (3.5%) being the main reasons. Measures taken by the Board to help people avoid making invalid appeals appear to be having some success. Appeals withdrawn as a percentage of the intake decreased from 6.7% to 6.3%.


There were 189 applications for leave to appeal by third parties of which 17% succeeded. All of these applications were decided within the statutory 4 week period.

### Current Trends and Outlook

The first five months of 2008 are showing a 15% decline in the total intake of cases. The number of cases disposed of is down by 8% due in the main to the Board's decision to concentrate on the oldest appeals. The volume of cases on hand has started to decline but remains very high and contains a substantial element of backlog. The Board is confident that with the continued fall in the intake of cases, the increased resources and other measures to improve productivity considerable progress will be made this year in moving back towards our strategic target of determining 90% of cases within the 18-week period. The Board regrets the delays that are occurring in the determination of appeals.

### Infrastructure Projects

The Board has over recent years been prioritising major infrastructure projects (whether planning appeals or local authority sponsored projects) to ensure that they are as effective as possible in shortening the timescale for decisions.



B'achomhairc neamhbhailí iad 12.4% (14.8% i 2006) de na hachomhairc ar fad a míniódh; na príomhchúiseanna a bhí i gceist ná achomharc déanach (4.0%), táille neamhbhailí (3.7%) agus achomhairc tríú páirtí gan admháil (3.5%). Is cosúil go bhfuil ag éirí le bearta atá curtha i gcrích ag an mBord le cabhrú le daoine gan achomhairc neamhbhailí a dhéanamh. Laghdaíodh lón na nachomharc a aistarraingíodh ó 6.7% go 6.3%.

Cuireadh 189 iarratas isteach ar chead pleánala ag tríú páirtithe, ar éirigh le 17% acu. Socraíodh na hiarratais seo uile laistigh den tréimhse reachtúil de 4 seachtaíne.

### Treochtaí Reatha agus Ionchas

Léiríonn an chéad chúig mhí de 2008 go bhfuil laghdú 15% le sonrú sa lín iomlán de chásanna isteach. Tá an lín cásanna a cuireadh de láimh laghdaithe faoi 8%, go príomha mar gheall ar shocru an Bhoird bheith ag diríú ar na hachomhairc is faide ó shin a taisceadh. Tá laghdú tar éis tosú ar lín na gcásanna idir láimha, ach é fós an-ard i gcónaí agus tá roinnt mhaith riáráiste i gceist. Tá an Bord muiníneach go ndéanfar dul chun cinn suntasach i mbliana, leis an laghdú leanúnach sa lín de chásanna isteach, na hacmhainní méadaithe agus bearta eile le feabhas a chur ar tháirgílacht, dul chun cinn i dtaca le dul i dtreo ár sprice straitéisí de chinneadh a dhéanamh faoi 90% de chásanna laistigh den tréimhse 18 seachtaíne. Cúis aiféala don Bhord é an mhoill atá ag tarlú maidir le cinneadh achomharc.

### Tionscadail Infrastruchtúir

Le blianta beaga anuas bhí an Bord i mbun tosaíochtaí a shocru i dtaca le mórtionscadail infrastruchtúir (cé acu achomhairc phleanala nó tionscadail a urraíonn údaráis



In 2007 the Board received 57 and disposed of 55 planning appeals that were classed as major infrastructure developments, 13% being determined within 18 weeks (overall average 34 weeks).

Of the 32 High Court judicial review proceedings instituted in 2007, one related to a major infrastructure case. This was subsequently withdrawn. It is noteworthy that the Board has not to date lost any legal case relating to a major infrastructure development and has, in fact, won a number of significant cases.

### Strategic Infrastructure

The Board assumed the functions in relation to strategic infrastructure development assigned to it under the Planning and Development (Strategic Infrastructure) Act 2006 on 31st January 2007. A brief commentary on activity under this heading in 2007 is contained in this report at pages 21 and 22.

In the first five months of 2008, the Board received 14 new requests to enter into pre-application consultations and held 25 meetings. Thirteen pre-application consultations were finalised, leaving 42 on-going at the end of May 2008.

The Board has received 17 formal applications for strategic infrastructure developments in the first five months of 2008 (6 of which were local authority projects). At time of writing, determinations were issued in respect of 8 infrastructure developments in 2008. Three of these related to non-local authority projects and 3 such cases were determined within the statutory objective period of 18 weeks, following oral hearings.



áitiúla) le cinntíú go mbíonn siad chomh héifeachtach agus is féidir maidir leis an scála ama a ghearradh siar le haghaidh socruthie. I 2007 fuair an Bord 57 achomharc pleanála agus chuir sé de láimh 55 achomarc pleanála a aicmíodh mar mhórfhorbairtí infrastruchtúir; cinneadh 13% acu laistigh de 18 seachtaíne (meánlón iomlán, 34 seachtaíne).

As na 32 imeachtaí athbhreithnithe bhrefiúnaigh Ardchúirte a tionscnaíodh i 2007, bhain 1 acu le cás mórrinfrastruchtúir. Aistarraingíodh an ceann seo níos déanaí. Tá sé suntasach nár chaill an Bord aon chás dlíthíúil go dtí seo a bhaineann le mórfhorbairt infrastruchtúir; os a choinne sin tá roinnt cásanna tábhachtacha buaite aige.

### Infrastruktúr Straitéiseach

Ghabh an Bord na feidhmeanna i leith forbairt bhoneagair straitéisigh dálte air faoin Acht um Phleanáil agus Fhorbairt (Infrastruktúr Straitéiseach) 2006, ar 1 Eanáir 2007. Cuimsítear tráchtairesacht ghearr ar ghníomhaíocht faoin gceannteideal seo i 2007 sa tuairisc seo ar leathanaigh 21 agus 22.

Sa chéad chuíg mhí de 2008, fuair an Bord 14 iarratas nua chun tosú ar chomhairliúcháin réamhiarratais agus reáchtáil sé 25 cruinníú. Tugadh 13 comhairliúchán réamhiarratais chun críche, ag fágáil 42 ag leanúint ar aghaidh ag deireadh Bealtaine 2008.

Fuair an Bord 17 iarratas foirmiúil i gcomhair forbraíochtaí infrastruktúir straitéisigh sa chéad chuíg mhí de 2008 (arbh iad 6 ó thionscadail údarás áitiúil). Ag am scríofa, eisíodh cinntí i leith 8 tionscadal infrastruktúir i 2008. Bhain 3 dóibh siúd le tionscadail neamhúdarás áitiúil agus socraíodh 3 dá leithéid de chásanna laistigh den tréimhse chuspóra reachtúil de 18 seachtain, i ndiaidh éisteachtaí ó bhéal.

## Resources

Approval was received in January 2007 from the Minister for the Environment, Heritage and Local Government for a considerable increase in the Board's staffing resources. In overall terms total authorised staffing has increased from 136 to 172 (26%) and Board membership from 10 to 11. This provides for a greatly strengthened management structure within the Board in line with the recommendations of the organisational review referred to in previous annual reports. The new Strategic Infrastructure Division of the Board will be supported by a separate staff Division within the organisation. The Board has largely been quite successful in recruiting the additional planning staff required.

## Improving the Organisation

- To further augment our capacity to deal with the increasing workload a number of other measures were taken in addition to the increased staffing referred to above. These included increasing the panel of consultant inspectors from 76 to 96 and reintroducing a weekend overtime scheme for inspectorate staff.
- At the time of writing, the Board is engaged in discussions with the trade unions representing staff concerning the implementation of the Strategic Infrastructure Act.
- The Board is continuing its commitment to equality in the workplace by carrying out surveys in relation to areas identified in the Equality Initiative and Review Reports in order to measure progress arising from the implementation of policies, training etc.
- As mentioned in the 2006 Annual Report we participated in the National Disability Authority's Excellence Through Accessibility Award scheme and received a Quality Level Award. As stated last year, the Board's website was redeveloped arising from the Disability Act 2005 and was short-listed in the "Best Accessible Website" category of the E-Government Awards.
- The Board operates a policy designed to promote a workplace which is free from racial or other discrimination and harassment and which welcomes diversity in the workplace.
- It is our policy to foster relations with the local inner city community in which we are located and we have established contacts with local schools and offer employment experience to local young people.

## Acmhainní

Fuarhas faomhadh in Eanáir 2007 ón Aire Comhshaoil, Oidhreachta agus Rialtais Áitiúil do mhéadú suntasach ar acmhainní foirnithe an Bhoird. San iomlán méadaíodh líon na foirne ó 136 go 172 (26%) agus ballraíocht an Bhoird ó 10 go 11. Déanann sin soláthar do struchtúr an-treisithe bainistithe laistigh den Bhord de réir mholtáin athbhreithnithe eagraíochtúil a ndéantar tagairt dó i dtuarascálacha blantúla eile roimhe seo. Tacófar le Rannán nua Infrastruchtúir Straitéisigh an Bhoird ag Rannán ar leith san eagraíocht. D'éirigh go maith leis an mBord, san iomlán, maidir le hearcú na foirne breise pleanála a theastaíonn.

## Ag Cur Feabhas ar an Eagraíocht

- Lenár gcumas a mhéadú tuilleadh plé leis an ualach oibre breise rinneadh roinnt beart eile chomh maith le cur leis an líon foirne a luadh thuas. Ar na bearta bhí méadú an phainéil de chigíri comhairleacha ó 76 go 96 agus ath-thabhairt isteach scéime ragoibre deireadh seachtaine do na cigíri.
- Agus seo á scríobh tá an Bord i mbun plé le ceardchumainn na foirne faoi chur i bhfeidhm an Acht um Infrastruktúr Straitéiseach.
- Leanann an Bord ar aghaidh lena thiomantas do Chomhionannas laistigh den ionad oibre trí chur i gcrích suirbhéanna i dtaca le réimsí a athnódh sna Tuairiscí Tionscnamh agus Athbhreithnithe Comhionannais leis an dul chun cinn a thomhas a d'eascair as cur i bhfeidhm polasaithe, oiliúna, srl.
- Mar a luadh i tuarascáil bhliantúil 2006 ghlacamar páirt i scéim Dámhacthainte Fheabhas trí Inrochtaineacht an Údarás Náisiúnta Mhíchumais agus fuaireamar Dámhacthaint Leibhéal Ardchaighdeáin. Mar a dúradh anuraidh athfhhorbraíodh suíomh gréasáin an Bhoird, á spreagadh ag an Acht um Mhíchumas, 2005, agus bhí sé ar an ngearriosta sa chatagóir "Suíomh Gréasáin is Inrochtana" de Dhámhacthainí an E-Rialtais.
- Feidhmíonn an Bord polasaí ar cuspóir leis ionad oibre a chothú atá saor ó leatrom agus ó chiapadh ciníoch nó de chineál eile, agus a chuireann fáilte roimh an éagsúlacht san ionad oibre.
- Ár bpolasaí atá ann caidreamh a chothú le pobal áitiúil lár na cathrach ina bhfuilimid suite, agus tá teagmháil déanta againn le scoileanna áitiúla, agus tairiscímid taithí fhostaíochta don aos óg áitiúil.

- Performance Management and Development Systems are in place for Board Members and staff within the organisation, including a Forecasting and Appraisal Scheme for inspectors. It is proposed to further develop these systems so as to enhance the opportunities for, and potential of, each person to contribute to the overall mission and objectives in a customer focused manner.
- The Board welcomes the use of the Irish language by those doing business with us and encourages and supports staff to become fluent in the language. The Board has adopted a scheme under section 11 of the Official Languages Act 2004 detailing the services it proposed to provide through Irish.
- In 2007 the Board submitted Progress Reports in accordance with the national partnership agreement, "Towards 2016" to cover the periods up to March and December 2007. Those reports were accepted by the Department of Environment, Heritage and Local Government.
- The Board submitted a detailed response to the Department of Environment, Heritage and Local Government to the efficiency review of public sector organisations carried out at the behest of the Minister for Finance.

### Public Confidence

The Board's three core principles of independence, impartiality and openness are embedded in our Mission Statement and objectives and underpinned by legislation. We are always mindful that public confidence depends on the integrity and quality of our decision-making and the professionalism with which we carry out our functions. There is a statutory code of conduct for all Board members, staff and consultants, which places stringent obligations on members and employees of the Board to declare interests and conduct themselves generally in a way that reinforces public confidence. It is the Board's policy to adopt the most open approach possible in its relations with the public and we operate a completely open file system once cases are determined.

As our decisions can relate to major developments, it is only natural that some of them give rise to public controversy. However, the Board considers it proper to maintain long established practice of not engaging in discussion on individual cases because of the quasi-judicial nature of our functions and to avoid the risk of prejudicing future cases.

- Tá Córais Bhainistithe agus Fhorbartha Feidhmíochta i bhfeidhm do Bhaill agus d'Fhoireann an Bhoird laistigh den eagraíocht, ar a n-áirítear Scéim Thuartha agus Mheasúnaithe do chigirí. Moltar go ndéanfaí tuilleadh forbartha ar na córais seo le feabhas a chur ar dheiseanna agus ar chumas gach duine cur leis an misean agus na cuspóirí iomlána, ar shlí a dhíríonn ar an gcustaméir.
- Cuireann an Bord fáilte roimhe úsáid na Gaeilge ag na daoine sin a bhfuil gnó acu linn, agus spreagann sé agus tacáonn sé leis na baill fhoirne sin atá ag baint líofachta amach sa teanga. Tá an Bord tar éis glacadh le scéim faoi alt 11 d'Acht na dTeangacha Oifigiúla, ina dtugtar sonraí faoi na seirbhísí a bhfuil sé beartaithe aige iad a chur ar fáil i nGaeilge.
- I 2007 chuir an Bord Tuairiscí Dul Chun Cinn isteach de réir an chomhaontaithe chompháirtíochta náisiúnta, "I dTreo 2016" leis na tréimhsí a chlúdach suas go Mártá agus Nollaig 2007. Ghlac Roinn Comhshaoil, Oidhreachta agus Rialtais Áitiúil leis na tuairisci sin.
- Chuir an Bord freagra mionsonraithe faoi bhráid na Roinne Comhshaoil, Oidhreachta agus Rialtais Áitiúil faoin athbhreithniú éifeachtúlachta d'egraíochtaí earnála poiblí a cuireadh i gcrích de réir orduithe an Aire Airgeadais.

### Muinín an Phobail

Tá trí bhunphrionsabail an Bhoird – neamhspleáchas, neamhchlaontacht agus oscailteacht – leabaithe inár Ráiteas Misin agus inár gcuid cuspóirí agus buntacaítear leo ag an reachtaíocht. Tuigimid i gcónaí go mbíonn muinín an phobail ag brath ar ionracas agus ar chaighdeán ár gcuid cinnteoireachta agus ar an ngairmiúlacht lena gcuirimid ár gcuid socruite i bhfeidhm. Dar leis an mBord, áfach, gur cuí cloí leis an gcleachtas seanbhunaithe gan plé a dhéanamh faoi chásanna aonair mar gheall ar nádúr garbhreithiúnach ár gcuid feidhmeanna, agus leis an mbaol a sheachaint go ndéanfaí dochar do chásanna eile sa todhchaí.



## Complaints

As part of our increased focus on customer service, the Board operates a system of considering complaints made in relation to cases determined. XX complaints were received in 2007 and there is a system of feedback at all levels within the organisation and learn from issues raised and improve procedures. However, many of the complaints relate to enforcement of decisions which is a matter entirely within the competence of the local planning authority and where the Board can do not more than pass on the correspondence to the relevant authority.

## Accounts

Appendix 10 contains the Board's audited accounts for 2007.

Expenditure increased from €20.9 million in 2006 to €23.2 million in 2007. In 2007, fee income together with costs recouped from local authorities on infrastructure projects was €3.2 million which represented 14% of the total costs of the Board's operations (12% in 2006).

In 2007, income amounted to €23.5 million leaving a surplus for the year of €318,217. There was an incoming deficit of €133,639 which left a cumulative surplus of €184,578.



## Gearáin

## Cuntas

Tá le fáil in Aguisín 10 cuntas iniúchta an Bhoird do 2007.

Méadaíodh caiteachas ó €20.9 milliún i 2006 go €23 milliún i 2007. I 2007, ba é an t-ioncam táillí, in éineacht leis na costais a forchúitíodh ó údarás áitiúla do thionscadail infrastruchtúir ná €3.2 milliún, sin 14% de chostais ionmlána an Bhoird (12% i 2006).

I 2007, méadaíodh ioncam go €23.5 milliún rud a fhágann farasbarr don bhliain de €318,217. Bhí easnamh inteachta i gceist de €133,639, rud a d'fhág farasbarr carnach de €184,578.




FIGURE 1: Summary All Cases	FIGIÚR 1: Achoimre Gach Cás	2007	2006	Méadú/(laghdú) % Increase/ (decrease) %









During 2007, the Board complied with the statutory requirement that notice in writing be served on the parties to a case where it would not be possible or appropriate to determine the case within the statutory objective period. *Average time taken to dispose of cases (weeks)*



## Oral hearings

Appeals and referrals are generally dealt with on the basis of written submissions from the parties together with a site inspection by an inspector appointed by the Board. Oral hearings are generally held in relation to applications for Strategic Infrastructure Development. The Board has absolute discretion to hold an oral hearing of any case whether or not a hearing is requested.


## Inspectors' Reports and Recommendations

## NORMAL PLANNING APPEALS



### Introduction

Normal planning appeals i.e. under section 37 of the 2000 Planning Act (and under section 26 of the 1963 Planning Act for old planning cases) accounted for 88% of the intake of cases in 2007. Normal planning appeals arise from decisions by planning authorities on applications for permission for the development of land.

Normal planning appeals may be first party, third party or first and third party. Appendix 1 analyses the above categories of appeals and the effect of appeal decisions by reference to the category of appeal and the planning authority decision.



### Invalid Appeals

The rate of invalid appeals in 2007 reduced from 14.8% in 2006 to 12.5% of the total disposed. This was probably as a result of measures taken by the Board.

**Late:** The period for making an appeal is four weeks starting on the day the planning authority make their decision. The Board's website has an interactive ready reckoner designed to assist in calculating the last day for making an appeal.

**No acknowledgement:** The stringent requirements of the 2000 Act generally require a third party appellant to include an acknowledgement from the planning authority of their submission or observation made at application stage.

**Name and address:** An appeal must state the name and address of the appellant and of the person, if any, acting on his/her behalf.



## Appeals by Area

An analysis of planning application decisions, appeals and appeal decisions for each county and city area is shown in Appendix 2. Overall, the number of appeals received as a percentage of planning authority decisions on planning applications was 6.7%, compared to 6.9% in 2006.

Dun Laoghaire/Rathdown (22.4%), Dublin City (15.7%) and Limerick City (15.4%) had the highest levels of decisions appealed. Areas with the highest rate of appealed decisions overturned by the Board were Wexford (47.8%), Cavan (47.2%) and Offaly (42.3%) while those with the lowest rate of appealed decisions overturned were Waterford City (16.7%), Kilkenny County Council (22.4%) and South Tipperary County Council (23.1%).



## Major Infrastructure Appeals

The number of major infrastructure appeals received during 2007 was 57. The number disposed of was 55, of which 13% were disposed of within the statutory objective period. The average time taken to dispose of major infrastructure appeals was 34 weeks. The following are the broad criteria that are currently applied in deciding whether a planning appeal should receive major infrastructural status:

- National and/or local/regional projects of exceptional economic significance,
- Significant employment potential,
- Exceptionally large-scale industrial/commercial/residential projects including very large scale mixed projects,
- Energy generation and transmission projects,
- Significant windfarm projects,
- Landfill, waste, waste/water, incinerators,
- Mining/major quarrying projects,
- Major medical facilities,
- Strategic Development Zones.

## Submission of documents to the Board by Planning Authorities

In 2007, planning authorities submitted the planning file and other documents in relation to appeals to the Board within the statutory period of two weeks in 69% of appeals (70% in 2006).

## Rural Housing

The Minister for the Environment, Heritage and Local Government launched the Sustainable Rural Housing Guidelines in April 2005. As the guidelines are issued under section 28 of the Planning and Development Act 2000 the Board must have regard to them.

An analysis of the outcome of appeals relating to one-off rural houses is contained in Appendix 5.

## STRATEGIC INFRASTRUCTURE CASES



The Planning and Development (Strategic Infrastructure) Act 2006 was enacted in 2006 and came into force on 31st January 2007. Under this Act the Board has become the single planning consent authority for certain major infrastructure projects on the transport, energy and environment areas (whether promoted by the public or private sector), including rail transport, gas pipelines and electricity generation and transmission. It has also been given responsibility for determining applications for compulsory acquisition relating to gas, airport and railway projects. The Board has published a number of guidelines advising applicants and local authorities of the procedures to be followed and advising the general public and interested bodies on how they can participate in the process. These guidelines are available on the Board's website.

The new procedures normally require applicants to engage in pre-application consultations with the Board which will be followed by a ruling from the Board as to whether the particular project will be treated as a strategic infrastructure project in accordance with the new Act.

The Act also provided that local authority infrastructure projects requiring environmental impact assessment are now also classified as strategic infrastructure (as is any compulsory acquisition application relating to such a proposed development). Determination of these local authority cases has been a Board function since 2001. They are not subject to a pre-application consultation requirement.

Fees have been determined and approved in respect of strategic infrastructure applications lodged on or after the 10th of December 2007 (€100,000 application fee and €50 observer fee).

The functions assigned to it under the Act are performed by the Strategic Infrastructure Division of the Board, comprising the Chairperson, Deputy Chairperson and three other members (Margaret Byrne, Angela Tunney and Karl Kent).

Of the concluded consultations in respect of proposed developments, 10 were deemed strategic infrastructure, 19 were deemed not strategic infrastructure and 4 were withdrawn.

Those local authority projects which also classify as Strategic Infrastructure since 31st January, 2007, are indicated in the chart below:

### Operation of the new Provisions:

The Board received 74 requests to enter into pre-application consultations in 2007 and it held 97 meetings relating to these requests during the year. The Board has been represented at such meetings by teams drawn from its professional planning and administrative staff. The main purposes of the pre-application consultation process are to enable the Board consider whether the proposed development should be deemed strategic infrastructure by reference to the criteria in the Act, advise prospective applicants regarding what considerations related to proper planning and sustainable development or the environment, may have a bearing on its decision in relation to any application and to also advise on the procedures involved in the making and consideration of a direct application to An Bord Pleanála. The pre-application consultation process does not involve the Board in any assessment of the merits of a proposed development as any such consideration is reserved until the formal planning application stage.

Of the 74 consultation requests, 33 were disposed of during the year, leaving 41 on-going at the start of 2008. The Board received three non-local authority strategic infrastructure development applications in the latter half of 2007. Two of these cases have already been determined in early 2008, and both of these decisions were made within the statutory objective period of 18 weeks following oral hearings into the applications.

## OTHER CASES

### Other Cases under Planning, Building Control, Water Pollution and Air Pollution Acts

Apart from normal planning appeals and local authority projects, other functions have been assigned to the Board under the Planning Acts; the Building Control Acts 1990 and 2007; the Local Government (Water Pollution) Acts 1977 to 2007; and the Air Pollution Act 1987. A summary of the various cases which came before the Board in 2007 is set out in Figure 12.





### Consultants, Advisers and Part-Time Consultant Inspectors

The Board has the power to engage such consultants and advisers as it considers necessary for the discharge of its functions.


During 2007, the Board retained, under section 124 of the 2000 Planning Act, the services of professional consultants to advise it on specialist matters arising in certain appeals.

In accordance with section 120(2) of the Act, the Board continued the engagement of part-time consultant inspectors having regard to the need to comply with the Board's statutory time objective of determining cases. Fee-per-case (FPC) Inspectors, who are all qualified planners, generally report on the smaller/less complex planning appeals. Qualified planners from professional consultancy firms (PCFs) were also engaged on a limited basis (following an open tendering process in 2001) to report on larger/more complex planning appeals.

The Board also engaged part-time consultants (PTCs), mostly engineers with appropriate experience, to conduct oral hearings and make reports and recommendations in relation to local authority infrastructure projects, e.g. road/motorway schemes, waste etc.


**FIGURE 13**

Figure 13 shows the number of reports received from part-time consultant inspectors in 2007 and 2006. The number of reports received from these inspectors in 2007 represented 43% of all reports received, (48% in 2006).

## FINANCE



### Fees

Fees are payable to the Board by parties in respect of strategic infrastructure development applications, appeals, referrals and certain other matters which are submitted to the Board for determination and in relation to requests for oral hearings under the Planning, Water Pollution, Air Pollution and Building Control Acts.

Fees are also payable by certain persons/bodies other than parties, generally known as “observers”, in respect of submissions or observations made to the Board.

Gross receipts from fees in 2007 amounted to €3,676,319 of which €755,422 was refunded where appeals were found to be late or otherwise invalid. In 2007, the net receipts from fees represented about 12.6% of total expenditure (11% in 2006).

### Income and expenditure

In 2007, total expenditure amounted to €23,213,677 while income amounted to €23,531,894 leaving a surplus for the year of €318,217. There was an incoming surplus of €133,639 which left a surplus of €184,578.

The accounts are reproduced in Appendix 10. Certification under the Prompt Payment of Accounts Act 1997 is in Appendix 7.

### Members' salaries and expenses

Members of the Board may hold no other employment and are paid salaries under the PAYE system. Fees are not paid to members.

A statement on Remuneration and Members' fees is in Appendix 9.

### Internal Audit and Financial Control

The Code of Practice for the Governance of State Bodies has been adopted and is being complied with and, in particular, appropriate procedures for financial reporting, procurement and assets disposal are being carried out. A statement on the system of Internal Financial Control is in Appendix 8.

## LEGAL PROCEEDINGS



There is no automatic right of appeal to the Courts in respect of decisions made by the Board on appeals, referrals and local authority project cases. Under the 2000 to 2007 Planning Acts, such decisions can only be challenged by way of an application for judicial review to the High Court.

During 2007, High Court judicial review proceedings arising from the Board's decisions and procedures in relation to appeals and other matters were instituted in 32 cases (23 in 2006). In the course of the year proceedings were discontinued or dismissed in 11 cases (9 in 2006). Leave applications for judicial review were refused in 3 cases (4 in 2006).

High Court judgements on substantive cases were given in 4 (2 in 2006) cases, 2 (4 in 2006) of which found in favour of the Board and 2 (8 in 2006) against. In respect of the latter cases, 4 (3 in 2006) of these decisions were in circumstances where the Board consented to the quashing of its decision order due to procedural defects while one other resulted in quashing of Board Order as a consequence of legal defects in the local planning authority handling of the relevant planning application.

## ACCESS TO INFORMATION



The Planning Acts, the Freedom of Information Act and Access to Information on the Environment Regulations provide for access to certain information on the Board's operations. Casework files are available for inspection free of charge on the third working day after the case is decided and copies of documents can be purchased. The Board's decision order and direction and the Inspector's report are also available on the Board's website.

The number of public access requests for casework files was 2,391 in 2007.

## CUSTOMER SERVICES/COMPLAINTS



In 2007, the Board received 343 letters in relation to decided cases and replied to 302. The nature of the correspondence was varied and not all would constitute a complaint. The following breakdown is based on the main reason for a contact. It is designed to illustrate the main reasons for correspondence, but it is often the case that the correspondence contains elements of several types of contact. For example, queries where both interpretation and enforcement is involved.

As the Board can only direct the person to the planning authority with such queries, anyone with an interest in such matters should contact the planning authority directly.

During 2007, the Board met with the National Parks and Wildlife Service (NPWS), Irish Rural Dwellers Association (IRDA), Joint Oireachtas Committee on the Environment, Heritage and Local Government, Irish Home Builders Association (IHBA), Irish Business and Employers Confederation (IBEC), Irish Planning Institute (IPI), Commission for Communications Regulations (ComReg), Institute of Engineering Ireland (IEI), County & City Managers Association x 2 (CCMA) - Planning Sub-Group, Industrial Development Authority (IDA) and the Environmental Protection Agency (EPA).







# Analysis of rural housing decisions



### Prompt Payment of Accounts Act 1997

The Board comes within the scope of the Prompt Payment of Accounts Act 1997, as amended by the European Communities (Late Payment in Commercial Transactions) Regulations 2002. The payment practices of the Board are reported on below for the year ended 31 December 2007 in accordance with section 12 of the Act.

1. It is the Board's policy to comply with the relevant provisions of the Act and, in particular, to ensure that all invoices are paid promptly. Specific procedures are in place that enable it to track all invoices and ensure that payments are made before the due date. Invoices are registered daily and payments are made as required to ensure timely payments. In 2007, the Board did not set or agree payment periods outside the terms of the Act.
2. The system of internal control incorporates such controls and procedures as are considered necessary to ensure compliance with the Act. This system includes accounting and computer controls designed to ensure the identification of invoices and contracts for payment within the payment periods required by the Act. Reports are produced that identify unpaid outstanding invoices and these reports are reviewed regularly at a senior level.
3. The procedures referred to at 1 and 2 above are designed to provide reasonable but not absolute assurance against material non-compliance with the Act. The Board is satisfied that its procedures have operated adequately in the main and that no remedial action is required.

### Statement on System of Internal Financial Control

#### Responsibility for System of Internal Financial Control

On behalf of the Board of An Bord Pleanála, I acknowledge our responsibility for ensuring that an effective system of internal financial control is maintained and operated.

The system can only provide reasonable and not absolute assurance that assets are safeguarded, transactions authorised and properly recorded, and that material errors or irregularities are either prevented or would be detected in a timely period.

#### Key Control Procedures

The Board has taken steps to ensure an appropriate control environment by:

- clearly defining management responsibilities;
- establishing formal procedures for reporting significant control failures and ensuring appropriate corrective action.

The Board established a process to identify and evaluate business risks by putting in place an Audit Needs Risk Assessment which led to formally-

- identifying the nature, extent and financial implications of risks facing the body including the extent and categories which it regards as acceptable;
- assessing the likelihood of identified risks occurring;
- assessing the costs of operating particular controls relative to the benefit obtained.

The Board proposes to undertake this process on an on-going basis. The system of internal financial control is based on a framework of regular management information, administrative procedures including segregation of duties, and a system of delegation and accountability. In particular it includes:

- a comprehensive budgeting system with an annual budget which is reviewed and agreed by Board members;
- regular reviews by the management committee of periodic financial reports which indicate financial performance against forecasts;

Thar ceann Boird an Bhoird Phleanála, glacaim lenár ndualgas a chinntíú go bhfuil córas éifeachtach rialaithe airgeadais inmheánach á choimeád agus á fheidhmiú.

#### Príomh-lmeachteái Rialaithe

- gnáthaimh fhoirmíúla a bhunú chun teip rialaithe a thuairisciú agus gníomhaíocht cheartaithe cuí a chur ar bun.

Tá próiseas bunaithe ag an mBord chun rioscái gnó a aithint agus a mheas, trí Mheasúnú Rioscái na Riachtanas Iníúchóireachta a bhunú, d'fhonn, go fairmeálta:

- nádúir, méid agus impleachtaí airgeadais na rioscái roimh an gcomhlacht a shainaithint, lena n-áirítear an méid agus na catagóirí a mheasann sé a bheith inghlactha;
- an seans go dtarlóidh rioscái aitheanta a mheas;
- an costas a bhaineann le rialúchán áirithe a oibriú a mheas i leith an leas a bhaintear as.

Molann an Bord an próiseas seo a athbhunú ar bhonn leanúnach. Tá an córas rialaithe airgeadais inmheánach bunaithe ar fhráma eolais bainistíochta rialta, gnáthaimh riarracháin le dualgais a roinnt san áireamh, agus córas dealagáideachta agus freagrachta. Go háirithe san áireamh tá:

- córas cuimsitheach buiséadach le buiséad bliantúil atá athbhreithnithe agus aontaithe ag comhaltaí an Bhoird;
- athbhreithniú rialta ag comhaltaí an Bhoird ar thuarascálacha airgeadais bliantúla agus tréimhsíula a chuireann feidhmíocht airgeadais in iúl i gcoinne réamhaisnéisí;

- review by the Board members of annual financial estimates and financial reports;
- setting targets to measure financial and other performance;
- clearly defined capital investment control guidelines.

The Board appointed consultants to carry out its internal audit function for a number of years. It now proposes to appoint its own internal auditor at a senior level from within its own resources in 2008. This appointment is an integral part of a restructuring of the organisation approved by the Minister for the Environment, Heritage and Local Government given with the consent of the Minister for Finance. Pending the appointment of an internal auditor, the Board continues to apply the system of financial control referred to above. The work of internal auditor will operate in accordance with the Framework Code of Best Practice set out in the Code of Practice on the Governance of State Bodies. The work of internal audit will be informed by analysis of the risk to which the body is exposed, and annual internal audit plans will be based on this analysis. The analysis of risk and the internal audit plans will be endorsed by the Audit Committee and approved by the Board. A function of the Internal Auditor will be to provide the Audit Committee with a report of internal audit activity. The report will include the Internal Auditor's opinion on the adequacy and effectiveness of the system of internal financial control. There was no internal audit function or Audit committee in operation in the year 2007. The system for monitoring controls was not fully operating and therefore, did not comply with the requirements of the Code of Practice. The Board failed to fulfil its commitment to have an annual review of the system of financial control.

#### **Annual Review of Controls**

In the year 2007 the Board did not formally review the effectiveness of the system of internal financial control. The Board will fully conform with the requirements of the Code of Practice in 2008.

### Statement on Remuneration and Members' Fees

#### General

The Board complies with the guidelines covering the payment of fees to the Chairperson and other members of the Board set out in the Code of Practice for the Governance of State Bodies. The Board implements wage increases in accordance with sanction from the Department of the Environment, Heritage and Local Government. It does not depart from Government pay policy in any way.

#### Members' Fees and Expenses

The salary of the Chairperson, under section 105(14)(a) of the Planning and Development Act 2000, is set at the same salary as is paid to a judge of the High Court. The salary of the post of Deputy Chairperson is set at a rate equivalent to a maximum of the salary scale for an Assistant Secretary in the Civil Service. The salary of other members is set at a rate equivalent to the minimum of the Assistant Secretary scale in the Civil Service.

## Statement of Accounting Policies

### 1. General:

The Board was established under section 3 of the Local Government (Planning and Development) Act 1976.

Under the Planning and Development Acts 2000 to 2007, the Board is responsible for the determination of applications for strategic infrastructure development from 31 January 2007, appeals and certain other matters. The Board is also responsible for dealing with appeals under the Building Control Acts 1990 and 2007, the Local Government (Water Pollution) Acts 1977 to 2007, and the Air Pollution Act 1987.

### 2. Basis of Preparation:

The financial statements are prepared under the accruals method of accounting, except as otherwise indicated, and in accordance with generally accepted accounting principles under the historical cost convention. Financial reporting standards recommended by the recognised accountancy bodies are adopted, as they become operative.

### 3. Oireachtas Grant:

Oireachtas grants are accounted for on a cash receipt basis.

## Ráiteas faoi Bheartais Chuntasaíochta

### 1. Ginearálta:

Bunaíodh an Bord faoi alt 3 den Acht Rialtais Áitiúil (Pleanál agus Forbairt) 1976.

Faoi na hachtanna um Phleanál agus Fhorbartha 2000 go 2007, tá an Bord freagrach as cinneadh iarratas i gcomhair forbairt bonneagair straitéisigh ó 31 Eanáir 2007, aghomhairc agus céarsaí áirithe eile. Tá an Bord freagrach chomh maith as plé le hachomhairc faoi na hachtanna Rialaithe Tógála 1990 agus 2007, An tAcht Rialtais Áitiúil (Truailliú Uisce), 1977 go 2007, agus An tAcht um Thruailliú Aeir, 1987.

### 2. Bunús an Ullmhúcháin:

Tá na ráitis airgeadais ullmhaithe faoin modh fabhraithe cuntasáiochta, mura bhfuil a mhalaírt taispeánta, agus maidir le gnáth phrionsabail chuntasaíochta inghlactha faoin gcoinbhinsiún costais stáiriúil. Glactar le caighdeánin thuarascála airgeadais molta ag comhlachtaí aitheanta cuntasáiochta, faoi mar a thagann siad i bhfeidhm.

### 3. Deontas Oireachtas:

Déantar cuntasáocht ar dheontais Oireachtas ar bhonn fáltais airgid tirim.

#### 4. Fees:

In 2007, fees fixed by the Board in accordance with section 144 of the Planning and Development Act 2000, as amended, were payable to the Board in respect of strategic infrastructure development applications, appeals and referrals under that Act. Fees were also paid to the Board in accordance with regulations made by the Minister for the Environment, Heritage and Local Government under:

- section 10 of the Local Government (Planning and Development) Act 1982,
- section 7 of the Building Control Act 1990, as amended,
- sections 6 and 19 of the Local Government (Water Pollution) Act 1977, as amended, and
- section 35 of the Air Pollution Act 1987

in respect of appeals and certain other matters under those Acts. Fee income in the accounts is shown net of refunds, which are made in respect of invalid appeals, referrals and other cases.

#### 5. Fixed Assets and Depreciation:

Fixed assets, which are stated at historical cost, are depreciated using the straight-line method at an annual rate of 10% for leasehold buildings and 20% for all other asset categories.

#### 6. Capital Account:

The Capital Account represents the unamortised amount of income used to purchase fixed assets.

#### 4. Táillí:

maidir le hachomhairc agus gnóthaí eile faoi na hAchtanna seo. Taispeántar ioncam ó tháillí sna cuntas mar aisíoc glan ar aisfocaíochtaí a déantar maidir le hachomhairc neamhbhailí, tarchuir agus cásanna eile.

#### 5. Sócmhainní Seasta agus Dímheas:

Sócmhainní seasta, atá curtha síos ar luach stáiriúil, atá ag íslíú luacha ar an modh líne díreach ar ráta bliantúil de 10% do fhoirgnimh ar léas agus 20% do gach catagóir shócmhainne eile.

#### 6. Cuntas Caipitiúil:

Déanann an Cuntas Caipitil ionadú ar an méid ioncaim neamh-amúchta a úsáidtear chun sócmhainní seasta a cheannach.



## 7. Superannuation:

The Board operates defined benefit superannuation schemes through the medium of four different independent schemes namely:

- An Bord Pleanála Staff Superannuation Scheme 1986 to 2006
- An Bord Pleanála Staff Spouses' and Children's Contributory Pension Scheme 1986
- An Bord Pleanála (Chairman and Members) Superannuation Scheme 1986 to 2003
- An Bord Pleanála (Chairman and Members) Spouses' and Children's Contributory Pension Scheme 1986 to 2002.

The payment of superannuation benefits to and in respect of employees and members of the Board is provided for in these defined benefit superannuation schemes approved by the Minister for the Environment, Heritage and Local Government and with the consent of the Minister for Finance under section 119 of the Planning and Development Act 2000.

The schemes are funded annually on a pay-as-you-go basis from monies available to the Board, including monies from exchequer funds provided by the Department of Environment, Heritage and Local Government and from contributions deducted from staff and members' salaries.

Superannuation costs reflect superannuation benefits earned by members and employees in the period and are shown net of staff superannuation contributions, which are retained by the Board. An amount corresponding to the superannuation charge is recognised as income to the extent that it is recoverable, and offset by grants received in the year to discharge superannuation payments.

Actuarial gains or losses arising on scheme liabilities are reflected in the Statement of Total Recognised Gains and Losses and a corresponding adjustment is recognised in the amount recoverable from exchequer funds provided by the Department of Environment, Heritage and Local Government.

- Scéim Pinsean Ranníocach Céilí agus Leanaí (Cathaoirleach agus Comhaltaí) An Bhoird Phleanála 1986 go 2002.

Tá an íocaíocht de shochair aoisliúntais le agus maidir le fostaithe agus comhaltaí den Bhord forálte do sna scéimeanna aoisliúntais sochair sainmhínithe molta ag an Aire Comhshaoil, Oidhreachta agus Rialtais Áitiúil agus le cead an Aire Airgeadais faoi alt 119 den Acht um Phleanáil agus Forbairt 2000.

Tá na scéimeanna maoinithe go bliantúil ar bhonn 'íomar a théann tú' ó airgid ar fáil dó, lena n-áirítear airgid ón státhiste curtha ar fáil ag an Roinn Comhshaoil, Oidhreachta agus Rialtais Áitiúil agus ó ranníocaíochtaí asbhainte ó thuarastail na foirne.

Léiríonn costais aoisliúntais sochair aoisliúntais tuillte ag comhaltaí agus baill foirne sa tréimhse agus tá siad taispeánta glan de ranníocaíochtaí aoisliúntais na foirne, a choimeádann an Bord. Superannuation liabilities represent the present value of future superannuation payments earned by staff to date. Deferred superannuation funding represents the corresponding asset to be recovered in future periods from exchequer funds provided by the Department of Environment, Heritage and Local Government.

#### **8. Legal Costs:**

It is the policy of the Board to discharge any legal costs awarded against it following conclusion of cases on foot of taxed Bills of Costs. It is also the policy of the Board to discharge its own legal costs associated with applications for judicial review of the Board's decisions following presentation of cases in the High Court or Supreme Court.

The Board, where practicable, seeks recovery of its legal costs arising out of legal actions where such costs are awarded by the Courts (see Note 11). Income from such awards is accounted for on a cash receipt basis and the amount recovered is netted to legal expenditure fees in the current year.

In addition, outstanding costs are written off when they are deemed to be unrecoverable.

#### **9. Lease Costs:**

It is the policy of the Board to write off all ancillary costs associated with the new lease at 64 Marlborough Street, Dublin 1 over 10 years.

Déanfaidh an Bord, san áit go bhfuil sé praiticiúil, iarracht a gcostais dlí ag éirí ó chaingean dlí a athghabháil san áit go bhfuil costais molta ag na Cúirteanna (féach nota 11). 



### Note 2 Salaries and Allowances

At 31 December 2007, the Board consisted of a chairperson and 10 ordinary members, (ten members at the end of 2006) in accordance with section 104 of the Planning and Development Act 2000, as amended. Membership of the Board is wholetime.

At 31 December 2007, there were 170 whole time equivalent employees in the Board of which 10 were management, 52.5 were professional and 107.5 were administrative. The average number of wholetime equivalent employees during the year was 152.4 (138.8 in 2006). During 2007, there was no increase in the intake of cases. The volume of cases disposed of increased by 9%. Staffing levels are approved by the Minister for the Environment, Heritage and Local Government with the consent of the Minister for Finance.

These events include the statutory basis for the establishment of the superannuation scheme, and the policy and practice in relation to funding public service superannuation including contributions by employees and the annual estimates process. While there is no formal agreement regarding these specific amounts with the Department of Environment, Heritage and Local Government, the Board has no evidence that this funding policy will not continue to meet such sums in accordance with current practice. The deferred funding asset for superannuation at 31 December 2007 amounts to €62 million (2006: €62 million).

### Note 12 Consultants' Fees and Services

In accordance with section 120(2) of the Planning and Development Act 2000, the Board engages part-time consultant inspectors on a fee-per-case basis in accordance with rates approved by the Minister for the Environment, Heritage and Local Government with the consent of the Minister for Finance. In addition, the Board engages, in accordance with section 124 of the Act, other consultants and advisors, as it is necessary for the performance of its functions. In 2007, about 43% of all inspectors' reports came from part-time consultant inspectors and their fees, along with associated costs relating to recording of oral hearings, accounted for nearly 89% (2006:87%) of all consultancy fees and services costs.

### Note 13 Premises

The Board occupies and pays rent on premises at 64 Marlborough Street, Dublin 1 which is held on a 25 year lease from October 2001.

The costs in relation to the fit-out and certain other matters, other than normal establishment and operating costs, were allocated for capital purposes and included under Leasehold Premises in the Fixed Assets. Ongoing improvements to the premises are treated in a similar manner.

The financial commitment on the above lease is the annual rent which in 2007 was €1,106,582. The rent is currently undergoing a 5 year review with the landlord and any change will apply with effect from 1st January 2007. The Board has made provision in the accounts for an increase in 2007 in line with professional advice which it has received.

### Note 14 Board Members & Staff Interests

Board members and certain staff are required to make declarations/disclosures of interests in accordance with the provisions of the Planning and Development Act 2000.

Section 147 of the 2000 Act provides for statutory declarations by members and certain staff in relation to certain interests. A register of interests is maintained by the Secretary in accordance with section 147 of the Act and is available for public inspection during office hours.

I have audited the financial statements of An Bord Pleanála for the year ended 31 December 2007 under the Planning and Development Act 2000.

The financial statements, which have been prepared under the accounting policies set out therein, comprise the Statement of Accounting Policies, the Income and Expenditure Account, the Statement of Total Recognised Gains and Losses, the Balance Sheet, the Cash Flow Statement and the related notes.

#### Respective Responsibilities of the Board and the Comptroller and Auditor General

An Bord Pleanála is responsible for preparing the financial statements in accordance with the Planning and Development Act 2000 and for ensuring the regularity of transactions. An Bord Pleanála prepares the financial statements in accordance with Generally Accepted Accounting Practice in Ireland. The accounting responsibilities of the Members of the Board are set out in the Statement of Board's Responsibilities.

My responsibility is to audit the financial statements in accordance with relevant legal and regulatory requirements and International Standards on Auditing (UK and Ireland).

I report my opinion as to whether the financial statements give a true and fair view, in accordance with Generally Accepted Accounting Practice in Ireland. I also report whether in my opinion proper books of account have been kept. In addition, I state whether the financial statements are in agreement with the books of account.

I report any material instance where moneys have not been applied for the purposes intended or where the transactions do not conform to the authorities governing them.

I also report if I have not obtained all the information and explanations necessary for the purposes of my audit.

I review whether the Statement on the System of Internal Financial Control reflects An Bord Pleanála's compliance with the Code of Practice for the Governance of State Bodies and report any material instance where it does not do so, or if the

In the exercise of my function as Comptroller and Auditor General, I conducted my audit of the financial statements in accordance with International Standards on Auditing (UK and Ireland) issued by the Auditing Practices Board and by reference to the special considerations which attach to State bodies in relation to their management and operation. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures and regularity of the financial transactions included in the financial statements. It also includes an assessment of the significant estimates and judgments made in the preparation of the financial statements, and of whether the accounting policies are appropriate to An Bord Pleanála's circumstances, consistently applied and adequately disclosed.

I planned and performed my audit so as to obtain all the information and explanations that I considered necessary in order to provide me with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or other irregularity or error. In forming my opinion I also evaluated the overall adequacy of the presentation of information in the financial statements.
