1. How many staff were employed by An Bord Pleanála for the years 2020,2021, 2022, 2023,2024 as of December in each year - could this be provided in tabular form please
2. How many decisions made by An Bord Pleanála were overturned after judicial review;
3. What are the number of cases where An Bord Pleanála agreed with the court to overturn or amend a decision in 2023 and 2024;
4. How much was spent on legal fees in 2022,2023 and 2024
5. What is the budget for legal costs for the years 2025 and 2026
6. What is the annual budget for An Bord Pleanála
7. What are the annual payroll costs for An Bord Pleanála
8. What are the total number of applications awaiting a decision from An Bord Pleanála for 6,12,18,24,30,36 and 36+ months - could this be provided in tabular form please
9. What is the number of planning appeal cases awaiting decision from An Bord Pleanála as of 1st May 2025; the numbers of homes included included in those cases, how many involve single homes, how many involve multiple homes.

Please note we based the information in relation to housing units on instances where between 1 and 29 residential units, including apartments, and 30+ residential units have been appealed to ACP. Please note that a number of cases on hand over 12 months may have legal issues associated with the case or further information was required. We are currently working through the backlog of cases which were lodged in 2024 and expect to have all those cleared by the end of the year. So far in 2025 at end of July are compliance rate for cases lodged in 2025 is at 56% year to date for all case types in comparison to approximately 25% at the end of December, 2024.
