5. Strategic Infrastructure Applications (Private Entities and Statutory Undertakers) Received in 2020

- 110kV electrical substation and associated 110kV infrastructure required to connect a solar farm to the existing Mullingar to Kinnegad 110kV overhead line and associated ancillary site development works, townlands of Hightown or Balloughter, Co. Westmeath.
- Wind farm consisting of 21 wind turbines and all associated site works, Derrinlough and other townlands Co. Offaly.
- 220kV transmission line and a 220kV gas insulated switchgear (GIS) substation along with associated and ancillary works, townlands of Cruiserath, Goddamendy and Bay, Co. Dublin.
- 110kV substation with associated electrical plant, control buildings, welfare facilities, security fencing, additional internal access traces, 110kV overhead line grid connection to existing transmission line on site, which will consist of a 10 year permission, lands at Harristown, Castlejordan and Clongall, Co, Meath.
- A two-storey 110kV Gas Insulated Switchgear (GIS) substation, underground cable and all associated and ancillary site works, , former Clyde House, IDA Blanchardstown Business and Technology Park, Snugborough Road, Blanchardstown, Dublin 15.
- Brexit Infrastructure Installation of porta-cabin structures. Resurfacing and amalgamation of existing yards. Parking for heavy good vehicles, cars and bicycles. Gates, signage and all ancillary site works, Dublin Port, Dublin 3.
- Increase in annual total waste for treatment from currently permitted 235,000 tonnes to 250,000 tonnes, increase in annual amount of hazardous waste from currently permitted 10,000 tonnes to 25,000 tonnes, development of a aqueous waste tank farm, hydrogen generation unit, bottom ash storage building, development of a single storage warehouse, new concrete yard, weather canopy, demolition and rebuilding of an existing single storey modular office and ancillary site works, Carranstown, Duleek, Co. Meath.
- 400kV electricity transmission cables, extension to the existing Kilpaddoge Electrical Substation and associated works, between the existing Moneypoint 400kV Electrical Substation in the townland of Carrowdoita South County Clare and existing Kilpaddoge 220/110kV Electrical Substation in the townland of Kilpaddoge County Kerry. The development includes work in the foreshore, townland of Carrowdotia South Co. Clare, and Kilpaddoge Co. Kerry.

- 220kV substation with two underground transmission cables, Bracetown, Gunnocks, Paddingstown, Co. Meath.
- 110kv Air-Insulated Switchgear substation, electricity lines, on-site access tracks and all associated site development works, Knockardagur, Ballinakill, Co. Laois
- Clutterland 110kV GIS Substation building and two underground single circuit transmission lines, Grange Castle South Business Park, Dublin 22.
- 110kV gas insulated switchgear substation compound, associated dropdown transmission lines, and associated development at Drogheda IDA Business and Technology Park, Donore Road, Drogheda, Co. Meath
- 19 wind turbines, one meteorological mast, 110kV substation and all associated site development works, townlands of Ballydonaghan, Caherhurley, Coumnagun, Carrownagowan, Inchalughoge, Killokennedy, Kilbane, Coolready and Drummod, Co. Clare.
- Construction of windfarm (12 turbines) with associated works, various townlands Tooslenagh, Treankeel, Aughkeely, Co.Donegal.
- 22 wind turbines and all related site works and ancillary development, townlands of Glashaboy North, Coom (Hudson), Tooreen South, Killeagh, Coom (Fitzgerald), Knuttery, Mullenaboree, Knockacullata, Knoppoge, Carrig, Glannasack, Knockdoorty, Lackendarragh North, Glashaboy South, Toorgarrif, Castleblagh, Co. Wexford.
- 110kV electricity substation to connect to and serve a solar farm and all ancillary works, Lysaghtstown, Midleton, Co. Cork.

- Residential development with ancillary commercial uses (retail unit, café and créche) partically comprising a "Build to Rent" scheme on circa 9.69 hectares, townlands of Shanganagh, Cork Little and Shankill, Co. Dublin.
- Flood alleviation works along and adjacent to the River Poddle, Tymon North, Tallaght to Merchant's Quay, Dublin.
- Distributor road approximately 1.15km of single carriageway together with all ancillary and consequential works, comprising an urban Arterial Street, incorporating both footpath and cycle path provisions, and a bridge traversing the River Blackwater, Abbeyland, Navan, Co. Meath.
- Extension to and widening of existing runway, Waterford Regional Airport, in the townlands of Lisselan, Killowen, Ballgarran, Monamintra and Keiloge, Co. Waterford.
- An urban park and urban street a pedestrian and cyclist dominated street, including ancillary site works, Abbey Quarter (former Smithwicks Brewery site), Kilkenny City.


