About this Guide

This guide provides information about:

- Our opening hours over the period and when you can view decided case files.
- The 2025 Christmas and New Year holiday period in An Coimisiún Pleanála.
- How the nine days of Christmas and New Year holidays (from 24 December to 1 January inclusive) can affect you making appeals, applications, observations, requests, submissions with us.
- Two important rules on time limits and time periods over Christmas and New Year and examples of how these rules work and how they affect cases.

Introduction

Over Christmas 2025 and the New Year 2026 period An Coimisiún Pleanála will be **closed** on four days. These days are:

- 25 December 2025 A
- 26 December 2025 A
- 29 December 2025 A
- 1 January 2026 *△*

During the holiday period, we are **open** on three days:

- 24 December 2025
- 30 December 2025
- 31 December 2025

On the days we are open, you can still make appeals, applications, referrals and observations, submissions and request oral hearings. You can also view decided case files in our office, and our staff are available to answer any questions you may have.

The holiday period between 24 December and 1 January affects:

- The time limits when you can send or deliver documents to us,
- The time limits in statutory notice letters we may have sent to you.

Before we explain what happens between 24 December and 1 January inclusive (nine days), we need to explain **two important rules** which affect time limits and time periods. These are:

- 1. the **holiday period rule**, and
- 2. the **weekend rule**.

These rules are explained below.

1. Holiday Period Rule

Under the Planning and Development Acts, the holiday period is the following nine days (shaded **gold** in the calendar below):

- 24 December
- 25 December
- 26 December
- 27 December
- 28 December
- 29 December
- 30 December
- 31 December
- 1 January

During the holiday period, we are **open** on three days:

- 24 December
- 30 December
- 31 December

Note: Even though we are open on these days, the holiday period rule below **still** applies.

How the holiday period rule affects time limits for the public:

If you are due to make or want to make:

- An appeal
- An application
- An observation
- A request
- A submission

to An Coimisiún Pleanála on any of these nine days, the holiday period gives you between one and nine extra days to send or deliver your item.

Example: Making a planning appeal to An Coimisiún Pleanála

If the planning authority makes its decision on a case on Friday 28 November 2025, the last date for an appeal would be Thursday 25 December 2025. However, that is one of the days in the holiday period, so nine days are added after the due date of 25 December 2025 leaving the revised date of **Monday 5 January 2026**.

2. Weekend Rule

If the last date for us to receive documents is on a Saturday, Sunday, public holiday or other day when our office is closed, we can receive it by 5.30pm on the **next** working day that our office is open. **Example:** If you are due to send or deliver something on Saturday 3 January 2026, the next working day you can send or deliver your item will be **Monday 5 January 2026**.

Do both these rules apply to all cases handled by An Coimisiún Pleanála?

When calculating time limits over Christmas 2025 and New Year 2026, the rules that apply depend on the relevant Act as you see in table below.

Under the:	The rules that apply to these cases are
Planning and Development Acts	the holiday period rule and the weekend rule apply – in that order.
Building Control Acts and Water Pollution Acts	only the weekend rule applies.

The following pages describe how the holiday period rule and weekend rule apply first to Planning and Development Acts cases (see pages 9 to 14 inclusive). After this we describe, how only the weekend rule applies to the Building Control Acts, and Water Pollution Acts and European Union (Planning and Development) (Renewable Energy) Regulations 2025 (see page 15).

Planning and Development Acts Cases

When does the Holiday Period rule and Weekend rule apply?

Both these rules apply if you want to make:

- a planning appeal,
- a large-scale residential development appeal (LRD)
- a referral.
- an observation on a current appeal or an observation on a current application,
- a submission on documents we have sent you,
- an oral hearing request,
- an application, appeal or request on any other function under the Planning and Development Acts, for example:
 - Substitute Consents
 - Appropriate Assessments

What happens between 24 December and 1 January?

From 24 December to 1 January, the holiday period rule will apply to time limits and time periods. The weekend rule will **also** apply if the revised last day is a Saturday or Sunday.

Can I still send or deliver items to An Coimisiún Pleanála during Christmas and New Year?

Yes, you can still send or deliver your items to us during Christmas and New Year on the days we are open – Wednesday 24 December, Tuesday 30 December and Wednesday 31 December 2025. You **do not** have to wait until after the holiday period to send or deliver your item if you wish. You **must** follow all the statutory requirements to make a valid appeal, application, observation, request or submission. Important Note

Do not place your appeal, application, or request in the letterbox of our office and do not email it to us as your appeal, application, or request will be invalid. We recommend members of the public do not place their observation in the letterbox of our office or send it to us by email.

The fastest and easiest way to send us your observation is online. Use our online uploader facility at: https://online.pleanala.ie/en-ie/planning-appeals/observation
For submissions on appeal documents you have received from us, please follow the advice in the letter you have received from us or contact us for further help.

Example: My appeal is due to be received by Wednesday 31 December 2025 which is one of the days you are open over the holidays. Does this mean I have to submit it by that date?

No. Even though we are working on 24, 30 and 31 December 2025, anyone with an appeal (or other items in the list above) which is due to be received by these dates benefits from the extra time allowed under the holiday rule. These three days are treated as holidays when the rule is being applied. A calendar for reference of last dates for making a planning appeal is set out in the next section of this guide.

Calendar: Last dates to make a planning appeal (November 2025 to January 2026)

The tables below can help you work out the last day to make an appeal when the planning authority has made a decision **on and between** Monday 24 November 2025 and Friday 2 January 2026 (but it does not cover weekends). This table applies the holiday period rule and weekend rule when they are needed.

To find out the last date to make an appeal on a planning authority decision:

- Find the date that the planning authority made its decision on the planning application in the left-hand column of the relevant table.
- 2. Then go across to the right-hand column to see the last date you can make an appeal to An Coimisiún Pleanála.

Two Timeframe Examples for Planning Appeal Cases

Example 1

I want to make an observation on a planning appeal. An Coimisiún Pleanála received the last appeal on Friday 5 December 2025

The time limit to make your observation is **Monday 12 January 2026.**

Why?

- If the last planning appeal is received on Friday 5 December 2025 and you
 want to make an observation, the last day of the four-week period would be
 Thursday 1 January 2026 (see X symbol in calendar).
- 2. This four-week period includes all nine days of the holiday period.
- We add nine extra days to the last day for making an observation to An Coimisiún Pleanála. The last day to receive this observation is **Monday 12** January 2026 (see gold circle in calendar).

In this example, both the holiday period rule and weekend rule are used. First, the holiday period rule is applied; then the weekend rule.

Example 2

I am a party to an appeal and An Coimisiún Pleanála has sent me a copy of an appeal on Friday 12 December 2025, and I wish to make a submission on it.

The time limit for you to make a submission on the appeal is **Monday 19 January 2026**.

Why?

- 1. If we write to you with a copy of an appeal on Friday 12 December 2025 and you want to make a submission, the last day of the four-week period would be Thursday 9 January 2025 (see X symbol in calendar).
- 2. This four-week period includes all nine days of the holiday period.
- 3. The last day to make a submission is nine extra days after Friday 9 January 2026. This is Sunday 18 January 2026 when we are closed.
- The weekend rule applies and the last day to make your submission is the next working day our office is open which is **Monday 19 January 2026** (see gold circle in calendar).

In this example, both the holiday period rule and weekend rule are used. First, the holiday period rule is applied, then the weekend rule.

Building Control Acts and Water Pollution Acts Cases

The Christmas and New Year holidays also affect appeals under the Building Control Acts and Water Pollution Acts. There is an important difference to time limits on these cases compared to planning appeals and applications. **Only** the weekend rule applies to time limits on these cases. **The holiday period rule does not apply on a case under the Building Control Acts or the Water Pollution Acts.**

Example:

I want to make an appeal on a Fire Safety Certificate decision. The building control authority made the decision on the application on Wednesday 26 November 2025

The time limit for you to make your appeal is **Tuesday 30 December 2025**.

Why?

- For a decision made on Wednesday 26 November 2025, the last day of the one-month period would be Thursday 25 December 2025 (see X symbol in calendar below).
- We are closed on Thursday 25 December 2025 and Monday the 29th of December. The weekend rule is used and the last day to make an appeal is the next working day our office is open.
- 3. Therefore, the last day to receive this appeal is **Tuesday 30 December 2025** (see **gold** circle in calendar).
