Appendix 1: Matters to be Addressed by Applicant

1. Identify any errata or proposed changes, modifications or updates as required, including Draft Railway Order, associated Schedules and property drawings.
2. Submit copies of any agreements made for the purposes of the Thirteenth Schedule of the Draft Railway Order.
3. Address implications of any policy changes since lodgement of the application (e.g. Dublin City Development Plan 2022-2028, Fingal County Development Plan 2023-2029, Greater Dublin Area Transport Strategy 2022-2042, Climate Action Plan, National Biodiversity Action Plan etc.).
4. Address implications of any relevant legislative or guidance updates since lodgement of the application (e.g. TII Carbon Tool and Ambient Air Quality Standards Regulations 2023).
5. Identify additional projects permitted since lodgement of the application for the purposes of assessment of cumulative impacts and in-combination effects.
6. Address potential implications of the designation of the North West Irish Sea cSPA with regard to both Appropriate Assessment and the Biodiversity assessment contained in the EIAR. Identify if there have been any changes (e.g. Conservation Objectives or qualifying interests) for any relevant European Site.
7. Provide a list of all other consents, licences and approvals that will be required for the proposed development.

- Overview of the fire safety, emergency and evacuation strategies (to include basis for, and location of, 1 No. intervention shaft at Albert College Park as proposed and the need for separate fire brigade/emergency services lifts at each underground station).
- Character appraisal/impact assessment of Santry Lodge and its curtilage.

Any such documentation should also be uploaded to the application website (www.metrolinkro.ie) on the day that it is submitted to the hearing. An electronic version of documentation should also be made available in screen accessible format.

Appendix 2: Notes to all Parties

1. Please note that you may attend the Oral Hearing even if you do not wish to take part in it.
2. The hearing is divided into modules and geographical areas as set out in the Agenda. **Module 1 is limited to the listed topics only. These topics will not be permitted to be raised in Module 2.**
3. If you are not on the Agenda but you wish to make a request to make an oral submission, please approach the Board's administrative team on the first day of the hearing. The Inspector will consider your request and has ultimate discretion as to whether or not the request can be facilitated. If your request is approved, and you have not previously made a valid written submission, this may be subject to a fee of €50 which must be paid in cash on the day.
4. Each submission to the Oral Hearing shall comprise solely of a response to the Applicant's written response to your submission received by An Bord Pleanála and available on the application website (www.metrolinkro.ie). You may also respond to any matters raised by the applicant in their submission at the start at the oral hearing.
5. Questioning shall follow each individual submission to the Oral Hearing and the time allocated to each party in the Agenda includes for any such questions.
6. Submissions will only be heard within the appropriate geographical area. Once the hearing has moved on to the next area, no further submissions relating to previous areas will be permitted within that Module.
7. The Agenda is intended to be strictly adhered to. However, due to the scale and nature of the oral hearing, it may be subject to variation if the Inspector determines it is necessary to so do. In such an event, an updated Agenda will be placed on the Board's website (www.pleanala.ie) as the hearing progresses.
8. There is no obligation on any party to make a submission to the Oral Hearing or to ask questions. All written submissions already received will be considered by the Inspector and the Board. For this reason, submissions previously made in writing will not be permitted to be repeated at the Oral Hearing.

9. Any legal arguments should be made as part of the submission made by the relevant party.
10. You are reminded that the Board has no role or jurisdiction in the determination or the assessment of compensation and that any submission made to the Hearing should bear this in mind. No discussion regarding compensation will be facilitated.
11. Written statements may be submitted to the Hearing. However, there is no obligation on persons appearing at the Hearing to do so. If such statements are submitted, it shall be necessary to have sufficient copies available for circulation to other parties. This would also apply to any document/plan/drawing presented to the Hearing. Six copies of any written documentation should also be submitted for the Board file.
12. No party is required to make concluding remarks. These should not be a further exposition of the case made by the party and should not introduce new information or legal arguments.
13. On completion of the Oral Hearing, the Inspector will prepare a report and recommendation on the case for the Board. The decision to approve or not to approve the Railway Order will be made by the Board.
14. The Board may direct the payment of a contribution towards the costs to any person appearing at an Oral Hearing, which have been incurred by that person, as a consequence of appearing at the Hearing. Any payment will be at the Board's discretion. Any application for costs should be made in writing to the Board within three weeks of the closing date of this hearing.
