In the case of Mr Tony Lowes and Dept of Agriculture, Food and the Marine, https://www.ocei.ie/en/ombudsman-decision/fa13a-mr-tony-lowes-and-the-department-of-agriculture-food-and-the-marine/ , the Commissioner stated: My view of the matter is bolstered by reference to the Aarhus Guide, which confirms that "it is clear that the expression 'in the course of completion' relates to the process of preparation of the information or the document and not to any decision-making process for the purpose of which the given information or document has been prepared". The Guide also explains: "Similarly, the mere status of something as a draft alone does not automatically bring it under the exception. The words 'in the course of completion' suggest that the term refers to individual documents that are actively being worked on by the public authority. Once those documents are no longer in the 'course of completion' they may be released, even if they are still unfinished and even if the decision to which they pertain has not yet been resolved.
