I understand that An Bord Pleanála has confirmed that it will not contest a High Court challenge to its planning approval for the Banagher Chilling meat processing plant in Banagher, Co. Offaly despite the board initially approving Offaly County Council's granting of permission for the development in June 2022.

I am asking for an urgent update on this matter as an elected representative for the area and for Offaly.

The decision by ABP has generated considerable local frustration and indeed anger.

I refer to your query in respect of a decision of An Bord Pleanála dated 3rd June, 2022 to grant permission subject to conditions for a proposed extension to an existing abattoir in Banagher, County Offaly (case 308064/20). This decision was the subject of a judicial review application to the High Court.

While An Bord Pleanála did inform the Court that it was not intending to defend the proceedings it is understood that the notice party applicant for permission advised that it intended to defend the proceedings.

Having regard to these on-going legal processes An Bord Pleanála is not in position to advise or comment further at this point in time.
