I was contacted by constituents regarding a development at Coolymurraghue, Upper Leemount, Kerry Pike, Cork.

They are wondering if An Bord Pleanála can clarify its position on the creche in Milboro, Kerry Pike?

The creche after a previous creche has failed to materialise by the same developer and was to be built before any house was occupied in Phase 1.

This was in the CCC conditions 7, An Bord Pleanála conditions 1 and enforcement complaint from the Clogheen Kerry Pike Community Association back last July and has not been acted on.

Can a definitive answer please be provided?

One further query I received, does condition no.1 of ABP ruling encompass condition no.7 from CCC?

Substantive Reply:

The Board's decision in relation to ABP 314905-22 contained 23 conditions in total. Condition no. 1 provides that, "Where such conditions requires details to be agreed with the planning authority, the developer shall agree such details with the planning authority prior to the commencement of development.....". Please note that a number of the conditions attached to this Board decision require the developer to seek prior agreement. One of the conditions is condition number 7 of the Board's decision – see attached decision. This is the condition now being referred to by Cork County Council.
