

### **Query:**

- 1. The amount of times the ACP Inspector has been overruled by the ACP Commission in the area of Meath County Council, can you provide for the last year please*
- 2. I am seeking to find out how many times in the last 10 years An Coimisiún Pleanála has lost a Judicial Review.*

### **Substantive Reply**

In response to part (1):

Between 1 October 2023 and 30 September 2025, a total of 236 cases associated with Meath County Council were formally disposed. Three of these were Leave to Appeal cases (where a Planning Inspector is not involved), and five cases have no recorded details. In 212 cases, the Commission generally accepted the recommendation of the ACP Planning Inspector. In 16 cases, the Commission did not accept the Inspector's recommendation.

Information relating to legal proceedings is detailed in the Commission's Annual Report and Accounts. *It has come to my attention that the three properties being constructed under the above planning reference are breaching the permitted height restrictions under the approved proposal. The original planning application was refused by South Dublin County Council but was granted on appeal to ACP.*
