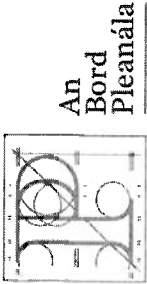

The below formatted three initialled pages include some 200 complaints made by me to the DAA and returned by DAA to me further to a GDPR request for same. All these request relate directly to my being awoken by flights. As you will see virtually all complaints were made at the time I was awoken, generally between midnight and 0600. The small number logged by DAA outside these time would relate to having been awoken the previous night.

I believe that these awakenings are having a detrimental impact upon my health and that of my family

I believe that the below listings provide ABP with a unique insight into data held be DAA. Indeed it is a minute part of a dataset which ABP might seek to elicit in an anonymised format from DAA relating to all complaints.

Furthermore, I herein give staff in An Bord Pleanala full permission to obtain copies of this data from DAA in order to verify the authenticity if what I have submitted.
