



## Fógra maidir le hEolas Suntasach Breise i ndáil le hachomharc reatha i leith úsáid oíche an chórais rúidbhealaigh ag Aerfort Bhaile Átha Cliath

Tugtar fógra leis seo go bhfuil eolas suntasach breise faighte ag an mBord ón iarratasóir, DAA PLC, a mheasann an Bord go bhfuil faisnéis shuntasach bhreise ann ar éifeachtaí na forbartha a bheartaitear ar an gcomhshaol. Fuarthas an t-eolas suntasach breise, lena n-áirítear Forlíonadh Tuarascála um Measúnú Tionchair Timpeallachta, mar fhreagra ar iarratas ar fhaisnéis bhreise ó fhógra a eisíodh ón mBord Pleanála an 26 Bealtaine 2023. Baineann an cás seo le hachomhairc a rinneadh chuir an mBord Pleanála i gcoinneann cinnidh a rinne Comhairle Contae Fhine Gall an 8 Lúnasa 2022, ar a bhfuil an uimhir thagartha pleánala thusa, ar cinneadh é sin cead a thabhairt le coinniollacha do DAA PLC chun 'gníomh ábhartha' a dhéanamh laistigh de bhrí Alt 34C den Acht um Pleanál agus Forbairt 2000 amháin, arna leasú, ag Aerfort Bhaile Átha Cliath, Co. Bhaile Átha Cliath, sna bailte fearainn seo: Baile Choilín, Tobar Buinne, An Coimín, Clochrán, An Corrbhaile, Coltraí, Port Mhaolól, Baile Anraí, Cnoc na Seangán, Cnoc an Ghainimh, Baile an Huntaigh, Baile an Phiocardhaigh, Dún Bró, Ceann an Mhuilinn, Baile an Rí, Baile an Bharbaigh, An Fhoraois Mhór, An Fhoraois Bheag agus An Charraig ar shuíomh c. 580 heicteár. Baineann an gníomh ábhartha atá beartaithe le húsáid oíche an chórais rúidbhealaigh ag Aerfort Bhaile Átha Cliath. Baineann sé le leasú ar an srian oibriúcháin atá leagtha amach i gcoinnioll uimh. 3(d) agus athsholáthar an tsriain oibriúcháin i gcoinnioll uimh. 5 de Chead Pleanála an Rúidbhealaigh Thuaidh (Comhairle Contae Fhine Gall Uimh. Thag. F04A/1755; ABP Uimh. Thag. PL06F.217429, arna leasú ag Comhairle Contae Fhine Gall F19A/0023, ABP Uimh. Thag. ABP-305289-19), chomh maith le bearta nua maolaithe torainn a mholaodh. Níor tháinig coinniollacha uimh. 3(d) agus 5 i bhfeidhm go fóill, toisc go bhfuil tógál an Rúidbhealaigh Thuaidh de bhun Chead Pleanála an Rúidbhealaigh Thuaidh ar siúl. Is é an gníomh ábhartha molta, dá gceadófaí é, ná deireadh a chur leis an teorainn uimhriúil ar lón na n-eitiltí a cheadaítear idir na huaireanta 11pm agus 7am go laethúil atá le teacht i bhfeidhm de réir Chead Pleanála an Rúidbhealaigh Thuaidh agus cuóta bliantúil torainn oíche idir na huaireanta 11.30pm agus 6am a chur ina ionad agus ceadú, ina theannta sin d'eitiltí éirí de thalamh agus/nó turirlingt ar an Rúidbhealach Thuaidh (Rúidbhealach 10L 28R) ar feadh 2 uair sa bhereis i.e. 2300 a chlog go 2400 a chlog agus 0600 a chlog an chloig go dtí 0700 a chlog. Tríd is tríd, cheadódh sé seo méadú ar lón na n-eitiltí ag éirí de thalamh agus/nó ag turirlingt ag Aerfort Bhaile Átha Cliath idir 2300 a chlog agus 0700 a chlog sa bhereis ar an lón atá sonraithe i gcoinnioll uimh. 5 de Chead Pleanála an Rúidbhealaigh Thuaidh, de réir an chuóta bhliantúil torainn oíche.

Is é an gníomh ábhartha de bhun Alt 34C(1)(a): Leasú a dhéanamh ar choinnioll uimh. 3(d) de Chead Pleanála an Rúidbhealaigh Thuaidh (Comhairle Contae Fhine Gall Uimh. Thag. F04A/1755; ABP Uimh. Thag.: PL06F.217429 arna leasú ag Comhairle Contae Fhine Gall F19A/0023, ABP Uimh. Thag. ABP-305289-19). Luanairtear an méid seo a leanas i gCóinnioll 3(d) agus sna heisceachtaí ag deireadh Choinnioll 3: '3(d). Ní úsáidfear rúidbhealach 10L-28R le haghaidh éirí de thalamh nó turirlingthe idir 2300 a chlog agus 0700 a chlog ach amháin i gcásanna sábháilteachta, cúinsí cothabhála, dálái eisceachtúla aerthráchta, drochaimsir, lochtanna teicniúla i gcórais rialaithe aerthráchta nó éigeandálai dearbhaite ag aerfoirt eile.' Tá cead á lorg chun an coinnioll thuras a leasú ionas go léifidh sé: 'Ní úsáidfear rúidbhealach 10L-28R le haghaidh éirí de thalamh nó turirlingthe idir 0000 a chlog agus 0559 a chlog ach amháin i gcásanna sábháilteachta, cúinsí cothabhála, dálái eisceachtúla aerthráchta, drochaimsir, lochtanna teicniúla i gcórais rialaithe aerthráchta nó éigeandálai dearbhaite. aerfoirt nó áit a bhfuil fad Rúidbhealach 10L-28R ag teastáil le haghaidh cineál sonrach aerárthaigh.' D'athróid glanéifeacht an athraithe bheartaithe, dá gceadófaí é, gnáthuaireanta oibriúcháin an Rúidbhealaigh Thuaidh ó 0700 a chlog go 2300 a chlog go 0600 a chlog go 0000 a chlog. Is é an gníomh ábhartha freisin: Coinnioll uimh. 5 de Chead Pleanála an Rúidbhealaigh Thuaidh (Comhairle Contae Fhine Gall Uimh. Thag. F04A/1755; ABP Uimh. Thag.: PL06F.217429 arna leasú ag Comhairle Contae Fhine Gall F19A/0023, ABP Uimh. Thag. ABP-305289-19) ina bhforáiltear mar seo a leanas: '5. Ar chríoch thogháil an rúidbhealaigh a cheadaítear leis seo, ní rachaidh meánlíon na ngluaiseachtaí aerárthaí oíche ag an aerfort tarth 65 in aghaidh na hoíche (idir 2300 a chlog agus 0700 a chlog) nuair a thomhaistear é thar an tréimhse samhailte 92 lá mar atá leagtha amach sa fhreagra ar an iarratas ar eolas breise a fuair an Bord Pleanála ar an 5ú lá de Dháirí, 2007. An chíos: Minicíocht na n-eitiltí oíche ag an aerfort a rialú chun taitneamhacht chónaithe a chosaint ag féachaint don eolas a cuireadh isteach maidir le húsáid oíche amach anseo ar an rúidbhealach comhthreomhar atá ann faoi láthair.' a chealú agus an méid seo a leanas a chur ina ionad: 'Tá córas cuóta torainn á mholaodh do thorann oíche ag an aerfort. Beidh an t-aerfort faoi réir cuóta bliantúil torainn 7990 idir na huaireanta 2330 a chlog agus 0600 a chlog.' I dteannta leis an gcuóta torainn oíche atá beartaithe, molann an gníomh ábhartha na bearta maolaithe torainn seo a leanas: - Scéim deontais inslithe torainn le haghaidh teaghaisí incháilíte laistigh de chomhrianta sonracha torainn oíche; - Creat mionsonraithe Monatóireachta Torainn chun monatóireacht a dhéanamh ar feidhmíocht torainn a dtuairisceofar na tortaí go bliantúil don Údarás Inniúil um Thorann Aerárthaí (ANCA), i gcomhréir leis an Acht um Rialáil Torainn Aerárthaigh (Aerfort Bhaile Átha Cliath) 2019. Ní lorgaonn an gníomh ábhartha molta aon leasú ar choinniollacha Chead Pleanála an Rúidbhealaigh Thuaidh a rialáinn oibriú ginearálta an chórais rúidbhealaigh (i.e., coinniollacha nach mbaineann go sonrach le húsáid oíche, eadhon coinniollacha uimh. 3(a), 3(b), 3(c) agus 4 de Chead Pleanála an Rúidbhealaigh Thuaidh) ná aon leasú ar acmhainn bhliantúil ceadaithe phaisinéirí na gCríochfort ag Aerfort Bhaile Átha Cliath. Forálann coinnioll uimh. 3 de Chead Pleanála an Chríochfort 2 (Comhairle Contae Fhine Gall Uimh. Thag. F04A/1755; ABP Uimh. Thag. PL06F.220670) agus coinnioll uimh. 2 de Chead Pleanála Sínte Chríochfort 1 (Comhairle Contae Fhine Gall, Uimh. Thag. F06A/1843; ABP Uimh. Thag. PL06F.223469) nach sáróidh acmhainn chomhcheangailte Chríochfort 1 agus Chríochfort 2 i dteannta a chéile 32 milliún paisinéirí sa bhliain.

Beidh an t-eolas breise a chuir an tlárratasóir isteach, lena n-áirítear Forlíonadh Tuarascála um Measúnú Tionchair Timpeallachta, ar fáil lena iniúchadh agus/nó lena ceannach ar tháille nach mó ná an costas réasúnach a bhaineann le cóip a dhéanamh in oifigi Chomhairle Contae Fhine Gall, Halla an Chontae, An Phriomhshráid, Sord, Co, Baile Átha Cliath, K67 X8Y2 agus/nó An Bord Pleanála, 64 Sráid Maoilbhríde, Baile Átha Cliath 1.

## Notice of Significant Additional Information in relation to a current appeal in respect of night-time use of the runway system at Dublin Airport

Notice is hereby given that the Board has received significant additional information from the applicant, DAA PLC, which the Board considers contains significant additional information on the effects on the environment of the proposed development. The significant additional information, which includes an Environmental Impact Assessment Report Supplement, was received in response to a request for additional information from a notice which issued from An Bord Pleanála on 26th May 2023. This case relates to appeals made to An Bord Pleanála against a decision made on 8th August 2022 by Fingal County Council, bearing the above planning reference number which decision was to grant permission with conditions to DAA PLC for the taking of a 'relevant action' only within the meaning of Section 34C of the Planning and Development Act 2000, as amended, at Dublin Airport, Co. Dublin, in the townlands of Collinstown, Toberbunny, Commons, Cloghran, Corballis, Coultry, Portmellick, Harristown, Shanganhill, Sandyhill, Huntstown, Pickardstown, Dunbro, Millhead, Kingstown, Barberstown, Forrest Great, Forrest Little and Rock on a site of c. 580 ha. The proposed relevant action relates to the night-time use of the runway system at Dublin Airport. It involves the amendment of the operating restriction set out in condition no. 3(d) and the replacement of the operating restriction in condition no. 5 of the North Runway Planning Permission (Fingal County Council Reg. Ref. No. F04A/1755; ABP Ref. No. PL06F.217429 as amended by Fingal County Council F19A/0023, ABP Ref. No. ABP-305289-19), as well as proposing new noise mitigation measures. Conditions no. 3(d) and 5 have not yet come into effect or operation, as the construction of the North Runway on foot of the North Runway Planning Permission is ongoing. The proposed relevant action, if permitted, would be to remove the numerical cap on the number of flights permitted between the hours of 11pm and 7am daily that is due to come into effect in accordance with the North Runway Planning Permission and to replace it with an annual night-time noise quota between the hours of 11.30pm and 6am and also to allow flights to take off from and/or land on the North Runway (Runway 10L 28R) for an additional 2 hours i.e. 2300 hrs to 2400hrs and 0600 hrs to 0700 hrs. Overall, this would allow for an increase in the number of flights taking off and/or landing at Dublin Airport between 2300 hrs and 0700 hrs over and above the number stipulated in condition no. 5 of the North Runway Planning Permission, in accordance with the annual night time noise quota.

The relevant action pursuant to Section 34C (1) (a) is: To amend condition no. 3(d) of the North Runway Planning Permission (Fingal County Council Reg. Ref. No. F04A/1755; ABP Ref. No.: PL06F.217429 as amended by Fingal County Council F19A/0023, ABP Ref. No. ABP-305289-19). Condition 3(d) and the exceptions at the end of Condition 3 state the following: '3(d). Runway 10L-28R shall not be used for take-off or landing between 2300 hours and 0700 hours except in cases of safety, maintenance considerations, exceptional air traffic conditions, adverse weather, technical faults in air traffic control systems or declared emergencies at other airports.' Permission is being sought to amend the above condition so that it reads: 'Runway 10L-28R shall not be used for take-off or landing between 0000 hours and 0559 hours except in cases of safety, maintenance considerations, exceptional air traffic conditions, adverse weather, technical faults in air traffic control systems or declared emergencies at other airports or where Runway 10L-28R length is required for a specific aircraft type.' The net effect of the proposed change, if permitted, would change the normal operating hours of the North Runway from the 0700hrs to 2300 hrs to 0600 hrs to 0000 hrs. The relevant action also is: To replace condition no. 5 of the North Runway Planning Permission (Fingal County Council Reg. Ref. No. F04A/1755; ABP Ref. No.: PL06F.217429 as amended by Fingal County Council F19A/0023, ABP Ref. No. ABP-305289-19) which provides as follows: '5. On completion of construction of the runway hereby permitted, the average number of night time aircraft movements at the airport shall not exceed 65/night (between 2300 hours and 0700 hours) when measured over the 92 day modelling period as set out in the reply to the further information request received by An Bord Pleanála on the 5th day of March, 2007. Reason: To control the frequency of night flights at the airport so as to protect residential amenity having regard to the information submitted concerning future night time use of the existing parallel runway.' With the following: 'A noise quota system is proposed for night time noise at the airport. The airport shall be subject to an annual noise quota of 7990 between the hours of 2330hrs and 0600hrs.' In addition to the proposed night time noise quota, the relevant action also proposes the following noise mitigation measures: - A noise insulation grant scheme for eligible dwellings within specific night noise contours; - A detailed Noise Monitoring Framework to monitor the noise performance with results to be reported annually to the Aircraft Noise Competent Authority (ANCA), in compliance with the Aircraft Noise (Dublin Airport) Regulation Act 2019. The proposed relevant action does not seek any amendment of conditions of the North Runway Planning Permission governing the general operation of the runway system (i.e., conditions which are not specific to nighttime use, namely conditions no. 3 (a), 3(b), 3(c) and 4 of the North Runway Planning Permission) or any amendment of permitted annual passenger capacity of the Terminals at Dublin Airport. Condition no. 3 of the Terminal 2 Planning Permission (Fingal County Council Reg. Ref. No. F04A/1755; ABP Ref. No. PL06F.220670) and condition no. 2 of the Terminal 1 Extension Planning Permission (Fingal County Council Reg. Ref. No. F06A/1843; ABP Ref. No. PL06F.223469) provide that the combined capacity of Terminal 1 and Terminal 2 together shall not exceed 32 million passengers per annum.
