This is a high priority case.

On 24th August, 2022, the Board received a 3rd Party appeal from Trevor Redmond against Fingal County Council's planning register reference number F20A/0668, decision to grant permission, subject to 11 conditions, for the development which comprises of taking 'relevant action' only within the meaning of Section 34C of the Planning and Development Act, 2000 (as amended), which relates to the night-time use of the runway system at Dublin Airport, County Dublin.

The appeal was circulated to the planning authority (Fingal County Council), Aircraft Noise Control Authority (ANCA) and the applicant (DAA) on 31st August, 2022.

The last date for observations on the appeal was 3rd October 2022. 77 valid observations were received within the statutory time period. I do not consider it necessary to circulate any of the 77 observations (pending Oral Hearing determination).
