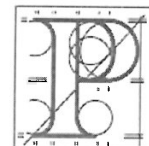

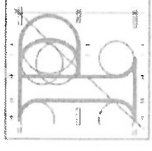

Appeal to An Bord Pleanála

These conditions, limiting the number of night flights to 65 and prohibiting take-off or landing on the new North Runway 10L-28R between 23:00 and 07:00 hours, were put in place by An Bord Pleanála after DAA themselves proposed and agreed to them at the Oral Hearing.

The "Noise Quota Scheme" will result in many more night flights (over 100) and for 2 hours longer than allowed in the ABP 2007 permission.

Residential Amenity will not be protected as people living under the flightpath will have their sleep disturbed by aircraft noise & frequency.
