Thanks for your response below.

The project team has identified one additional query which we request be added to the previous letter sent through Thursday last week.

This is as follows:

*Road Traffic Modelling is to be prepared in response to ANCA's request (Item A). For the road traffic modelling we propose to determine noise levels in terms of the  $L_{den}$  and  $L_{night}$  parameters, which will be consistent with the other sources of noise. We propose to use the CNOSSON-EU 2015 method to do this, which we note will be used for the next round of Strategic Noise Mapping in Ireland (UK CRTN 1988 method was previously used for Strategic Noise Mapping).*

*Can ANCA please confirm they agree with this approach?*

It would be much appreciated if this query could be added to our request for clarifications.
