

I wish to object to any easing of the restrictions on the nighttime use of Dublin Airport, and any move away for the restrictions for the number of movements to a noise quota.

Section 3 of the European Convention on Human Rights Act 2003, places a positive obligation on all statutory bodies **including An Board Pleanala**, to perform their functions in a manner compatible with the State's obligations under the Convention provisions.

Further to this, Article 8 of the Convention provides the right to respect for private and family life. The recent case of Swiss Senior Women (application no. 53600/20), found that inadequate action by respective Governments in respect of climate targets constituted a violation of Article 8.

I have no doubt that this right to respect for private and family extends beyond climate matters, and that the plan to remove the restrictions on the nighttime movement of plane is a breach of my right enjoy my life and live in peace and have a night's sleep which is necessary for mental and physical wellbeing.

The impact of nighttime flights on the health of individuals is well documented. I am currently suffering these negative effects including loss of sleep, increased stress levels impacting my sleeping habits, eating

habits, relationship with my family, performance at work and the ability to live a normal life and enjoy family and home life.

I also refer to the Aircraft Noise Competent Authority Decision of 20th June 2022, which appears to set conditions establish which include the move to (1) a noise quota for flights to/from Dublin Airport, (2) a change from the definition of night time flights to and from Dublin Airport from 11pm to 7am (as set out in the environmental noise Directive), to midnight to 5.59 am, and (3) residential sound insulation scheme. It is not clear that the ANCA has the legal basis to do as this does not respect the Doctrine of the supremacy of EU law. As the ANCA decision is a change to the period for nighttime flights from that set out in the Environment Noise Directive. Therefore, this decision appears to be flawed and unlawful.

There are some who argue that increasing flights is necessary for economic reasons. I direct you to Pobal HP Deprivation Index Launched, published on November 2, 2023, and the aircraft noise contour maps which show that as Dublin Airport expands is operations is negatively impacts some of the most deprived areas of Dublin. While the most affluent areas which benefit most from economic growth remain untouched. This is particularly noticeable that areas in Dublin that are affected are some of the most deprived, as this can be avoided.

Therefore, it appears that the DAA are asking those who benefit least from economic growth in Ireland to carry the biggest burden of the negative effects for the whole country. Even though they are least equipped, economically, to do so. https://www.pobal.ie/pobal-hp-deprivation-index/

I have lived peacefully in my home since my wife, and we bought it in 2005 until a significant change to flight paths and times in 2023. However, this has been hugely negatively affected by the increase of nighttime flights over my home. This is directly affecting my ability to sleep and night, leaving me tired and irritable, impacting on my ability to concentrate and perform at work, which may, if matters get worse, impact on my ability to earn a living, pay the mortgage and keep a roof over my family heads. As a father with two children this terrifies me.

For example, on **Sunday** 28 April **between the hours of 5 -7am**, 23 flights were directed over my home, this represented over 95 percent of flights which departed Dublin Airport turning south flying over the Lucan area where I live. This included flights as low as 3,541 feet.

What I refer to is just a sample of the nighttime flights which are a daily occurrence. I also have to suffer low flying flights over my home at 3am.

I have not moved to are surrounding Dublin Airport and begun complaining, but rather the DAA have significantly altered the flight times and patterns so that even homes in South County Dublin are suffering for the negative of nighttime flights. I no longer feel like I can enjoy a nights sleep in my home, simply because the DAA was to implement unsustainable development at Dublin Airport.

I would argue that the Country and the Regions would be better served if a sustainable development plan were implemented to develop capacity in the 5. regional airports. One example of this would be the immediate movement of all flights to the Americas from Dublin Airport to Shannon, freeing up capacity.
