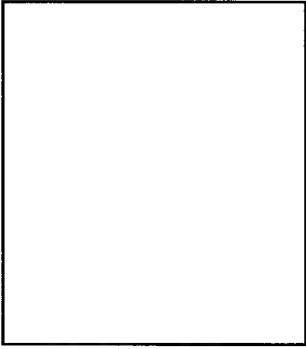

In accordance with Section 131 of the Planning & Development Act 2000 [ as amended], I wish to make the following observations:

- The maps submitted to ABP on foot of the Board request for additional information show areas in Meath, outside of the "Initial Eligibility Contour Areas"- there was NO PUBLIC CONSULTATION OF MEATH RESIDENTS AT ANY STAGE- THIS IS A BREACH OF THE AARHUS CONVENTION.
- Independent noise monitoring data along the North Runway flight paths should be supplied by Dublin Airport Authority to support its application. Residents along the flight path cite noise of 65Db & higher, whilst ANCA reports noise of 55Db.
