

The 2007 planning condition documentation includes flightpath assumptions which many people have built their lives around. The flightpath in the 2007 planning permission are much different to the ones in use today and since it opened. The noise from the current flightpaths is a nuisance and intolerable. These flights must be changed back to what was proposed in 2007. No further changes can be considered until this crucial issue is addressed first.

Considering the gravity of this situation, an oral hearing is absolutely necessary.
