

Dear Secretary,

I am writing on behalf of my family living in the North County Dublin area. I am one of the 30,000 people who are living under an illegal flightpath since the opening of the North runway. To say that this development has had a severe impact on our family's wellbeing and health since its opening would be a gross understatement. Our quality of life, in terms of sleep and rest and ability to enjoy living in our home, has been greatly diminished.

The noise from the current flightpaths is intolerable. These flightpaths must be changed back to what was proposed in 2007. No further changes can be considered until this crucial issues is addressed first. There is a major health risk to tens of thousands of people due to this noise. The harmful effects of this noise has not been adequately considered and we believe an oral hearing is absolutely necessary given the gravity of the situation.
